OPEN DISCUSSION

Scott Clamp – 720 Wasatch – Scott inquired about the status of a new ZIP code for the City of Mills. Mayor Juarez responded by explaining that Mills does not technically have its own unique ZIP code, which continues to create challenges. Although many assume that 82644 belongs to the City of Mills, that ZIP code is actually assigned to the post office. As a result, Mills shares mail processing with Casper, which leads to a variety of issues.

One notable example involves medical billing. If an ambulance responds to a residence in Mills that does not receive direct USPS mail delivery, critical medical bills are often delayed or lost, creating confusion and hardship for both residents and healthcare providers.

Mr. Clamp asked whether there was a risk of losing the 82644 ZIP code entirely. The Mayor clarified that 82644 was never officially assigned to Mills. Mr. Clamp, who has operated a business in Mills for over 60 years, expressed concern that changes to the ZIP code could negatively impact his and other local businesses.

Mayor Juarez acknowledged those concerns and emphasized that this has been a long-standing issue. In addition to inconveniences like delayed deliveries and misdirected mail, the shared ZIP code has resulted in more serious consequences—such as the misallocation of property tax revenue to other municipalities. These problems affect not only individual residents and businesses, but also city operations and the broader financial health of the community.

The Mayor noted that some cities have successfully pursued unique ZIP+4 designations—the additional four digits appended to a standard ZIP code. For Mills, obtaining a specific 82644-XXXX identifier could help address many of these challenges without requiring a complete ZIP code reassignment.


