# MINUTES

## CALL TO ORDER

### AGENDA ITEMS

- 1. City Administrator Bar Nunn's Hydro Vac-Trailer
  - a. When Bar Nunn acquired Wardwell, they have 2 trailers and they are looking at getting rid of some property.
    - i. Casey is talking to someone at Bar Nunn and they want \$30k, has 68 hours on it, we have maintained the maintenance on it, Cody has the records
    - ii. Found a few in California comparable in price but more hours
    - iii. Makes it easier to take out curb stop
    - iv. Not a full truck, just a trailer
    - v. Bar Nunn is keeping the diesel one, selling gasoline one
    - vi. Brad says move forward, Leah agrees
    - vii. Add to council for approval
- 2. Community Development Director BRC Loan Application
  - a. Lisa B called about land by the school, 30 acers. Buffalo Meadows is almost all sold. 99 houses
  - b. Stagger lot sizes for minimal lot sizes
  - c. We could do a business committed loan at 1%
    - i. She would probably pay the loan
  - d. Business Council has not done this before, they are looking at what they want to fundi. Wants to be able to duplicate plan with other municipalities.
  - e. Leah asked for drawings or site plan she is looking at, would like to see something or some sort of plan
  - f. Mike brought up lift station, we are about maxed out and would have to replace or upgrade the lift station, upgrade pumps
  - g. Leah would like to hear more and price point the houses will be
  - i. Sabrina smaller lots, smaller houses, not low income
  - h. Mike reminder, no extra promises on the side
  - i. Pat Say we get the loan, immediately pass through to developer?
    - i. Sabrina Similar to grant process, we receive money, we receive invoices, sent to State, they pay us, we pay her.
    - ii. They only need us, because they cannot loan to a private entity
    - iii. There would need to be another traffic study
- 3. Tyler technologies
  - a. Nate has been talking to them, they do not use payroll
  - b. Casper is using a Tyler Tech payroll system
  - c. Sara out billing system is a mess
  - d. Bryon Wyoming is going to Tyler Tech
  - e. Summer Community Connect, look into it

    - i. Asked Nate and Sara to go to Casper and see how their system is
  - g. Bryon Runs report beam, Casper is going to Tyler for crash program, more date, could have people go in and download their own crash test, should know more in June.
