OPEN DISCUSSION

Randy Morrison, a local business owner moved into Heights BLVD about a year and a half ago into the old Ramshorn construction building off of Salt Creek. His problem is with Heights Blvd between Salt Creek and Platte St, as no one is maintaining Platte St and there is no drainage and has no ditches. City Attorney and Councilmember Newmiller noted that some roads are public thoroughfares without municipal dedication; if Heights Boulevard is not dedicated, it is a private access and the city cannot maintain it. City planner, Casey added that, even if determined to be a Mills road, full repaving is unlikely due to cost and limited public benefit; a depth replacement with gravel might be more feasible. City attorney suggested title/dedication research to determine ownership and maintenance responsibility.

Tabitha Nelson, a resident of Mills, is requesting assistance with a past-due utility bill. She said she has been working with Community Action and is on a waiting list for assistance. She had some other bills that came up and was requesting more time on her past due bill of \$373.00 so her water doesn't get disconnected. The council decided to grant Tabitha Nelson an extension on her utility payment, preventing a shut-off until July 6, 2026.

Scott Clamp, a resident of Mills, is asking the council to allow him to put a C-can in his parents back yard. He said that there is currently a 40X8 foot trailer on the property that his mother used for storage and would rather have an earthy-tone C-can in place of the trailer. If a C-can is not permitted, he plans to refurbish the existing trailer (paint, reseal roof) to retain it. This will be addressed in the planning and zoning meeting to review current restrictions and propose standards for new earth-tone containers, or clarify refurbishment requirements for existing trailers.

Scott Clamp, a resident of Mills, also proposed organizing a "meet the candidate" session (not a formal debate) to allow candidates to share visions and take questions. The Mayor noted elected officials cannot promote such events while in meetings but welcomed community-led efforts. A resident volunteer approach was encouraged; Scott will explore community organizers for the event.

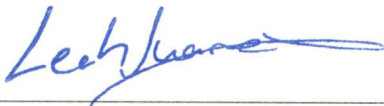
