OPEN DISCUSSION

Scott Clamp shared several comments with the Council. He suggested that open discussion be moved back to the end of the meeting, noting that in the past it allowed residents to comment on items that arose during the meeting.

He also expressed concern that ordinances are sometimes listed only by number on agendas, without a description, which makes it difficult for residents to understand what Council is considering. He recommended including a brief summary of the ordinance.

Mr. Clamp also spoke about the Service & Sacrifice Park project, asking whether the City had considered acquiring the vacant property across Platte Street (formerly associated with the Burton family/Rainbow Cleaners) to potentially expand the park and create a larger focal point for the community.

Finally, Mr. Clamp shared historical information about the former Mills water tower that once stood near the park and suggested exploring the possibility of bringing it back or incorporating it as a historical feature.

Mr. Clamp concluded his comments and thanked the Council.

Mayor Juarez responded to Mr. Clamp's comments regarding meeting procedures and other topics.

The Mayor explained that open discussion was intentionally moved to the beginning of the meeting so that residents have an opportunity to provide input before the Council takes action or votes on items. She noted that many municipalities structure their meetings differently, and in Mills much of the Council's discussion occurs during the work session held one hour prior to the council meeting, which is open to the public so residents can hear how Council arrives at decisions.

Regarding ordinances listed on agendas, Mayor Juarez stated that additional information is available to the public. Ordinances are posted online and available at City Hall for anyone who wishes to review them, and copies can be printed upon request.

Mayor Juarez also addressed the comments regarding additional land near the Service & Sacrifice Park, noting that the City had previously reached out about acquiring the property but was given a definitive refusal. She stated the City may attempt to inquire again in the future.

Mr. Clamp provided additional historical context about property development, contamination issues, and floodplain changes related to nearby properties. Mayor Juarez thanked Mr. Clamp for sharing his historical knowledge and input with the Council.


