 - a. Amy Fleming- Director of Senior Center in Casper, Evansville.
 - b. Linda Blackstone President of Senior Center
 - i. Amy spoke about PowerPoint
 - ii. 5 years, Cash reserves have been used to stay afloat. Reserves are almost gone, may have a year left.
 - iii. Huge increase in expenses
 - iv. Reduced Grants, remained flat or have gone down, due to Covid
 - v. Limited funds for seniors
 - 1. Always looking for Senior specific grants, hard to find
 - vi. Seniors and Meals on Wheels are non-profits
 - vii. 43-45% covered by State and Federal
 - 1. Can't pay \$10-12/hour to keep employees
 - viii. Annual Fund Raiser Night at the Races, at Ramkota,
 - 1. Donations needed for prizes
 - ix. What is at stake?
 - 1. Cap on how many people can eat, how many people we can help
 - 2. 2019 Wise program survey, what would happen if state quit funding program
 - 3. 48% people would be in nursing home within 4 months
 - 4. \$2738/person in home services
 - 5. \$83,952/person in nursing home costs
 - 6. Mental health and rapid decline in health
 - x. By 2030 1 in 5 people will be over 65
 - xi. 1 in 4 live by themselves
 - xii. Cost of home tax payer 1.58/month
 - 1. 5 trustees in election
 - 2. 9 counties hurting
 - 3. Natrona county would include Mills
 - a. Requesting 1 Mill. \$200k home \$19/year
 - xiii. Grant process, would show need and financials, bonded
 - 1. Strict audits

 - 2. Case management, housekeeping, personal care, all that fall apart that

 - 1. Doing chores for care giver, caregiver decline is a real thing

- xxv. Senior Population has grown 47%
- c. Leah asked Up to \$1 million is needed?
 - i. Pat S. it is set at \$1 million for Natrona County, Converse County \$2 million
 - 1. Amount could go down if they funds not needed
- d. Amy detailed Letter from North Big Horn Letter
- e. Leah Are audits completed by State
 - i. Yes
- f. Leah Is the Loan Closet depleted?
 - i. Amy said it all comes and goes, gave example about walkers needed, they keep back stock but not always available
- g. Leah What is the Federal Funding?
 - i. Amy said Wyoming needs to increase their revenue, expenses have grown for everyone.
- h. Leah What happens to overage if \$1.7m isn't needed,
 - i. Pat S. Could be invested
- i. John Gudger how much do you think the expense are due to inflation?
- i. Amy responded that a significant increases in expense and not enough given
- 2. Fire Department New Ambulance
 - a. Jeremy from Fire Department, we are over on what was requested on Ambulance, over \$9k, requested \$43k, swapping out radio system, 225k from grant, brand new ambulance for \$55, extra \$9k will go on lease
 - b. Sara Is that all? Yes
 - c. Leah What were some things on change orders? Jeremey, doesn't know specifically, can look through emails a bunch of little things. Knowing what we like and don't like with current ambulance, Leah asked if there is a fee on change order? Jeremey said no. Miscommunication some of the issues, new person added in communications
 - d. Fire Hall Space, Frank with Hunting with Heroes, September 21st, vets dinner, provide space and table and chairs, at station, need alcohol permit; Mike made note that table and chairs used
 - i. Hero outdoors, 10 Marines
 - ii. Frank came in, take vets hunting,
 - 1. Catered a lot of meat
 - 2. Fund raising
 - 3. Apply for 24 permit, waive \$50 fee for alcohol permit
 - 4. Talked about quilts given to the vets, Rib and Chop was too expensive.
 - 5. Jeremy to talk to Keyhole about borrowing BBQs
- 3. Leah Brought Brad up to speed on Home Occupation Permits

 - i. Mike Spoke about hazard materials, should have inspections
 - 1. Should not change exterior of property
 - ii. Leah started working on the home occupancy application

 - 1. Change License to Permit

 - v. Updated Resolution to show \$45 instead of \$25
