**WHEREAS,** The City of Casper has amended its code to require Message Bodywork Therapists to acquire a permit from the City of Casper in order to operate with in Casper's municipal boundaries; and

**WHEREAS**, The City of Mills is adjacent to the City of Casper and, therefore, has a legitimate concern that persons or entities seeking to evade the operation of the provisions of the ordinances in Casper may locate in Mills; and

**WHEREAS**, The City of Mills has the same health, safety and welfare concerns as the City of Casper in regard to its citizens

**NOW THEREFORE,** The City Council of the City of Mills, Wyoming hereby adds to its Municipal Code the attached Sections 8.40.100 to 8.40.280 and to list Massage Bodywork Therapists as category G under Section 5.04.049 of Title 5 of the Municipal Code. This ordinance shall be in full force and effect upon passage on three readings and publication.

# **ORDINANCE No. 795**

AN ORDINANCE ADOPTING THE 2023 NATIONAL ELECTRICAL CODE
(NEC) INCLUDING CERTAIN APPENDICES, AND AMENDMENTS
REGULATING AND GOVERNING THE INSTALLATION AND WIRING OF
RESIDENTIAL AND COMMERCIAL CONSTRUCTION, ALTERATION,
MOVEMENT, ENLARGEMENT, AND REPLACEMENT, REPAIR,
EQUIPMENT, LOCATION, AND PROPER REMOVAL OR DEMOLITION OF
SAID BUILDING AND STRUCTURES.

**WHEREAS** the City of Mills in accordance with Sections 15-1-701 through 15-1-801 of Wyoming Statutes, 1977 and the authority granted to the City wishes to amend Chapter 15.05 of Mills Municipal Code, for the purpose of adapting the 2023 NEC, and

**WHEREAS** the City of Mills is even mindful of ensuring the security and safety from hazards, and promoting health and general welfare of the residents of Mills, Wyoming.

# NOW, THEREFORE BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF MILLS, WYOMING THE FOLLOWING:

# **Section 1:**

Section 15.05.010 of Mills Municipal Code is hereby created as follows:

15.05.010 Adaption.

That a certain document, two (2) copies of which are on file in the office of the CITY CLERK of the CITY OF MILLS being marked and designated as the National Electrical Code, 2023 edition, including all appendixes, as the regulating NEC of the CITY OF MILLS, in the State of WYOMING for regulating construction, alteration, movement, enlargement, replacement, repair, equipment, location, and proper removal or demolition of said buildings and structures.; providing for the issuance of permits and collection of fees therefore; and each and all of the regulations, provisions, penalties, conditions and terms of said NEC on file in the office of CITY CLERK are hereby referred to, adapted, and made a part hereof, as if fully set out in this ordinance.

# **Section 2:**

That if any section, subsection, sentence, clause or phrase of this ordinance is, for any reason, held to be unconstitutional or unenforceable, such decision shall not affect the validity of the remaining portions of this ordinance. The CITY COUNCIL hereby declares that it would have passed this law, and each section, subsection, clause, or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional or unenforceable.

# **Section 3:**

That nothing in this ordinance or in the Building Code hereby adopted shall be construed to affect the right or ability of the City of Mills to initiate any suit or proceeding in any court, or assert any rights acquired, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed as cited in Section 3 of this ordinance; nor shall any just or legal right or remedy any character be lost, impaired or affected by this ordinance.

**IT IS FUTHER ORDAINED**: That upon passage and execution of this Ordinance it shall be filed with the office of the Natrona County Clerk.

# RESOLUTION NO. 2023-10

# A RESOLUTION SETTING CERTAIN BUSINESS LICENSE FEES

**WHEREAS,** Section 5.04.010 requires every business operating within the City of Mills to obtain a license in order to operate within the City, and :

**WHEREAS**, Certain businesses listed at Section 5.04.040 have more specific licensure requirements; and

WHEREAS, A principal reason for the business license requirement has been to provide for fire inspections to be conducted by the City of Mills Fire Department in order to provide for the safety and welfare of the municipality with that being the sole reason for the license in some circumstances; and

**WHEREAS,** During the fire inspection, fire crews use the opportunity to pre-plan structures, locate utility shut-off points and identify hazards to the occupants and responders; and

**WHEREAS**, The fire inspection fee/business license fee is not intended to be a deterrent to businesses coming to or staying in Mills, but to stress the importance to businesses that the City of Mills cares about their safety, the safety of the employees and anyone who visits the business, as well as for responder safety in the event of a catastrophic event.

**WHEREAS**, Section 5.04.050 provides that the City Council may set the fees for business licenses by resolution.

# **NOW, THEREFORE,** The City Council Resolves as follows:

- A. The business license fee for all businesses which are referenced only at Section, 5.04.040(F) shall be their annual Fire Inspection Fee.
- B. All businesses that are required to have a Business License which is specific to their business and occupation, and which is otherwise addressed in the Mills Town Code outside of Section 5.04.040(F), to include but not be limited to Section 5.04.040(A) through (E) and (G), as well as licensed trades such as electrical, building and plumbing trades, shall also have a Fire Inspection with a fee as set forth herein if they maintain a business location inside of the Citiy of Mills, but the City Council may otherwise set the fee for their license. Where such a fee has been previously set, this Ordinance does not remove it, but the fire inspection fee shall be additionally required.
- C. The fees shall be as follows:
  - i. Businesses that qualify for the Self-Assessment Fire Inspection \$45

- ii. Businesses between 1-5000 sq. feet, \$75
- iii. Businesses between 5001-10,000 sq. feet \$125
- iv. Businesses greater than 10,000 sq. feet \$250
- v. Businesses that have a fire alarm system, sprinkler system or commercial hood extinguishment system, an additional \$50 fee shall be assessed.
- D. For purposes of clarity, this may be referred as a Fire Inspection Fee.
- E. This Resolution shall become effective on July 1, 2023.
