### New Draft Comprehensive Plan Parks and Recreation Element

Commissioner Ankney opened the public hearing on the Draft Comprehensive Plan Chapters 1,2,3, & 4 Updated Community Visioning - Goals, Policies and Actions Framework & New Draft Comprehensive Plan Parks and Recreation Element at 6:11 pm. Commissioner Ankney asked if any of the Commissioners had a conflict of Interest; none of the Commissioners had a conflict of interest.

Ms. Tainio presented her staff report which included the changes incorporated from the Planning Commission's work to date. She discussed with the Commission the Racially Disparate Impact Analysis (RDI) she was working on for the Comprehensive Plan and the racially restrictive covenants that were still in place on Millwood lots.
