Issue: The City of Minnetrista Representative for the Lake Minnetonka Conservation District (LMCD) has resigned effective 12/31/2025, and the City must fill the seat for the remainder of the term through 1/31/2026 and also appoint for the subsequent two-year term, starting 2/1/2026.

Overview: Staff solicited for and has received one application to be considered for appointment as the Minnetrista LMCD Representative. That application is attached for review. The Mayor will facilitate the interview of the applicant during the meeting.

Recommended City Council Action: Staff request that the City Council evaluate the attached application, conduct the interview of the applicant, and consider appointment at the regular meeting to fill the remaining term of the resigning Minnetrista LMCD Representative, and also consider appointment to the subsequent two-year term starting 2/1/2026 as the Minnetrista LMCD Representative.
