MINUTES OF REGULAR MEETING

August 15, 2022

MONTGOMERY ECONOMIC DEVELOPMENT CORPORATION

CALL TO ORDER

President Rebecca Huss called the meeting to order at 6:00 p.m.

Present: Rebecca Huss - President

OPEN PUBLIC COMMENT

No public comments were made.

APPROVAL OF MINUTES

1. Consideration and possible action regarding the Minutes of the Regular Meeting Minutes of June 20, 2022.

Motion to approve the minutes of June 20, 2022, was made by Byron Sanford and seconded by Jeff Angelo. All in favor. (6-0)

APPROVAL OF FINANCIAL REPORT:

2. Consideration and possible action regarding the MEDC Financial Report.

Carol Langley said June's sales tax was \$84,813.38 with an interest rate of 1.37 percent and July's sales tax was \$126,665.96 with interest on the TexPool accounts of 2.12 percent.

Carol Langley said she did not see anything unusual that was paid out or needed to be brought to anyone's attention.

Rebecca Huss said she just signed a wire transfer for \$750,000 from the checking account to the TexPool account.

Motion to approve the Financial Report was made by Jeff Angelo and seconded by Dan Walker. All in favor. (6-0)

CONSIDERATION AND POSSIBLE ACTION:

3. <u>Presentation by Mr. Charlie Diggs of proceeds from the Montgomery Music & Mudbugs</u> <u>Festival by Charlie Diggs Entertainment.</u>

Mr. Diggs said they had 3,800 in attendance, somewhat less than last year.

Rebecca Huss said there were some comments made about parking and traffic. Rebecca Huss said she was working with the Lions Club on parking until 7:00 p.m. and only saw four or five cars come from the downtown area. Rebecca Huss said everyone else came from CB Stewart and everyone stayed within the two parking areas. Rebecca Huss said it worked out very well and she was not sure what the comments were from people who said there was too much traffic because it was all on SH-105.

Dan Walker asked if they still have access to the two fields that were used. Mr. Diggs said the one field in front they are eager to sell now and Ransom's sold the other field across the street from them. Mr. Diggs said they can still use the southwest field for this upcoming event. Mr. Diggs said the police department said they did not have any parking issues. Rebecca Huss said it works well having a group in charge of parking instead of having it be a free for all. Rebecca Huss said it was very well done.

4. Consideration and possible action regarding sponsorship of the Montgomery Fall Festival.

Mr. Diggs said it will be the same as last year, but there will need to be some adjustments made. Mr. Diggs said he has not spoken with the steakhouse yet and mentioned using the lot on Clepper Street. Mr. Diggs said once they receive that information, they will let them know.

Jeff Angelo asked where the festival will be located. Mr. Diggs said he wanted to see what everyone thought because he thinks it is possible to have it on the property next to the school. Mr. Diggs said he knows there are mixed emotions as some of the business owners want to have the event downtown and others do not. Mr. Diggs said he wants to do what makes everyone happy. Jeff Angelo asked what date he is considering for the event this year. Mr. Diggs said October 8th. Mr. Diggs said his goal is to meet with business owners on Wednesday to see what their preferences are. Jeff Angelo asked if the parking would remain the same by Longview Golf. Mr. Diggs said yes, last year they had hay rides from there down to the festival. Jeff Angelo asked how many people can fit into that particular space. Mr. Diggs said around 3,000 to 3,500. Jeff Angelo asked if the vendors would be located in the parking lot where the school administration building is. Mr. Diggs said right now he would like to keep it downtown. Mr. Diggs said the issues on his end are staging and buses. Jeff Angelo asked if he has it downtown would the stage be set up where it is now or would he go through Jacobs lot. Mr. Diggs said last year they had it in the center and where it would be again this year. Jeff Angelo asked if his preference was downtown. Mr. Diggs said he likes the atmosphere downtown but also does not want to upset anyone. Mr. Diggs said two businesses were not on board, but the remaining businesses loved it. Jeff Angelo said he thinks they should keep the event where it was last year because people now know where it is. Dan Walker said you will not be able to make everyone happy. Mr. Diggs said it is a fall festival atmosphere and that is what he wanted.

Byron Sanford asked if they could give Mr. Diggs complete access to all the businesses so he can specifically address them. Rebecca Huss said they cannot as it is more of a private sector. Rebecca Huss said she thinks that is something Mr. Diggs can do well on his own.

Jeff Angelo said he thinks if Mr. Diggs is proactive this time he will have a much better response. Rebecca Huss said she thinks he was proactive last time but thinks the big difference is one of the unhappy businesses was the steakhouse and what was agreed upon was either not clear or had changed after the agreement. Rebecca Huss said having everything in writing will be important. Jeff Angelo said he thinks the steakhouse will be fine and Wine & Design too, as Mr. Diggs just needs to have a discussion with them. Mr. Diggs said knowing those businesses have issues, those will be the first people he approaches and asks what they want him to do to make them happy so everyone is happy. Jeff Angelo said he thinks that is a good approach.

Rebecca Huss said on Mr. Diggs's application he did not include a dollar amount and believes last year Mr. Diggs was asking for \$8,000.00. Rebecca Huss asked Mr. Diggs if that was the same amount for this year. Rebecca Huss said she believes that is the amount paid in security costs as well. Mr. Diggs said he paid a bit over that amount.

Motion was made to approve the sponsorship of the 2022 Montgomery Fall Festival as stated in item three for \$8,000.00 by Byron Sanford and seconded by Dan Walker.

Rebecca Huss commented this will be taken from the 2022-23 budget.

Carol Langley said the communication needs to be more precise this year due to some of the problems from last year. Mr. Diggs asked who the contact person will be this year. Rebecca Huss said our code enforcement officer. Rebecca Huss said Mr. Diggs's responsibility will be the festival permit which comes from the City and the food vendor permits that the City issues.

All in favor. (6-0)

5. Presentation by Mid-South regarding internet service for the city and surrounding area.

Mr. William Bond, Fiber Sales Manager, and Ms. Stacey Forgason, Communications Manager with MidSouth gave their presentation. Ms. Forgason said there is a difference between MidSouth Fiber Internet and many other internet services in the area. Ms. Forgason said one is MidSouth Fiber Internet is owned by MidSouth Electrical Co-op and there is a difference

when it comes to co-ops. Ms. Forgason said MidSouth, member-owned by community members has been around for over 80 years and was originally established by local residents.

Ms. Forgason said their fiber internet service is based on the same service they provide for electricity. Ms. Forgason said they are subscriber focused. Ms. Forgason said one example is when Covid-19 hit they had started putting in fiber to the areas where they already serviced electricity but it became quickly apparent they had some areas within their communities that did not have access to reliable high-speed internet. Ms. Forgason said what was originally supposed to be a five-year project, their employees turned into a two-year project. Ms. Forgason said the same people who developed that infrastructure three years early also now service their businesses on fiber internet.

Mr. Bond said their business customers have access to priority status service which means if there are bulk outages in the area, businesses will take precedence over anyone else. Mr. Bond said the 24/7 support is also a huge advantage, whereas a lot of the other internet providers in the community will have customers wait until the next day or until someone can arrive in the area. Mr. Bond said with 24/7 support if the issue cannot be resolved over the phone, a technician will be on the road usually within 45 minutes. Mr. Bond said they like to pride themselves on their service and reliability.

Mr. Bond said they provide a free business package for small businesses and they also offer custom solutions.

Ms. Forgason said they are subscriber focused and they want to reiterate this just in the fact their operations are designed with their consumers in mind. Ms. Forgason said the reason being is their consumers are their owners.

Mr. Bond said they currently provide 100mbps, 500mbps, and 1gbps business packages with all of the packages including 24/7 support.

Ms. Forgason said MidSouth does not throttle speed as is common practice with internet providers. Ms. Forgason said this means when you reach maximum data the speed begins to slow down, but this is not the case with MidSouth. Ms. Forgason said they established this

fiber infrastructure with state-of-the-art equipment and have implemented everything top of the line.

Rebecca Huss asked if MidSouth is the maintenance provider that services the City's electric wires. Mr. Bond said not if electricity is provided through Entergy. Mr. Bond said there is no service territory with fiber unlike electric territories such as with Entergy. Mr. Bond said they have plans to build out but it is a matter of financials, feasibility studies, and time. Rebecca Huss asked if there is a time frame in mind. Mr. Bond said not at the moment.

Dan Walker asked when MidSouth goes into another extra-territorial jurisdiction do they share a line or are they having to run their own service. Mr. Bond said they run their own service. Dan Walker asked if they have television service. Mr. Bond said no just internet and phone service.

Jeff Angelo asked how many customers MidSouth currently has. Mr. Bond said they are very close to approaching 10,000 customers. Jeff Angelo asked if this is the same company as MidSouth Electric. Mr. Bond said MidSouth Electric is the parent company and MidSouth Fiber is a subsidiary.

Jeff Angelo said he was checking on Google and with 53 reviews and 1.7 stars there were a lot of comments made stating they would like to give MidSouth Electric zero stars. Jeff Angelo said service is a big issue and when he sees these kinds of numbers it is not acceptable. Jeff Angelo asked what is going to be different with the internet service department as opposed to the electric service department of MidSouth that they are not providing. Ms. Forgason said before the recent spike in natural gas prices their Google numbers were not so low on the electric co-op side. Ms. Forgason said on their social media platforms there is a small portion of people who are very unhappy that natural gas prices increased. Ms. Forgason said it was then perceived that MidSouth raised its rates and MidSouth has not raised its rates in over a decade. Jeff Angelo said with as many customers as MidSouth has there are going to be folks who are not happy. Jeff Angelo said when they are vetting a new company they have to make sure they are given the best information and it is important to be well received. Ms. Forgason said she just ran an updated survey today and they are up to an 85 percent approval rate.

6. Consideration and possible action on the acceptance of the Moore Archeological Consulting report pertaining to the Adams Lot and instruct the MEDC President to close on the purchase of the property.

Jeff Angelo asked if there was anything in the report that would preclude them from moving forward. Jeff Angelo said it does not appear there is anything concrete in the document.

Carol Langley said she thought the City approved this report. Rebecca Huss said after discussing with Moore Archeological Consulting, there would be nothing to find on their radar and it would be highly unlikely. Carol Langley asked if they stated that in their report. Wade Nelson said it does state that in the report. Rebecca Huss said given the composition of the soil and the age of the elapsed amount of time there is nothing to find. Carol Langley asked if they could take this to court and give a copy of this to the Historical Society and use this to assure people they have done their duty. Rebecca Huss said yes. Rebecca Huss said Ms. Adams sent her a note stating she felt the tree was actually in the middle of FM 149 as opposed to on the property they were purchasing based on her family documents. Carol Langley asked if this report would take care of EDC and the City doing their job to make sure there were no graves there. Rebecca Huss said yes she believes so. Rebecca Huss said Virginia Adams also sent her a notarized document stating that a baby be removed from her cemetery plat at her expense in the unlikely event that any 168 year old remains are found.

Rebecca Huss said the archeological report states that based on what they know regarding how carbon-based things decompose and spending \$10,000 on a ground penetrating radar survey, it will find items, but not those remains based on the age.

Rebecca Huss said from a religious perspective they believe they buried the family at the Methodist Cemetery across the street at the time. Rebecca Huss said she believes Methodists do not believe in original sin which means she is not sure why they would have buried the babies on the property when the cemetery was right there.

Jeff Angelo said it sounds like they have an agreed recourse. Rebecca Huss said they have historical evidence pointing to the burial being somewhere else if it did happen, time has passed so there would not be anything to find, and they have financial recourse.

Motion to accept the Moore Archeological Report pertaining to the Adams Lot and instruct the MEDC President to close on the purchase of the property was made by Jeff Angelo and seconded by Wade Nelson. All in favor. (6-0)

7. Consideration and possible action to approve the proposed MEDC FY2022-2023 budget.

Rebecca Huss said after the two budget workshops they agreed on finalizing everything except the possibility of hiring a part-time person but going a different route which would be the half-time person combined with another half-time person who works in the park and recreation department under Public Works. Rebecca Huss said Public Works is willing to fund half of a person to be the other half of the MEDC person. Rebecca Huss said the total MEDC funding would be \$35,000.

Jeff Angelo asked if the MEDC would have any input as to who this person is. Rebecca Huss said they do not have the training or the legal liability coverage to manage an employee.

Carol Langley said the City has asked for a job description for the position of parks and recreation but also for handling City events as well. Carol Langley said this person will report to Mike Muckleroy.

Rebecca Huss said after MEDC is satisfied with where they are with its budget it will go to City Council for approval. Rebecca Huss said at their next meeting they need to have a call for public hearings which are needed to approve their budget. Rebecca Huss said beforehand, City Council needs to approve the budget. Rebecca Huss said if City Council does not approve their budget, at the next meeting they will need to make the recommended changes or make their own changes and go back and get a secondary approval and still have their public hearing.

Motion to send the finalized proposed MEDC FY2022-2023 budget to City Council for approval was made by Rebecca Huss and seconded by Wade Nelson. All in favor. (6-0)

8. Consideration and possible action on approval of Bitly expense to create unique website addresses.

Motion to approve the subscription for 96 dollars per year to approve Bitly's annual subscription was made by Jeff Angelo and seconded by Wade Nelson. All in favor. (5-0). Byron Sanford stepped out prior to the vote.

9. Consideration and possible action on purchasing equipment from Montgomery Movie Night events.

Motion to reimburse Public Works for Movie Night equipment was made by Jeff Angelo and seconded by Dan Walker. All in favor. (6-0)

10. <u>Discussions on the possibility of the Montgomery Economic Development Corporation</u> funding in full or part for MLK Sidewalks.

Mr. Mike Muckleroy, Public Works Director said the City applied for two TxDOT Transportation Alternative grants in 2021 for two sidewalk projects and was not awarded funding for either project. Mr. Muckleroy said one project was Clepper Street/Bessie Price Owen sidewalk and the MLK sidewalk project. Mr. Muckleroy said the MEDC funded a sidewalk project that included a portion of the Clepper Street grant application that connects the historic downtown to Fernland Historical Park and adjacent City property used for event purposes.

Mr. Muckleroy said during a recent City Council budget workshop, Councilwoman Patricia Easley requested the MLK sidewalk project be presented to MEDC for consideration. Mr. Muckleroy said a construction cost estimate from 2021 and details about the scope of the MLK sidewalk project are attached for reference. Mr. Muckleroy said the engineering design costs are not included in the cost estimate and will be around \$40,000 in additional project costs. Mr. Muckleroy said City staff intends to reapply for TxDOT mobility grants in their 2023 Call for Projects.

Mr. Muckleroy said they had to remove several items from the capital fund project they wanted to do last year and this is one of those projects. Mr. Muckleroy said it came down to choosing between this project and the Round About project at Lone Star Parkway and Buffalo Springs that Precinct 1 verbally committed 50 percent to. Mr. Muckleroy said their share is \$265,000 and they thought this was the better choice for next year.

Mr. Muckleroy said this sidewalk does not have as much of an MEDC impact as Clepper Street, but an alternative would be to choose to fund the Round About project for the City and that would free up City funds to do the sidewalks.

Carol Langley asked when the grant will be open again. Mr. Muckleroy said in 2023 but does not know what month. Carol Langley said she knows Mr. McCorquodale applied twice and was turned down but is taking classes online through TxDOT to help him with the third application.

Byron Sanford asked if the MLK sidewalk project was a six-year deal. Mr. Muckleroy stated he did not know. Byron Sanford asked if is it necessary to put a contingency in a line item that says MLK sidewalks and then when you get to the end of the budget you see it is not there. Byron Sanford asked if they are setting themselves up for situations like this when they know they are trying to obtain a grant and chances and time are unclear, and strings are attached to these grants, but they chose to put something out there that makes a false hope and puts them in these types of situations. Byron Sanford asked if they could get away from these practices.

Mr. Muckleroy said he does not know who could answer that, but cannot say it is a bad practice to try. Mr. Muckleroy said some of these grants are reimbursement grants and you have to plan for them. Byron Sanford said if it was a six-year project you can wait until the grant comes in eight months later and then three more months put it in the budget then and they can avoid these types of situations. Byron Sanford said he asking to have the process reconsidered.

Rebecca Huss said the problem with Clepper Street has always been it is another one of Montgomery's rinky-dink spending of five dollars and wasting it going down the drain because it will last one minute as opposed to waiting until they can afford to spend the cost to do a quality job and get it done right the first time that lasts for its intended life cycle. Rebecca Huss said some of the things that were previously installed are in the wrong place.

Carol Langley said Clepper Street was a grant project that began five or six years ago through the Chamber and they did not get that grant either. Carol Langley said City Council did not fund it once they did not receive the grant. Carol Langley said MLK in her memory has only been a couple of years.

Jeff Angelo said he does not understand how MLK is in EDC. Rebecca Huss said she does not think it is either but is wondering if the City's capital projects budget has too many things being pulled from it, if they can swap out something that is an MEDC project, they can swap it back in if it is a priority. Rebecca Huss said it could be asked of City Council what other projects they have that have been cut from the budget that they would like MEDC to take on. Rebecca Huss said they could say they have in their budget \$160,000 for City capital projects. Dan Walker said what projects will bring the most benefit to the most people is what they have to look at.

Jeff Angelo said they need to focus on the areas around the center of downtown where they are going to be making their development and have the greatest impact from an infrastructure standpoint. Jeff Angelo said Clepper Street is a good project and that is why they all agreed on that but it is not something that is going to have a major impact on their community.

Rebecca Huss said there is a big need the City has right now and maybe they should look at their budget and see if they can make their capital projects a bit tighter. Rebecca Huss said she was originally thinking of offering the swap but instead let the City come to them and say this is what they would like them to spend the money on. Jeff Angelo said as long as they have discernment over those issues he does not see a problem with that.

Rebecca Huss said she has heard they have run out of cement and that they ran into some contract issues where TxDOT could have had drawings that did not show some type of expansion joints. Jeff Angelo asked if they have an estimated time of completion on the project. Rebecca Huss said no.

Byron Sanford said he received a letter from Mr. Terry Weaver concerning Breaking Strongholds which has been streaming now for three months. Byron Sanford said on YouTube alone they have had over 75,000 views with many viewers reaching out and providing testimonies of the good it is doing. Bryon Sanford shared the show has now been picked up by PureFlix and stated Mr. Weaver wrote a huge thanks goes out to the City of Montgomery for continued support.

Dear MEDC members,

On August 13, 2022, I organized the first Lone Star Street Dance. It was held in the parking lot of Jacob's Property and was only promoted through a Facebook Page that I created for the event. The community response to the event was amazing. I am approximating that we had around 800 people attend the first event and the interest in another event has been very strong. I quickly discovered that additional funds would be needed due to the size of the event. I am including the costs involved to be permitted, insured and have additional security due to the high community interest.

For the 1st event, I paid for the expenses out of my own pocket. I bought a photo booth frame that can be used at future events for \$108.23. I purchased a Snapchat Geofilter so that people attending the event would have a custom banner on their Snapchats that promoted the Lone Star Street Dance for \$7.00 for 2 hours. I had 10 custom color flyers made for \$7.58 to take to local businesses since it was done on very short notice for \$7.58. I bought roughly \$20.00 worth of bottled waters to hand out due to the heat. I also spent \$89.90 to purchase 10 cardboard trash receptables but I was able to return those and have them donated by Waste Management. Trash bags to fit the donated boxes were purchased as well as balloons. The DJ donated his services for free that evening with a value of \$600 for his services.

As this event goes forward, we will need roughly \$2500 per event for insurance (\$900), police officers to do security (\$800 for 4 officers), a reduced rate of \$400 to the DJ and then \$250 for the permit fees and deposits. I am requesting \$5000 for the next 2 events to be held on 10/22/22 and then also in the 1st quarter, date to be determined. I would like to ask for this to be put in the budget as a quarterly event going forward. It is a great way to promote the Downtown Historic Montgomery area and its businesses.

Thank you for your submittal, dated Monday, August 22, 2022.

A review of the street festival permit application for the September 24, 2022 Lone Star Street Dance has been completed. $2\sqrt{2}$

The following requirements must be met prior to permit

issuance:

- Submit permit fee payment. The fee for the street festival permit shall be \$50 with a clean-up deposit of \$200 that shall be paid prior to issuing the permit.
- 2. Site plan. A revised site plan was submitted August 24, 2022. The revised site plan shows the closure of two streets, College and McCown. It appears that access to the parking lot of the Montgomery Community building will be blocked during this event. Please let us know, in writing, your safety plans and traffic control for accommodating general parking on this property. (*Note, if the Montgomery Community building is reserved for use by another group, you must submit an alternative plan to address the other group's use of the community building.)
- Barricades. An assessment of the schedule and placement of barricades will be addressed by the City Public Works Department.
- 4. Police assessment. Based on the enlarged location of the event, the increase in the number of attendees (from 100 to 500), and the inability to control alcohol coming in from outside sources, a minimum of four (4) on-sight officers will be required for the duration of the event. (The officers have a 4 hour minimum so they will be on-

sight from 6:30 pm to 10:30 pm. The Pay Rate for this job is \$50 per hour per officer). Montgomery Police Officer Lozano will have the officers names available to you before the event.

- Fire/EMS assessment. No FD/EMS on-site presence is needed.
- 6. Music. (a) Please ensure that the DJ has the appropriate license to play artists' music in public. (b) The application indicates the use of loudspeakers. An amplification permit is required if the sound exceeds 65 dB(A) up to 10:00 pm (heard from a residential property) or exceeds 68 dB(A) (heard from a nonresidential property). The President of the MEDC has spoken with several of the downtown business owners who have shared two sentiments:

- They are enthusiastic about participating in the event.
- Purchasing candy for such a large number of children is becoming a financial obstacle.

In an effort to help defray the cost for downtown businesses, staff recommends discussing the event and considering funding the cost of the candy for downtown businesses. This can be accomplished two ways:

- 1. MEDC purchases the candy in bulk and distributes to the downtown businesses with a simple form that ensures the candy purchased will be used for the event.
- 2. Reimbursing individual businesses for some or all of the candy purchased for the event. This would increase the variety of candy given out and takes the burden off of city staff in purchasing, storing, and distributing the candy.

Dear Mayor and Council:

The following is a brief summary that describes our activities since the July 26, 2022 Council Meeting:

Capital Projects:

1. Water Plant No. 3 Improvements – We did not receive a pay estimate this month. Construction of the project is substantially complete. The final inspection was held on August 3rd and the contractor is working to address punchlist items identified at the final inspection.

2. GLO Projects

a. Water Plant No. 3 Generator – Quiddity issued a notice to proceed on May 16th. It is our understanding the contractor is experiencing delays in the generator arrival. It is also our understanding Quiddity requested that the contractor proceed with construction of the generator slab.

b. Dr. Martin Luther King Jr. Drive Ditch Regrading and Sanitary Sewer Rehabilitation — Enclosed as Attachment No. 1 is Pay Estimate No. 1 in the amount of \$55,948.50. The contractor is 12% complete by value and 17% complete by time. The contractor is continuing work on the cured-in-place-pipe lining of the sanitary sewer lines.

- 3. 2022 Sanitary Sewer Cleaning and Televising Phase 1 We did not receive a pay estimate this month. As a reminder, CCML,LLC dba Pinnacle Pumping Services is no longer in business and the work is being completed by MagnaFlow as a subcontractor. MagnaFlow is proceeding with construction, and we have received and are reviewing the televising videos as they are submitted.
- **4.** Clepper Sidewalks As a reminder, the project was awarded to Environmental Allies Inc. in the amount of \$231,279.20 and 90 calendar days. The pre-construction meeting was held on August 12th, and we issued a notice to proceed to the contractor on August 19th.
- **5. 15-Year Infrastructure Plan** We have completed a majority of the requested changes and are proceeding with the additional sanitary sewer analysis as requested. We expect to be complete this month.
- **6. Old Plantersville Waterline Extension** We received the survey of the project area and are proceeding with design of the 12" waterline. We expect to be complete with design by mid-October. As a reminder this project is being funded by the developer.
- **7. Old Plantersville Force Main Extension** We received the survey of the project area and are proceeding with design of the 6" force main. We expect to be complete with design by mid-October. As a reminder this project is being funded by the developer.
- **8.** McCown St. and Caroline St. Waterline Replacement We are coordinating with the surveyor to obtain the survey of the downtown area. Upon receipt of the survey we will proceed with design as authorized at the July 12th Council meeting. We expect to be complete by mid-November.

- 9. Downtown Drainage Master Plan We are coordinating with the surveyor to obtain the survey of the downtown area. We are proceeding with review of record documents to begin gathering information and upon receipt of the survey, we are prepared to begin the drainage analysis of Downtown Montgomery.
- **10. Downtown Sanitary Sewer Rehabilitation** We are proceeding with design as authorized at the July 12th Council meeting and expect to be complete with design in early October.
- **11. Lift Station No. 8 Repairs** We are working with the City staff to determine the most cost-effective way to repair the force main at Lift Station No. 8, including contacting contractors to discuss pricing for multiple repair options.

Developments:

1. Feasibility Studies -

a. There are no ongoing feasibility studies at this time.

2. Plan Reviews

- a. Shipley's Donuts We provided plan approval on August 16th.
- **b.** Town Creek Storage II We received revised plans on July 8th and provided comments to the plans on July 28th.
- **c.** Hills of Town Creek Section 5 We are awaiting a revised plan set from the Developer.
- **d.** Popeye's We did not receive a revised plan set this month.
- **e. Grand Monarch Apartments** We received revised plans on August 16th and plan to provide comments this week.
- **f. Express Oil Change and Tire** We received plans on August 9th and are proceeding with our review.
- g. Pizza Shack We received plans on July 21st and returned comments on August 17th.
- **h.** Montgomery Summit Business Park We received plans on July 21st and returned comments on August 10th. We received additional drainage plans on August 11th and are proceeding with our review.
- i. Pulte Drainage Report We received the drainage study on July 12th and provided comments on August 18th.

3. Plat Reviews

a. Montgomery Brewing Minor Plat – We received the revised minor plat on July 18th and provided comments on July 28th. We are waiting on a revised plat.

4. Ongoing Construction

a. There are no ongoing construction projects at this time.

5. One-Year Warranty Inspections

- Town Creek Crossing, Section 1 The One-Year Warranty Period will end on March 31, 2023.
- **b.** Villas of Mia Lago, Section 2 We are continuing to coordinate with the developer to ensure the remaining punch list items are addressed.

General Ongoing Activities:

1. TxDOT:

- **a. FM 1097 & Atkins Creek Drainage Improvements** We are coordinating with TxDOT to provide any documentation necessary to determine and prepare the easement area that is to be obtained for the project.
- b. FM 149 & SH-105 North Bound Right Turn Lane It is our understanding that TxDOT continues to wait for utilities to be relocated. It is also our understanding that there is approximately 30 days of work remaining once utilities are relocated.
- c. Access Management along SH-105 As you are aware, construction has begun on the access management project along SH-105. According to TxDOT, construction within the City is anticipated to be complete in late summer/early fall 2022. It is our understanding that TxDOT is experiencing delays due to concrete shortages.
- d. Access Management along SH-105 from Grimes County Line to Shepperd Street—We are continuing to identify potential utility conflicts with the SH 105 improvements. According to TxDOT, the first phase of the project is scheduled to let in July 2023.
- **e. FM 1097 and Buffalo Springs Drive Traffic Signal Warrant Analysis** It is our understanding the signal is in design. We do not have an estimated completion date at this time.
- **f. SH-105** and **Buffalo Springs Drive Traffic Signal Warrant Analysis** It is our understanding the signal is in design. We do not have an estimated completion date at this time.
- g. SH-105 and Emma's Way It is our understanding TxDOT is reevaluating and adjusting the timing of the traffic signal at SH 105 and Emma's Way to allow for additional green time for vehicles leaving the Hills of Town Creek Subdivision.
- **2. Biweekly Operations and Developments Call** We are continuing the biweekly operations and developments calls with City Staff and H2O Innovations.
- **3.** Emergency Preparedness Plan No engineering update. We will continue to follow up until plan approval is received.
