**ORDINANCE NO. 2022-**

**AN ORDINANCE CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE CITY OF MONTGOMERY GENERAL ELECTION HELD ON MAY 7, 2022, FOR THE PURPOSE OF ELECTING A MAYOR AND TWO (2) CITY COUNCIL MEMBERS, PLACES 2, AND 4, TO THE CITY COUNCIL FOR THE CITY OF MONTGOMERY, TEXAS.**

**WHEREAS**, a General Election was held in the City of Montgomery, Texas on May 7, 2022, for the purpose of electing a Mayor and two (2) City Council Members to the City Council, Places 2, and 4; and

**WHEREAS**, said election was duly and legally held in conformity with the election laws of the State of Texas, and the results of said election have been verified and returned by the proper judges and clerks; and

**WHEREAS**, it appears that a total of 951 ballots were cast in such election; now, therefore **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MONTGOMERY, TEXAS:**
