A. Resolution 2024-42 - A Resolution of the City of Mount Pleasant, Tennessee to authorize the City to enter into a Professional Services Agreement with Barge Design Solutions, Inc. for a Sewer System Analysis. Infrastructure Planning Grant

Mrs. Jones stated the City applied for and received award for a Fiscal Year 2024 Infrastructure Planning Grant (IPG). Staff proposes to use these funds to develop a sewer system analysis. The analysis will provide the City with a planning tool to determine rehabilitation needs in the inspected areas and budget for future construction system. The City selected Barge Design improvements to the wastewater collection Solutions to perform this work. The purpose of this resolution is to enter into a contract with Barge for the development of a sewer system analysis. The contract, which includes the scope of work will be in your packet. The project timeline is 5 months, and the cost of the engineering is \$208,000.

B. Resolution 2024-43- A Resolution updating the City of Mount Pleasant Cross Connection Plan

Mrs. Jones stated the purpose of this resolution is to adopt a revised Cross Connection Plan. This relates to the city's water system. A cross connection is a link with the public water system and a possible source of water contamination. State law, TDEC Rules, and your ordinances already prohibit cross connections. This plan outlines a course of action to control cross connections in the area of service. The plan will be attached and in the packets. Dale will be here Tuesday, but Phillip can answer any questions you may have. The Plan is an exhibit to the resolution and will be in your packet.

We are having additional signs made and the back entrance is open during business hours and if anyone needs accommodations we will go out and make sure we get them in. Even at the Museum he talked to Ms. Hardison and told her they would help them if they needed it. The Museum is a great asset, and it is a pretty cool place. The Connected Facilities Grant that we were awarded the \$2.2 million we do have a conceptional design back. He will be emailing them in the next couple of days so they can see that.

He stated we did get the ad out for the rebid of East Merchant Street today. Hopefully we are going to open it on the 15th, and it will be on the agenda next month for approval. He jumped ahead to next month and stated the Skid Filter System approved to go to market for a bond several months back. In the meantime, we have been talking to USDA, and we feel like we can get a 25% grant on that so we will have a resolution next month to apply for that. We still have that funding source there, but he thinks anytime we can try to get some grant money we should.

He stated the Police Department did receive their four new vehicles this week. They will be putting them into service soon. He wanted to recognize Sergeant Jesse Lovett who was promoted to sergeant and is assigned to the day shift. He has been with us for five years and over eighteen years of experience.

He stated the monthly report features an employee recognition and this month it was Firefighter Gilbert Marshall who is retiring after twenty-eight years of service for the City. Congratulations to him for that. He was one of the first people twenty-five years ago, when he walked into the fire station out there, that met him at the door. He remembers that like yesterday.

#### **ORDINANCE 2025-1130**

AN ORDINANCE AMENDING TITLE 14, ZONING AND LAND USE CONTROL, CHAPTER 2, ZONING ORDINANCE, OF THE MOUNT PLEASANT MUNICIPAL CODE, THE SAME BEING THE ZONING ORDINANCE FOR THE CITY OF MOUNT PLEASANT, TENNESSEE, INCLUDING THE MUNICIPAL ZONING MAP INCORPORATED THEREIN BY REZONING A PROPERTY FROM LIGHT INDUSTRIAL (IL) to HIGH DENSITY RESIDENTIAL (R-3)

#### APPROVED REZONE – MAGNOLIA DRIVE

WHEREAS, Title 14, <u>Zoning and Land Use Control</u>, Chapter 2, <u>Zoning Ordinance</u>, of the Mt. Pleasant Municipal Code (hereinafter referred to as the "Zoning Ordinance") constitutes the comprehensive zoning ordinance for the City of Mount Pleasant, Tennessee, and incorporated therein is the Municipal Zoning Map; and

WHEREAS, The City Commission of Mount Pleasant, Tennessee has broad discretion to change or amend the Zoning Ordinance for the purpose of promoting the health, safety, prosperity, morals and general welfare of the City; and

WHEREAS, Burchell Properties LLC, submitted an application to the Mount Pleasant Planning Commission staff requesting that said Zoning Ordinance be amended by rezoning approximately 20.53 acres of property located on Magnolia Drive identified as a portion of Tax Map 127, Parcel 25.00, more fully described below and shown on Exhibit A attached hereto from Light Industrial (IL) to High Density Residential (R-3).







Mr. Howell requested that Adams price remove the asphalt through the 174 LF area out to the main (approx. 6' wide) and replace it with the Typical TDOT pavement section. Thank you for taking the time to discuss this matter earlier. As mentioned, we are aiming to incorporate all immediate work into the scope of this change order. Below is the breakdown of the additional items and adjustments for your review:

- Asphalt at Handicap Areas in Phases 1 and 2: There is approximately 1,800 SF of asphalt pavement that is to be removed and replaced with the TDOT-recommended typical section. This will increase the following.
- Item 202- 03.01: Removal of Asphalt Pavement priced at \$50.00 per SY.

**Item 303.01:** Mineral Aggregate, Type Base, Grading D priced at \$90.00 per ton.
