1. Call to Order

4. Approval / Correction of Minutes from Prior Meetings

A. Meeting Minutes from April 9th, 2025

Mrs. McWilliams stated that everyone was sent a copy of the minutes and asked if there was anything that need to be corrected and if not asked for a motion to approve the minutes from the April 9th, 2025 meeting. Mrs. Knowles made the motion that the minutes be accepted as written and Ms. Pepe, seconded that motion. The vote to accept was unanimous.

5. Completion / Review of Unfinished Business from prior meeting

A. Movie Night
