CALL TO ORDER

The Molalla City Council Meeting of November 11, 2021 was called to order by Mayor Scott Keyser at 7:01pm.

CONSENT AGENDA

- A. Meeting Minutes October 27, 2021
- B. Wave Division Holdings, LLC. Rate Information

A motion was made by Council President Childress to approve the Consent Agenda, seconded by Councilor Newland. Vote passed 4-0, with all Councilors voting yes.

PRESENTATIONS, PROCLAMATIONS, CEREMONIES

Community Development Director Corthell explained the next step in the process of creating the Beautification & Culture Committee, which is to appoint members to the CPC. There are four candidates who have applied to steer the committee. They are David Jackson, Roxie Smith, Pamela Lucht, and Connie Farrens.

Council President Childress expressed her thanks to this group, as they have been involved in the Culture & Arts CPC and are dedicated to seeing projects through to completion.

Council President Childress made a motion to appoint all four applicants, seconded by Councilor Shankle. Vote passed 4-0, with all Councilors voting Aye.

ORDINANCES AND RESOLUTIONS

A. <u>Resolution No. 2021-25:</u> Declaring Certain City Property as Surplus, Authorizing the Retirement of the Firearm, and Providing an Effective Date

City Manager Huff requested that Council authorize the retirement of a firearm, for retiring Chief Schoenfeld. It is firearm that Chief Schoenfeld has carried during his time with the City of Molalla.

Councilor Newland made a motion to approve Resolution No. 2021-25, seconded by Councilor Shankle. Vote passed 4-0, with all Councilors voting Aye.

GENERAL BUSINESS

- A. City Hall Remodel 2nd Floor Police Office Improvements Contract Award
- B. RFP #2101-02: Police Facility Project Manager Contract Award

Mr. Huff explained to Council that bids were returned for the City Hall 2nd Floor Remodel. The remodel is to create more office space for the Police Department, until the new facility is built. Staff recommends INLINE Commercial Construction, with the lowest bid.

Councilor Shankle made a motion to award the contract to INLINE Commercial Construction, seconded by Council President Childress. Vote passed 4-0, with all Councilors voting Aye.

Recently the City sent out an RFP for a Police Facility Project Manager. The Police Facility CPC met on Ocotber 20, 2021 and recommended a company named Otak. Staff is recommending the contract be awarded to Otak, as well.

A motion was made by Council President Childress to award the contract to Otak, seconded by Councilor Shankle. Vote passed 4-0, with all Councilor voting Aye.

STAFF, MAYOR, AND COUNCIL REPORTS

- Lt./Chief Long shared with Council that they are in the selection process for Sergeant. There are three internal candidates applying for the position.
- City Recorder Teets reminded citizens that there is a Council vacancy, applications due on December 1st. She also shared with listeners that Council chambers are smaller than usual. People are welcome to attend, however viewing online is best while the Civic Center is under construction.
- City Manager Huff explained to Council that there are many staff changes occuring currently, and asked for patience as we fill positions. Mr. Huff also shared an article from the most current LOC publication, that highlights the new bike/ped path bridge on Molalla Forest Road.
- Councilor Newland reminded citizens of the Veteran's Day celebration being held at St. Jame's Church on Thursday, November 11th from 11am 2pm.
- Councilor Shankle had no report.
- Council President Childress spoke to citizens regarding recent discussion of conflict of interest that has been taking place on social media. She explained the need to recuse ones self, as well as what it means to bring financial gain to one as an elected or appointed official.
- Mayor Keyser announced Coffee with a Cop on Saturday, November 13th at 9am with Sergeant Watkins and Chief Schoenfeld.

Sample Water Bill

Current Rate vs. Graduated Rate (proposed)

Current Water Rates for 3/4" Meter = \$13.82 base rate + \$3.03/100ft3 Water usage

- July Water Use 1,154ft³
 - Base Rate = \$13.82
 - O Water Use Rate = 1,154/100 = 11.54 * \$3.03 = \$34.97
 - **Total Bill** = \$13.82 + \$34.97 = **\$48.79**
- August Water Use 834ft³

A RESOLUTION OF THE CITY OF MOLALLA, OREGON ESTABLISHING WATER RATES AND ANNUAL INFLATION ADJUSTMENTS THEREAFTER AS APPROVED BY MOLALLA MUNICIPAL CODE CHAPTER 13.04

WHEREAS, The Molalla Municipal Code Section 13.04.160 provides that fees for water service be established by resolution of the City Council; and

WHEREAS, the City desires to regularly review the costs of operating, maintaining, and improving the water system; and

WHEREAS, the City has previously established via Resolution No. 2016-08, a schedule of future water rate increases effective July 1, 2016; and

WHEREAS, the City has caused to be prepared a fee rate study which has identified water system costs, rate structure alternatives and equitable cost recovery methods; and

WHEREAS, the City has completed the 2021 Water Management, Conservation and Water System Master Plan. That plan has identified \$40,753,400 in needed water system capital improvements over the next twenty years; and

WHEREAS, the City desires to establish within its water rate structure both incentives for water conservation and the ability for the City to recover the costs of providing water services; and

WHEREAS, the City desires to establish within its water rate structure an annual increase to address inflation, service provision and maintenance.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Molalla as follows:

- **Section 1.** Resolution No. 2016-08 is repealed upon the effective date of this Resolution.
- Section 2. The Water Rates and Fees are established. All Fire Line Rates are set at \$0.00 per month. Rates for all services outside of the City limits shall be 150% of inside-City rates.
- Section 3. Annual inflationary adjustments for all water users shall be effective automatically each year on July 1 based on the published values by the Bureau of Labor Statistics "All Items in West Size Class B/C, All Urban".
- **Section 4.** Meters serving multiple dwelling units shall be normalized by the number of dwelling units for the purposes of determining conservation usage charge blocks.

Section 5. This Resolution is and shall be effective July 1, 2022, and all rates and charges established herein for water customers shall go into effect as of such date.

Fiscal Impact: No change in current Revenue status

Background:

Included with this memo is Resolution 2021- 27 that extends the Transportation System Development Charge (SDC) roll back until July 1, 2022. Council discussed this issue at length between January and May of last year and moved to extend the SDC roll back until January of 2022 (Resolution 2021-17 attached). The proposed Resolution continues the SDC roll back for another 6-months.

Previously, we had mentioned that we were beginning to experience long-term impacts of the COVID-19 pandemic with respect to supply chain and labor availability. We are now experiencing historic inflation increases. Although we are busy, continuing the SDC roll back for at least another 6-months provides the City, as well as the development community additional time all while making needed improvements to city infrastructure.

- 6. The effective date of the revised SDC in Exhibit "A" shall become effective on January 01, 2022.
