## **CALL TO ORDER**

The Molalla City Council Meeting of August 24, 2022 was called to order by Mayor Scott Keyser at 7:00pm.

## **GENERAL BUSINESS**

A. Mercury TMDL Report

Public Works Division Manager Peters shared the Staff report for the Mercury TMDL. The City of Molalla has been working to implement the new requirements for the past two years and has updated its TMDL to comply with these new rules. Care has been taken to identify, and plan for the implementation of, mercury reduction strategies that will meet the requirements while resulting in the least impact to budgets, staff, and the public. He also shared that DEQ has pre-approved our document.

A motion was made by Councilor Robles to approve the Mercury TMDL Report, seconded by Councilor Childress. Vote passed 6-0, with all Councilors voting Ave.

B. Distinguished Budget Presentation Award

City Manager Huff explained to Council that it took many years to accomplish the task of earning the Distinguished Budget Presentation Award. This year is the third year in a row that we have been honored by earning this award. Mr. Huff feels that it is very important for the community to see that the City is fiscally responsible.

Finance Director Seifried shared that each year the award is earned, more tasks and requirements are added. Staff is very proud to have earned this award again.

Council members expressed their thanks and congratulations.

## STAFF COMMUNICATION

- City Recorder Teets shared an Election Candidate with Council. Candidate Ashly Hansen has withdrawn from the election process. This leaves Martin Ornelas, Rae Botsford, Thomas Luttrell, Terry Shankle and Leota Childress running.
- PW Division Manager Peters gave an update on Strawberry Park, which completed this week.
- Community Development Director Corthell shared his thanks to Mr. Peters on the hard work that was put into Strawberry Park, along with the money he was able to save by looking into procurement options. Mr. Corthell shared his monthly director report, which is available on the City's website, as well as the Molalla Current.
- Finance Director Seifried had no report.
- City Manager Huff shared that his focus this week is on Celebrate Molalla.

## **COUNCIL COMMUNICATION**

- Councilor Vermillion shared updates on the MRSD Board Meetings. A town hall meeting has been discussed. The Chamber will hold an election in October for new members. Molalla Cares presented Skate Park committee chair, Rae Botsford, with a check for \$1,411.00.
- Councilor Shankle will have Councilor Childress give a Celebrate Molalla update.
- Councilor Childress shared the history of Celebrate Molalla. She and Councilor Klein worked together with the Ford Family Foundation and the community to create the Vision and Action Plan. When it was complete, the celebration took place.
- Council President Newland is excited about everything going on with the Parks right now.
- Councilor Robles announced Citizenship Classes are beginning at the Library on September 17<sup>th</sup>. She encouraged people to contact the Library for more information. Councilor Robles also shared that the Parks CPC will be at Celebrate Molalla, promoting fundraising opportunities.

SUBJECT: Irrigation Gun Purchase, Determination of Sole Source

FISCAL IMPACT: \$86,000 – Approved in the Adopted Budget for FY 22/23

**RECOMMENDATION/RECOMMEND MOTION:** Approve Resolution 2022-18, Determination of

Sole Source for Irrigation Equipment

**BACKGROUND:** This Resolution is part of a holistic approach being taken by the City to ensure the maximum potential from its existing Wastewater Facilities during this interim period before the new Plant can come online.

During the summer months the City is forbidden by its NPDES Permit to discharge treated effluent to the Molalla River, and has therefore, for many years, irrigated this effluent as recycled water on the Coleman Ranch as part of a mutually beneficial agreement.

The City currently owns four largely identical Irrigation Guns built to a special specification. During certain phases of plant operation, the bottleneck on capacity can be the speed at which we can irrigate this water.<sup>1</sup>

The addition of a fifth gun will directly increase this capacity. In addition, if this fifth Irrigation Gun is built to the same specification as the other four, then the City will benefit from part interchangeability and other redundancy considerations, that will help ensure this capacity is available even during certain kinds of breakdowns.

However, purchasing directly from a single vendor without competition is referred to by Oregon Purchasing Rules as a "Sole Source" Procurement, which must be accompanied by a Finding by the Contracting Agency involved; in this case, the Molalla City Council.

In addition, the rules require that if a Sole Source is the option, the City do its best to ensure favorable terms and prices from the vendor, which City Staff has done during the quotation process by ensuring the price is comparable to Irrigation Equipment built to different specifications. The quote is attached below.

<sup>&</sup>lt;sup>1</sup> This is in order to draw down the lagoons fast enough to levels that allow for maximum holding capacity during months when the City cannot discharge to the Molalla River, but also cannot irrigate because these fields are too wet to do so.



## A RESOLUTION OF THE CITY OF MOLALLA, OREGON RECYCLED WATER IRRIGATION GUN SOLE SOURCE DETERMINATION

**WHEREAS**, the Molalla City Council (the City) is a Local Contract Review Board with Procurement Authority under ORS 279A.050; and

**WHEREAS**, the City has not adopted local procurement rules and is thus subject to OAR Chapter 137, the States' Model Procurement Rules; and

**WHEREAS**, The City wishes to conduct a sole source procurement under OAR 137-047-0275, and ORS 279B.075; and

**WHEREAS**, The local contracting board must make particular findings in order to conduct a s source procurement in accordance with ORS 279B.075.,

## Now, Therefore, the City of Molalla Resolves as follows:

**Section 1.** The efficient utilization of existing goods requires acquiring comparable goods. ORS279B.075(2)(a). The City currently uses four "Big-Guns", all of which have the exact same specifications. To maximize redundancy, part interchangeability, operator training, and standard operating procedures, the new "Gun" must match the build of the existing units.

**Section 2.** Other findings support the conclusion that the goods are available from one source. ORS 279B.075(2)(d). All irrigation "Guns" currently owned by the City were built to specifications that are only available from the Sole Source manufacturer, Valley Fab Corporation.

**Section 3.** Based on the finding adopted in Sections 1 and 2 of this resolution, the City Council, under its authority as the local contracting board, authorizes sole source procurement for the purchase of a new "Big Gun" for irrigation, from Valley Fab Corporation.

**Section 4.** This authorization is subject to the budgetary constraints of the adopted FY22-23 budget and the spending authority of the Molalla Municipal Code.

**Section 5.** This resolution is effective immediately upon passage by the City Council and signature by the Mayor and City Recorder.
