CALL TO ORDER AND FLAG SALUTE

The Molalla Urban Renewal Agency Budget Meeting was called to order by Agency Officer, Dan Huff at 8:57 pm.

PRESENTATIONS, PROCLAMATIONS, AND CEREMONIES

A. Elections of Agency Budget Committee Chair and Vice-Chair

Director Huff explained to Agency Members that before continuing with the agenda, a Chair and co-Chair would need to be elected/appointed.

A motion was made by Agency Member Keyser to appoint Elizabeth Klein as the MURA Budget Committee Chair, seconded by Agency Member Vermillion. Vote passed 14-0, with all Agency Members voting Aye.

Chair Klein resumed the meeting and election of the Vice-Chair.

A motion was made by Agency Member Keyser to appoint Rory Cramer as the MURA Budget Committee Vice-Chair, seconded by Agency Member Vermillion. Vote passed 13-1, with all Agency Members voting Aye and Agency Member Cramer voting Nay.

APPROVAL OF THE AGENDA

A motion was made by Agency Member Keyser to approve the agenda as presented, seconded by Agency Member Newland. Vote passed 14-0, with all Agency Members voting Aye.

BUDGET MESSAGE PRESENTATION

A. Presentation by Agency Director (Huff)

Agency Director Huff presented the Budget message to the Agency Members. Mr. Huff briefly explained the need for an Urban Renewal Agency. Urban Renewal districts set or freeze the value of property within the district, with any growth above the frozen level that the property gains, go back into the district. Tax incremint financing funds are used to pay back bonds, and complete public improvements. In 2008, the funds dropped dramatically. In 2020, the Urban Renewal Plan was updated to reflect the need to build a public safety facility.

A few items that have been identified for MURA funding are: Molalla Forest Road, Police Facility (in hopes of the bond passing), and other items that will be partnered projects.

REVIEW AND DELIBERATION ON FISCAL YEAR BUDGET

A. Proposed FY 2022-2023 MURA Budget Document

There was little deliberation, although Agency Members commended staff for the work that had been put into the Budget. Agency Member Botsford congratulated staff on earning a Budget Award.
