CALL TO ORDER

The Molalla City Council Meeting of October 25, 2023 was called to order by Mayor Scott Keyser at 7:00pm.

COUNCIL ATTENDANCE

STAFF COMMUNICATION

- Police Chief Long shared that on Saturday October 20, 2023, the Molalla Police Department arrested a twenty-year-old male after receiving information he was possibly selling narcotics to high school students. A search warrant was written on the suspects' vehicle and cocaine, LSD, MDMA, Xanax, codeine, psilocybin mushrooms, marijuana, marijuana vape oil, and a loaded firearm were seized as evidence. The suspect was lodged at the Clackamas County Jail and is being charged with two counts of distribution of a controlled substance, unlawful possession of a controlled substance, unlawful possession of marijuana by a person under 21 years of age, and unlawful possession of a firearm. Chief Long shared that this was a result of someone that saw something and reported it, therefore leading to the investigation and arrest.
- Assistant City Manager Corthell had nothing to report.
- City Recorder Teets had nothing to report.
- City Manager Huff shared a memo with Council from the League of Oregon Cities, seeking volunteers for committees. (See Meeting Minute Attachment #6)

COUNCIL COMMUNICATION

- Councilor Botsford shared that her experience attending the LOC Conference as a new Councilor was a very good one. She feels that Molalla is very well informed about government, codes and ordinances
- Councilor Vermillion was unable to attend the Conference and extended his thanks to ACM Corthell for going in his place. He also announced Molalla Fire Department's upcoming Operation Santa Claus Parade.
- Councilor Robles thanked Chief Long and his officers for the dedication to keeping our community safe. She feels it is a privilege to live in a community that is highly protected by its officers.
- Councilor Shankle announced the upcoming Downtown Trick-or-Treat event that will take place on Halloween, an encouraged families to attend.
- Councilor Childress made the following statement, "During the April 27, 2022, Council meeting, I failed to properly announce an actual conflict of interest concerning Molalla HOPE's request for a lease. I self-reported to the State Ethics Commission. I agreed to the terms of the Stipulated Final Order. In lieu of a civil penalty, I have received a letter of education." She also announced that October is National Domestice Violence Awareness Month and provided the number to the hotline at 800-799-SAFE(7233).
- Council President Newland thanked Councilor Childress for the opportunity to announce that one of the features in the new Police Station that may be built is a safety vestibule for people to escape to if they are in need of a safe room. They can go in and lock the doors behind them and then call the Police from the inside. She also announced that there would not be a Parks CPC meeting in November, that they would reconvene in December.
- Mayor Keyser shared his experience at the LOC Conference, stating that City Councilors attended different classes. A
 class was provided for City Managers and Mayors to attend together. He very much appreciates the rapport he has with
 City Manager Huff. He also appreciated the time that Council and staff were able to spend together over dinner, talking
 and collaborating.

SUBJECT: Development Agreement – 1000 W Main St

FISCAL IMPACT: None.

RECOMMENDATION/RECOMMEND MOTION: None.

BACKGROUND:

City Staff is asking for Council's approval or denial to allow full Occupancy of the development at 1000 W Main prior to completion of ODOT required improvements on OR-211. This is not request that staff would typically consider, much less elevate to the Council, but has chosen to in this case for a number of reasons:

- 1. The well known, and ongoing difficulties and delays with the ODOT development process;
- 2. The costs associated with ODOT delays visited upon Molalla developers;
- 3. The long-term neglect of OR-211 by ODOT, that has only been improved by Molalla developers for some time;
- 4. The substantial financial guarantees for improvements beyond the scope of those required in the land use process;
- 5. The desire to provide a fair and reasonable development process to those doing business in Molalla.

If Approved: Prior to occupancy of 1000 W Main, staff will obtain at least 110% bonding for the ODOT improvements required for both 1000 W Main and 105 S Ona Way, and a fairly substantial set of voluntary improvements on OR-211 that the developer has agreed to make (sidewalk along the north side of OR-211 from terminus near Hezzie Ln to halfway between Ona Way and Industrial Way; sidewalk infill in front of church next to Stone Place Apartments; all associated ADA Ramps and stormwater upgrades; and the North intersection of OR-211 and Ona Way).

So, if the developer does not complete the required improvements, or does not move forward with phase 2 at 105 S Ona Way, the developer – through their bond, would still pay for completion of all three sets of improvements along OR-211 (required for 1000 W Main, required for 105 S Ona Way, and voluntary).

If Denied: The developer will experience a \$100,000 per month penalty starting in November.

Good evening, Mayor, and City Council Members

I would like to speak out in support of Bond Measure 3-602. For those that are still on the fence about how important this bond is here are some statistics:

There are currently 17 active police officers in Molalla.

The day shift consists of 2 patrol officers, 1 Sergeant & 1 Student Resource Officer

The night shift consists of 2 patrol officers & 1 Sergeant

The police station was built in 1970's when the population of Molalla was 2,000.

Since that time the city has grown to over 10,000.

The national average number of officers per citizen should be 2.4 per 1,000 so technically we should have a total of 24 officers. We are already 7 officers below the national average for our population of 10,000. Our current location is not sufficient for even the average numbers of officers the city needs. PSU did a 20-year study (in 2022) regarding housing needs for Molalla. The estimated growth projection would see an increase of 5,560 citizens by 2042 making our population growth an average of 755 citizens per year. I personally believe that number is low. Just look at the current construction happening in our city. Who are all those apartment buildings for?

We need this facility to protect our small town feel and keep our streets safe. Once criminals hear that we do not have enough officers to enforce the law you will see an influx of criminal behavior. We know we already have drug houses in Molalla. I understand there have always been drugs in Molalla. However, for whatever reason it has not affected the safety on your streets. Kids are still able to go outside and play in their yards and ride their bikes through town. If you can imagine a dystopian future of drugs, crime and homeless you would envision Portland, where kids aren't even allowed out in their own front yards.

I have been told on FB that I am fear mongering. Say whatever you wish, I have lived in the "Belly of The Beast" known as Portland and I have seen how things can deteriorate in several years when good people stand by and just watch.

DAVID POTTS-10/25/23 - CITY TESTIMONY IN SUPPORT OF BOND MEASURE 3-602

Protecting Molalla's quality of life is an inherent value most Molalla residents share. Public safety is prioritized to keep our streets and neighborhoods safe. Providing a safe and adequate police station will promote Molalla as a place that values community safety.

The Molalla Police Department and City Hall have shared the same building since early 1970's when the population of Molalla was approximately 2,000. Today's population is a little over 10,000 people. There is not room in the current building for staff workspace, let alone secure storage for arms and evidence.

Currently, the Molalla Police Department operates without adequate headquarters. The space our police work from now is not appropriate for booking and processing offenders. Police currently have limited, shared desk space to fill out necessary paperwork in the office. Officers do not have adequate lockers, showers or changing facilities. Security needs currently exceed capacity, and there is no room for on-site training or community meetings.

There is no secure temporary holding facility in Molalla, which causes safety concerns when dealing with violent offenders. Molalla is losing officer time and weakening our law enforcement capacity as a result. There is no secure police parking lot or protected garage.

The planned police station would allow us to use our limited police force capacity to maximum effect, increase efficiency and improve our support for the sworn officers who serve our community.

This increased capacity would enable Molalla to have an emergency coordinating center with capacity for wildfire response and other natural disasters.

SUBJECT: Building Resilient Infrastructure Communities (BRIC) Grant

FISCAL IMPACT: Up to \$12 million in potential funding

RECOMMENDATION/RECOMMEND MOTION: Approve.

I move that the Molalla City Council does support staff submittal of a BRIC Grant application for funding to Study, Design, and Construct a new 2.0mg Water Reservoir and new Water Intakes. I further move that the Mayor is authorized to sign a letter of support for these grant projects, and the City Manager is authorized to sign the necessary application documents.

BACKGROUND:

Every 5-years, the City of Molalla must submit an addendum to the Clackamas County Hazard Mitigation Plan that is submitted to State OEM and finally to FEMA.

The addendum identifies hazards in Molalla, how likely/frequent those hazards are to occur, and what actions may be taken to mitigate the impacts of those hazards. Once approved by FEMA, several pots of Federal money are made available as grants to fund the projects contained in the plan.

With this in mind, City staff has intentionally and appropriately ensured that those projects in the City's Capital plan with a hazard mitigation element are included in the City's addendum as hazard mitigation actions. The application for BRIC grant funding is part of the City's larger plan to seek financial support for major projects. The new intake and reservoir are expected to cost over \$11 million to study, design, and construct. City staff has been preserving Water Capital funds and Water SDC's to help meet the match requirements for this opportunity.

Additionally, staff has obtained commitments for letters of support from Molalla Fire, Molalla River School District, and Clackamas County OEM if this proposal is approved. Staff also intends to engage state and federal elected officials for support of these projects if this proposal is approved by the Council.

SUBJECT: MMC Table 17-2.2.030, Bars and Taverns

FISCAL IMPACT: N/A

RECOMMENDATION/RECOMMEND MOTION: Provide Feedback

BACKGROUND:

Molalla's Development Code currently allows Bars and Taverns to operate, subject to Conditional Use Permit review, in both Commercial Zones (C-1 and C-2) and in the Light Industrial Zone (M-1).

But, any Bar or Tavern established after 2010 "must not be located within 500 feet of another Bar or Tavern."

The code does not define a Bar or Tavern, and does not define how to administer the 500-foot rule (e.g. property line to property line, door to door, building to building, etc...).

With these concerns in mind staff took this provision to the Planning Commission on 10/4/23 for a recommendation concerning this provision and the Planning Commission voted to remove the 500-foot standard and merge the Bars and Taverns use with the same category used for restaurants – Commercial and Retail Sales and Services.

This would remove the 500-foot prohibition and alleviate the need to define Bars/Taverns, and interpret how to measure the 500-foot prohibition. However, it would also remove the ability to place a Bar or Tavern on Light Industrial (M-1) property.

Below staff has provided 3 logical options for handling of the 500-foot prohibition:

- 1. Leave it in place, define Bars and Taverns, and interpret how to measure the 500-foot rule.
- 2. Adopt the planning commission's recommendation to merge the category with Retail Sales and Services thereby eliminating the 500-foot rule and Conditional Use permit requirement, but also eliminating Bars and Taverns from the M-1 zone.
 - a. Eliminates the need to define Bars and Taverns
- 3. Eliminate the 500-foot rule for Bars and Taverns, change the use to Permitted in the C-1 and C-2 Zones (instead of Conditional Use) and allow them in the M-1 zone subject to Conditional Use.
 - a. A definition for Bars and Taverns would still need to be developed

SUBJECT: Civic Center Bathroom & ADA Improvements Contract Award

FISCAL IMPACT: \$128,825.64

RECOMMENDATION/RECOMMEND MOTION: Approve.

I move that the Molalla City Council Accept the Bids outlined in the Recommendation Letter and Award the Contract to ATK Construction Inc. for \$128,825.64 for Project 21-10 Civic Center ADA Improvements.

BACKGROUND:

The City of Molalla was awarded a CDBG grant to complete ADA improvements at the Molalla Civic Center including:

- 1. Remodel of the Public Restroom to meet ADA Compliance
- 2. Replacement of Sidewalk Ramps on the outer edges of the Civic Center Driveway to meet ADA Compliance (includes relocation of the bus shelter about 10 feet north to allow room for ADA ramp and to provide ADA access to the shelter).
