CALL TO ORDER

The Molalla City Council Meeting of May 25, 2022 was called to order by Mayor Scott Keyser at TIME

COUNCIL ATTENDANCE

Present: Mayor Scott Keyser, Council President Jody Newland, Councilor Elizabeth Klein, Councilor Leota Childress, Councilor Terry Shankle, Councilor Crystal Robles, and Councilor Eric Vermillion.

A motion was made by Councilor Childress to approve the Consent Agenda, seconded by Councilor Vermillion. Vote passed 7-0, with all Councilors voting Aye.

PRESENTATIONS, PROCLAMATIONS, CEREMONIES

A. Interfor Presentation

Mr. Zach Haas from Interfor submitted regarding Oregon Department of Forestry Habitat Conservation Plan. The letter was read by Mayor Keyser in its entirety.

City Recorder Teets requested that Mayor and Council move Item 8A to Item 4B. Council agreed by consensus, and the Skate Park Presentation followed.

B. Skate Park Presentation - Family of Timateo De La Cruz

Ms. Salena De La Cruz-Forsythe presented a slide show to Council requesting the renaming of the Molalla Skate Park, in honor of her brother, Timateo De La Cruz. Ms. Cruz shared a suggested timeline, and offered her assistance in the project. Mayor Keyser explained that currently there was not a policy of this nature in place. He stated that Council would like to look into renaming a park. Mayor Keyser thanked Ms. De La Cruz-Forsythe for her time, and shared his condolences to the family.

Connie Gordon, supporter of Timateo De La Cruz, submitted a letter to the City Recorder also requesting the renaming of the skate park.

PUBLIC COMMENT

None.

PUBLIC HEARINGS

A. Molalla Enterprise Zone Re-Designation and Expansion

Community Development Director Corthell explained that the process for re-authorization and /or expainsion of an enterprise zone requires special notice to all taxing districts in the zon, public outreach, and a public hearing to provde those effected with a chance to comment. Staff has completed all notice requirements for this hearing.

Businesses locating or expanding in an enterprise zone may be elibile to receive an expemption from property taxes for three to five years on new investments including building contstruction, improvements, and equipment.

Mayor Keyer opened the Public Hearing for the Molalla Enterprise Zone Re-Designation and Expansion at 7:31pm.

Mr. Todd Gary of the Molalla Fire Department, spoke in favor of the re-designation. Mr. Gary stated that something for Council to consider when bringing new business to town is insurance rates. Mr. Gary referenced the ISO (Insurance Services Office) and how it relates to insurance for the business community. High insurance rates can become a deterrant to business owners.

Councilor Klein reference the four districts as City, Fire, School, and Aquatic Center. She wanted to know if the exeption would impact all of them. Mr. Corthell responded yes.

Councilor Shankle asked Mr. Corthell if other businesses have taken advantage of the incentive in the past. Mr. Corthell shared that Pacific Fiber Products (PacFiber) and Licotek Medical each have.

This opportunity is eligible to industrial businesses only, not for grocery, retail, construction, and finance institutions. This is geared towards industrial jobs. Mayor Keyser asked if Dansons would fall into this category, Mr. Huff replied yes, if they were to apply and meet critera.

Mayor Keyser closed the Public Hearing at 7:46pm.

ORDINANCES AND RESOLUTIONS

A. <u>Resolution No. 2022-05</u>: Authorizing the Partial Release of the Municipal Lien on Property Known as 12786 S. Toliver Rd.

Mr. Corthell shared the Staff Report representing this Resolution. This property is scheduled to be used by ODOT for the Hwy 213 Round-a-Bout project. This property is currently liened by the City. ODOT is requesting a partial lien, that provides the space that ODOT needs, while honoring the lien with the City.

A motion was made by Councilor Vermillion to approve Resolution No. 2022-05, seconded by Councilor Shankle. Vote passed 7-0, with all Councilors voting Aye.

GENERAL BUSINESS

C. Planning Commission Discussion

City Manager Huff stated to Council that included in packets is the current Molalla Municipal Code language for Planning Commission and Council. Any decision to change current language is Council responsibility.

Rae Botsford, Planning Commission Chair, approached Council with a few items from her six years on the Planning Commission regarding a Hearings Officer. Ms. Botsford agreed with Council regarding the importance of having a quorum in order to hold meetings. She shared that in past years, there have been difficulties filling seats on the Commission, therefore at times making it hard to hold a meeting. She also shared her concern of having a Hearings Officer, is citizen involvement and education.

Mayor Keyser stated that currently there isn't anything in our Code regarding how an open Planning Commission position is filled. He would like Council to consider having a Public Notice created, giving other citizens an opportunity to apply. He also addressed the importance of attendance for those appointed, as meetings are held once a month.

Mr. Corthell suggested a Work Session for Council to evaluate current language, including edits and suggestions.

D. Contract Award: RFP for Auditing Services

A motion was made by Councilor Vermillion to approve the contract award for Auditing Services, seconded by Councilor Robles. Vote passed 7-0, with all Councilors voting Aye.

STAFF COMMUNICATION

- Public Works Division Manager Peters had no report.
- Community Development Director Corthell shared the monthly Community Development Department report with Council.
- City Recorder Teets announce that June 1st, Candidate packets for the November 2022 General Election will be available.
- City Manager Huff informed Council that he would provide upcoming meeting dates for the Police Facility CPC.

COUNCIL COMMUNICATION

- Councilor Vermillion announced the dates and times for upcoming Chamber and MRSD Board Meetings.
- Councilor Robles shared that the Library will be holding a Repair Fair this Saturday.
- Councilor Childress addressed Mayor Keyser regarding recent posts on Facebook involving Molalla Cares nonprofit organization. She referenced money that is being held for the Skate Park, as well as the Molalla River Jam proceeds that will be used the following year. Ms. Childress is requesting proof of the IRS Determination Letter for Molalla Cares, or if there is not one, that Mayor Keyser not reference that there is one to the public. Mayor Keyser responded that Councilor Childress is welcome to contact his CPA for Molalla Cares.
- Councilor Shankle had no report.
- Councilor Klein had no report.
- Council President Newland announced that the Molalla Farmer's Market is starting this week. The Library is bringing back the Music in the Park series this summer. She also encouraged people to get involved in our community, as there are many volunteer opportunities.
- Mayor Keyser reminded people of the upcoming Molalla River Jam, encouraging people to carpool if possible. A Saturday Market is also being held. There are no other tickets available.

Oregon Department of Forestry Habitat Conservation Plan

Thank you for the opportunity to speak with you tonight about the States Proposed Habitat Conservation Plan and draft Environmental Impact Statement (EIS). As some of you may already know the Oregon Department of Forestry is embarking on a Habitat Conservation Plan to cover the State Forests of Northwest Oregon, which on the surface may sound like a good idea but after reading the draft EIS the its clear that the plan will have some severe consequences as a result. Current Iterations show a 50% reduction in available acreage for harvest from state forests, which would severely reduce the annual output of timber sold from state forests and forecasts show that the revenue generated from reduced harvests will not support operating costs of the department, making them rely on general fund dollars which they do not currently do.

Interfor operates a sawmill in Molalla, OR and employs 125 people. We currently produce around 180 Million Board Feet of lumber per year and directly employ 125 people at our mill. We also operate a sawmills in Philomath, OR, and Longview, WA which both employ about the same amount of people and rely on State Forest Volume for a portion of their timber supply. Oregon Forest Industries Council estimates that approximately 11 jobs are created with the harvest of 1 million board feet of timber. For just our Molalla mill that equals about 825 jobs that are supported by our operation, many of those jobs are here in Molalla. During the scoping process for the draft EIS many mills were not contacted about employment numbers and potential effects of reduced harvest from state forests.

In our current situation in the aftermath of the 2020 wildfires 100's of thousands of acres burned locally which will effectively put those acres off the table for available harvest for at least the next 40 years. The United States Forest Service is planning on reducing harvest levels in region 6(Oregon and Washington) by 200 million board feet per year for the next 5 years, and in Oregon private forests will subject to new laws that will reduce available acres for harvest with increased stream buffers on private lands. All of this reduction is expected to take out 7 sawmills in Oregon over the next 40 years. In the meantime we are also dealing with increased fire prevalence on the landscape and millions of acres in need of forest management treatments. Reducing harvest on public lands will effectively reduce the contractor pool available to treat acres in need, this coupled with the disappearance of sawmills will reduce our states capacity to process logs that would come from these treatments.

As an industry collectively we would like for the state to re-analyze the EIS and their proposed habitat conservation plan and put forth an alternative that would treat more acres to increase forest resilience to wildfire and insects and disease. If the state chooses not to do so our preference would be for them to choose option 5 in the HCP or the increased harvest alternative. With a good portion of the

population of Molalla working in the forest products sector and lumber being one of the most important economic drivers in the City we ask for your support by sending a letter and comments to NOAA fisheries (EIS Preparer), the state forester and the board of forestry asking for more alternatives to be explored that would exclude fewer acres from harvest, and if they cannot do that at lease choose option 5.

Thank you for the opportunity to present this important information and for your willingness to support the forest sector economy in Molalla.

BACKGROUND

- May of 1997 five local skaters approached their teacher, who just happened to be the mayor of the city, Mike Clarke, for a skate park
 - Timateo De La Cruz
 - Daniel Beaudry
 - Mike Arrigo
 - Shawn Noble
 - Doug Noble
- Mayor Clarke stated that he would support the endeavor with a proposal
- Timateo reached out to me (his sister) and asked for help with the proposal
 - Non-profit, SkatePark Investors was formed by Salena to start the process
 - Proposal was written up and the initiative was approved June 1997

HOW WE GOT THERE

- For three years, Salena and the original skaters worked to fundraise, hosted skate competitions and stayed actively involved in the skater park
- The skaters shared their blood, sweat and tears by committing to this body of work by having their hands in the dirt, laying concrete, promoting the skate park
- June 24, 2000, the skate park officially opened up with a skate competition
- We continued to have skate competitions until 2007, when Salena gave the reigns to younger brother Timateo as a skate liaison
 - Timateo continued to skate and visit the park and mentor local skaters and bust out his own moves.





OVERVIEW

I am pleased to submit this proposal to the Molalla City Council on behalf of my brother, Timateo De La Cruz, who recently passed away. My goal is to see the City of Molalla Skate Park renamed to the Timateo De La Cruz Memorial Skate Park.

The Objective

- Need #1: Rename the current City of Molalla Skate Park to the Timateo De La Cruz Memorial Skate Park.
- Need #2: Rename any future skate park the same Timateo De La Cruz Memorial Skate Park.
- Need #3: Assist the City as needed in the renaming and have a grand renaming event.

Support for this Endeavor

- Support #1: Timateo was raised in Molalla and graduated Molalla High School. He is and was well-known among the community and skaters alike.
- Support #2: Timateo was an integral and instrumental person in advocating for the development of the Molalla Skate Park.
- Support #3: What better way to get people to start talking about the skate park again and get more people involved then to rename it after a hometown boy that started the work.

OUR PROPOSAL

Background

In May of 1997, SkatePark Investors was given the opportunity to help local skaters; including the CEO's young brother, Timateo De La Cruz, make their dreams of having a skate park in town a reality. Salena De La Cruz, CEO, welcomed the chance to give back to a place she had called home for most of her life. Skate Park Investors has worked for more than four years to help make the Molalla Skate Park a success by donating their time, money and determination. I have

worked in conjunction with the City of Molalla and local skaters to establish a place where skaters can call their own and not worry about getting police called on them for various complaints ranging from noise to just good old fashioned FUN. SkatePark Investors recognized the need for such a place and facilitated the meetings between the city officials and the skaters. Though it wasn't an easy task, we eventually were able to begin construction of the park. With a lot of volunteer time, and energy the skaters now have a home to call their own. On June 24, 2000, the Molalla Skate Park opened up for blading and boarding.

After the dream took flight, SkatePark Investors was still actively involved in the skate park from minor complaints to promoting and hosting skate competitions until late 2007. Fast forward to 2022, where a new initiative is coming together to develop a new/better skate park. We are not trying to dissuade or hinder that effort. Our intention is to support and promote the renaming of the current skate park and any newly developed skate park as the Timateo De La Cruz Memorial Skate Park.

Timateo was one of the original skaters that brought this endeavor to city council. Had it not been for that first step we may not even have the current skate park we do. Timateo drove those initial conversations to get the ball rolling. He reached out to me to assist in moving this body of work forward. I handled the business and technical logistics, met with city representatives, coordinated with skate industry leaders. Timateo was a friend to all, skaters and community members. He had a heart. Mike Olson of Portland took first place among the rollerbladers. Molalla's Tim DeLacruz took second place and Daniel Beaudry took third.


Ten of the entrants were rollerbladers, three were skateboarders.

Rollerbladers seek community help

 Some complain as skaters leave downtown for homemade ramps near their homes

The rollerbladers are at it again.

No, they're not scaring shoppers out of their wits as they fly past within inches of upsetting people carrying bags of groceries.

They came to the Molalla City Council Sept. 10 to continue pleading their case — a case that they brought to the council several months ago.

Acting as spokesman, Sclena DeLacruz, the sister of rollerblader Tim DeLacruz, asked the council for permission to close off a section of Shirley Street in front of the Buckeroo grounds Saturday. Oct. 4 for a public competition.

She said the boys hadn't received much response from the business community in their attempt to gather support for a local skate park, so they hoped the public meet would show the community what they're all about and raise some money at the same time.

Although the council said it supported the boys' efforts, it was hesitant to close the road and suggested the newly paved parking lot at the middle school might be a better location.

Some councilors also said they were concerned about the hability issue.

After running into problems from skating on private property, three of the boys approached the council several months ago asking the city's help in building a skate park, similar to the one in Salem, only on a smaller scale.

The council and police chief asked the boys to research the project and contact local businesses to raise money, material and labor since the city had no money in its budget for such a project.

The boys spent the summer visiting other skate parks in the state, but haven't received much response from local businesses, they said.

Selena DeLacruz said Avison Lumber said it was willing to donate some lumber and Mark at Sentry Market said he knew a local man who was willing to do the concrete work for the ramps

Tired of waiting the boys got together and built their own wooden ramps, which they've set up in the 800 block of Southeast Fenton.

Nearly everyday after school, the boys can be seen twisting and turning as they fly off the ramps, to the consternation of some drivers and neighbors.

Although most of the neighbors appear to be supportive, at least one neighbor is suspected of complaining to the police, another neighbor said.

Tim Delacruz said officer Homero Reynaga came by last week and warned the boys that if the police received another complaint, a citation would be issued.

Selena DeLacruz said the Oct, 4 date was about the latest they figured they could hold such a skate meet before the ramy days of winter set in.

She figured they would charge entrants \$1 apiece and onlookers \$2 apiece to try to raise money for the skale park

RE: Re-Designation and Expansion of Molalla Enterprise Zone

Molalla Fire District has great concerns over the Re-Designation and Expansion of the Enterprise Zone. The record inflation rate and fuel costs are at all-time highs and the Fire District is very concerned about any possible loss of revenue.

Enterprise Zones normally last 3 to 5 years but in Molalla Enterprise Zone, a business can apply for additional Enterprise Zone tax exemption throughout the life of the Enterprise Zone.

Due to lost revenue, any extensions past the 3 years to a business could prove to be detrimental to the Molalla Fire District with reduction of staffing levels available for emergency apparatus to meet the demands of the continued increase in emergency call volume. Along with the reduced revenue, the actual cost of fire suppression, training expenses and call response will continue to fall on the citizens and businesses outside of the Enterprise Zone in which this area retains fire services at no cost.

In addition to the Enterprise Zone, The Fire District currently sees a loss of over \$35,000.00 annually from Molalla Urban Renewal District. At this time, the Urban Renewal District does make the Fire District whole. Monies from the Urban Renewal District can only be used for capital projects, not to hire paramedics or general expenses. The Fire District Board would like to work with the Urban Renewal District for an easy and seamless way towards the Fire District being made whole every year.

The Molalla Fire District Board of Directors understands the value of bringing business and jobs to Molalla and would like to work closely with the Urban Renewal District and the City of Molalla to ensure the best possible coverage to the structures and people in all areas of the city and the Fire District of Molalla at a fair and reasonable expense to our citizens and businesses.



- 1. To have prepared on its behalf and to adopt an ordinance or resolution for the issuance of its bonds containing such items and in such forms as are required by State statutes and as are agreeable and acceptable to the Government.
- 2. To refinance the unpaid balance, in whole or in part, of its bonds upon the request of the Government if at any time it shall appear to the Government that the Association is able to refinance its bonds by obtaining a loan for such purposes from responsible cooperative or private sources at reasonable rates and terms for loans for similar purposes and periods of time as required by section 333(c) of said Consolidated Farm and Rural Development Act (7 U.S.C. 1983(c)).
- 3. To provide for, execute, and comply with Form RD 400-4, "Assurance Agreement," and Form RD 400-1, "Equal Opportunity Agreement," including an "Equal Opportunity Clause," which clause is to be incorporated in, or attached as a rider to, each construction contract and subcontract involving in excess of \$10,000.
- 4. To indemnify the Government for any payments made or losses suffered by the Government on behalf of the Association. Such indemnification shall be payable from the same source of funds pledged to pay the bonds or any other legal ly permissible source.
- 5. That upon default in the payments of any principal and accrued interest on the bonds or in the performance of any covenant or agreement contained herein or in the instruments incident to making or insuring the loan, the Government at its option may (a) declare the entire principal amount then outstanding and accrued interest immediately due and payable, (b) for the account of the Association (payable from the source of funds pledged to pay the bonds or any other legally permissible source), incur and pay reasonable expenses for repair, maintenance, and operation of the facility and such other reasonable expenses as may be necessary to cure the cause of default, and/or (c) take possession of the facility, repair, maintain, and operate or rent it. Default under the provisions of this resolution or any instrument incident to the making or insuring of the loan may be construed by the Government to constitute default under any other instrument held by the Government and executed or assumed by the Association, and default under any such instrument may be construed by the Government to constitute default hereunder.
- 6. Not to sell, transfer, lease, or otherwise encumber the facility or any portion thereof, or interest therein, or permit others to do so, without the prior written consent of the Government.
- 7. Not to defease the bonds, or to borrow money, enter into any contractor agreement, or otherwise incur any liabilities for any purpose in connection with the facility (exclusive of normal maintenance) without the prior written consent of the Government if such undertaking would involve the source of funds pledged to pay the bonds.
- 8. To place the proceeds of the bonds on deposit in an account and in a manner approved by the Government. Funds may be deposited in institutions insured by the State or Federal Government or invested in readily marketable securities backed by the full faith and credit of the United States. Any income from these accounts will be considered as revenues of the system.
- 9. To comply with all applicable State and Federal laws and regulations and to continually operate and maintain the facility in good condition.
- 10. To provide for the receipt of adequate revenues to meet the requirements of debt service, operation and maintenance, and the establishment of adequate reserves. Revenue accumulated over and above that needed to pay operating and maintenance, debt service and reserves may only be retained or used to make prepayments on the loan. Revenue cannot be used to pay any expenses which are not directly incurred for the facility financed by USDA. No free service or use of the facility will be permitted.

According to the Paperwork Reduction Act of 1995, an agency may not conduct or sponsor, and a person is not required to respond to, a collection of information unless it displays a valid OMB control number. The valid OMB control number for this information collection is 0572-0121. FISCAL IMPACT: \$10,800 for FY 22/23

RECOMMENDATION/RECOMMEND MOTION: Approve Addendum to the Judge Contract.

BACKGROUND: Since we approved in June of 2021, we have examined the wage component of the contract and found it to be deficient. Staff has worked with Judge Heil for an appropriate update to the contract (addendum attached) and recommend Council approval.

ADDENDUM FOR MUNICIPAL JUDGE FOR THE CITY OF MOLALLA

This Contract is to be amended as follows:

SECTION 5. COMPENSATION AND REPORTING

JUDGE will perform duties described above at the rate of \$2,700.00 per month.

Requests for any compensation adjustments must be made to the City Manager and approved by the City Council between January and March of a given year for budgeting purposes. Any adjustment granted will go into effect at the beginning of the fiscal year (July 1.)

SECTION 10. TERM OF AGREEMENT

This AGREEMENT shall commence on July 1, 2022 and will run continuously for two years. This AGREEMENT will roll over automatically after being reviewed by City Council.

JUDGE serves at the pleasure of the City Council. Therefore, this AGREEMENT may be terminated effective by either party for any reason upon (60) days' written notice of the party's intent to terminate. In the event this agreement is terminated, JUDGE shall receive compensation only for Services performed up to the last day of work performed as a JUDGE.

SECTION 12. GENERAL PROVISIONS

IN WITNESS WHEREOF, the City of Molalla has caused this AGREEMENT to be signed and executed in its behalf by its City Council and duly attested by its City Recorder, and AGENT OF THE CITY has signed and executed this AGREEMENT, both in duplicate, the day and year first above written.

AGREEMENT FOR MUNICIPAL JUDGE FOR THE CITY OF MOLALLA

This AGREEMENT ("Agreement") is made and entered into this 1st day of July 2021, by and between the CITY OF MOLALLA, a Municipal Corporation, hereinafter called "CITY," and Lucy Heil, hereinafter called "JUDGE" both of whom agree as follows:

WITNESSETH

WHEREAS, the City desires to contract for the services of said JUDGE as Municipal Judge of the City of Molalla;

WHEREAS, it is the desire of the Molalla City Council to establish certain conditions under this contract with said JUDGE;

WHEREAS, JUDGE desires to contract with City as Municipal Judge of said CITY.

SECTION 1. CONTRACT

CITY hereby contracts with JUDGE as the Municipal Judge of said CITY to perform the functions and duties specified in City Charter, attached hereto, and incorporated by reference herein; and to perform such other legally permissible and proper duties and functions as may from time to time arise in the operation of the Municipal Court. This AGREEMENT may be modified in writing when there is agreement by both parties.

SECTION 2. DUTIES

- a. Duties include all normal duties of Municipal Judge acting in that capacity for the Municipal Court. These duties include, but are not limited to, having regular arraignments, accepting pleas, conducting bench trials, presiding over jury trials as necessary, and conducting sentencing hearings. It may be necessary to conduct a jury trial on a separate day from regular court day. The JUDGE also issues warrants, such as bench warrants for criminal non-appearances and administrative search warrants, reviews probation reports, and has probation violation hearings. The JUDGE must be available for telephone calls or video conferences to consider probable cause affidavits and other court matters.
- b. JUDGE will perform work in a manner according to professional standards observed by those in the municipal court judge profession. JUDGE shall maintain membership in good standing with the Oregon State Bar.
- c. The Municipal Court Clerk assists the JUDGE with paperwork and necessary orders. The JUDGE may review court programs, court fines, court charges, and court procedures that are consistent with applicable law. The JUDGE may issue court orders establishing the procedure and amounts of fees consistent with applicable law. The JUDGE will keep the Municipal Court Clerk apprised of changes in laws and procedures. The JUDGE, Municipal Court Clerk and City Prosecutor will meet to review calendars and programs applicable to court operations.
- d. While it is agreed that JUDGE shall personally serve as Municipal Court Judge and shall be available to fill the duties of that office generally not less than eighty percent of the time needed to fulfill those duties, it is anticipated that ethical conflicts, scheduling conflicts, vacations, illness, and etcetera will occasionally require the employment of pro tem municipal judges. It is understood that it is in the interest of both parties to maintain an active pro tem judge so that the work for the Municipal Court will not be interrupted when JUDGE must be absent from that position. Therefore, JUDGE shall provide at her own expense, a pro-Tem Judge, who shall sit and hear cases when the JUDGE is absent due to illness, vacation, or when conflicts arise. The pro-Tem Judge or Judges shall be approved by the City Council. To accommodate Council approval, JUDGE shall submit to the City Council the names of those persons whom she wishes to nominate as pro tem judges for the term of this Agreement within twenty days of the effective

date of this AGREEMENT or when a vacancy occurs in the pro-tem position. These persons shall be members of the Oregon State Bar, and in good standing. Any pro tem judge shall also be an independent contractor and not an employee of the City and shall, in JUDGE'S absence, provide the same services listed in this AGREEMENT.

- e. The JUDGE will not represent any clients in legal matters where the City is involved, whether in Municipal Court, Clackamas County Circuit Court, or any in any other court of competent jurisdiction.
- f. The Council shall conduct an evaluation of the JUDGE'S performance annually. The JUDGE is to develop a self-evaluation form each year and turn it in to the City Manager for the City Council no later than 60 days prior to the scheduled performance review. The date of the evaluation shall be no later than March 31 of each year.
- g. The CITY agrees to notify the JUDGE promptly when a citizen is lodged in jail on a Molalla Municipal Charge.
- h. Part of JUDGE'S duties may also require the JUDGE to go to the Clackamas County jail located in Oregon City to arraign defendants via video that may be lodged in Clackamas County jail pursuant to a warrant issued by the Molalla Municipal Court.

SECTION 3. CONFLICT OF INTEREST

JUDGE will disclose any actual, apparent, or potential conflict of interest that may exist relative to the services to be provided pursuant to this AGREEMENT. In the event of a potential conflict of interest due to a former attorney-client relationship between JUDGE and an accused, the accused and the City Prosecutor will be given the opportunity to waive the conflict after full disclosure. In the event a former client or the City Prosecutor declines to waive the conflict, a pro-Tem Judge will handle the proceedings. A pro-Tem Judge will be assigned in the event an apparent or actual conflict of interest is identified.

SECTION 4. AGENT OF THE CITY STATUS

JUDGE is an agent of the CITY, and as an agent of the CITY, she is responsible for all employees, subcontractors, and agents performing portions of this work under this AGREEMENT. JUDGE will not be considered an employee of the CITY for the performance of any work under this AGREEMENT.

JUDGE will not be a participant in, nor be in a qualified position as defined by PERS or be eligible for any other benefits provided to CITY employees.

SECTION 5. COMPENSATION AND REPORTING

JUDGE will perform duties described above at the rate of \$1,800.00 per month.

Requests for any compensation adjustments must be made to the City Manager and approved by the City Council between January and March of a given year for budgeting purposes. Any adjustment granted will go into effect at the beginning of the fiscal year (July 1.)

SECTION 6. ANNUAL REVIEW OF OPERATIONS

On an annual basis, JUDGE will prepare a report to the Council regarding court operations. The report shall be provided to the City Manager no later than [insert date].

SECTION 8. COMPLIANCE WITH LAW

- a. JUDGE shall comply with all applicable federal, state and local statutes, ordinances, administrative rules, regulations and other legal requirements in performance of this AGREEMENT.
- b. JUDGE shall not discriminate against any individual because of race, color, religion, sex, age, national origin, physical or mental disability, disabled veteran or veteran status, or any other protected status or activity in violation of local, state or federal law. JUDGE will administer the Court in compliance with City policy and applicable union collective bargaining agreements.
- c. JUDGE shall comply with all requirements associated with access to and confidentially of law enforcement data system records and categories of records protected by law which come before the Court. JUDGE shall appropriately direct Court staff and the police department with respect to such matters which come to her attention.
- d. JUDGE shall be a contract employee for all federal or state taxes applicable to any compensation or payments paid to JUDGE under this AGREEMENT. JUDGE is not eligible for any federal Social Security, unemployment insurance, or workers' compensation benefits from compensation or payments paid under this AGREEMENT.

SECTION 9. DISPUTE RESOLUTION

Any controversy or claim arising out of or relating to this AGREEMENT, including without limitation, the making, performance, or interpretation of this AGREEMENT or the AGREEMENT documents, shall be attempted to be settled by mediation in good faith prior to any litigation being filed. Any litigation arising under or as a result of this AGREEMENT shall be tried to the court without a jury. Each party agrees to be responsible for payment of its own professional fees, including attorneys' fees.

SECTION 10. TERM OF AGREEMENT

This AGREEMENT shall commence on July 1, 2021 This AGREEMENT shall expire on June 30, 2023, unless terminated as specified in this section. The Parties may, by mutual agreement, renew this AGREEMENT for two- year terms.

JUDGE serves at the pleasure of the City Council. Therefore, this AGREEMENT may be terminated by CITY at any time for its own convenience by written notice to JUDGE, effective immediately or at any time identified. JUDGE may terminate this AGREEMENT, for any reason upon (60) days' written notice of JUDGE'S intent to terminate. In the event this agreement is terminated, JUDGE shall receive compensation only for Services performed up to the last day of work performed as a JUDGE.

SECTION 12. INDEMNIFICATION AND INSURANCE

Except for the performance of her judicial functions for which the City shall indemnify, defend and hold JUDGE harmless, JUDGE acknowledges responsibility for any and all liability arising out of the performance of this AGREEMENT and shall hold City harmless from, indemnify and defend CITY for any and all liability, settlements, loss, costs, and expenses in connection with any action, suit, or claim resulting or allegedly resulting from JUDGE'S acts, omissions, activities or services in the course of performing this AGREEMENT.

JUDGE shall maintain occurrence form commercial general liability and automobile liability insurance for the protection of JUDGE, CITY, its Councilors, officers, agents and employees. Coverage shall include personal injury, bodily injury (including death) and broad form property damage, including loss of use of property, occurring in the course of or in any way related to JUDGE'S operations, in an amount not less than Two Million dollars (\$2,000.000.00) combined single limit per occurrence. Such insurance shall name CITY as an additional insured.

JUDGE shall maintain professional liability insurance as mandated by the Oregon State Bar.

JUDGE is self-employed and is responsible for any claims of workers' compensation that may arise from her self-employment in accordance with Oregon law.

JUDGE shall furnish the CITY certificates evidencing the date, amount, and type of insurance required by this AGREEMENT. All policies will provide for not less than thirty (30) days written notice to the CITY before they may be canceled.

The coverage provided by insurance required under this AGREEMENT shall be primary, and any other insurance carried by CITY shall be excess.

SECTION 13. GENERAL PROVISIONS

JUDGE shall maintain the confidentiality, both external and internal, of that confidential information which JUDGE receives in her capacity as JUDGE, to the extent appropriate. This Agreement shall not be interpreted or applied to affect the proper and public sessions of the Court or proper access to judicial proceedings and Court records not under seal.

JUDGE shall not use any data, pictures, or other representations of the CITY in JUDGE'S external advertising, marketing programs, or other promotional efforts except with prior specific written authorization from the CITY.

JUDGE shall furnish to City JUDGE'S employer identification number, as designated by the Internal Revenue Service or JUDGE'S Social Security number.

The AGREEMENT shall be governed by the laws of the State of Oregon. Venue shall be in Clackamas County, Oregon.

Neither CITY nor JUDGE shall assign or transfer their interest or obligation hereunder in this AGREEMENT without the written consent of the others. Except as otherwise provided above, JUDGE must seek and obtain CITY'S written consent before subcontracting any part of the work required of JUDGE under this AGREEMENT. Any assignment, transfer, or subcontract attempted in violation of this subparagraph shall be void.

All work, including but not limited to documents, drawings, papers, computer programs, and photographs, performed or produced by JUDGE under this AGREEMENT shall be the property of CITY. JUDGE shall retain all books, documents, papers, and records that are directly pertinent to this AGREEMENT for at least ten years after CITY makes final payment on this AGREEMENT and all other pending matters are closed.

This AGREEMENT shall not create any rights in, or inure to the benefit of, any party other than the CITY and JUDGE.

The AGREEMENT incorporates, without limitation, standard contract clauses that are required in every public contract in accordance with the Oregon Revised Statutes Chapter 279B and in particular the provisions of ORS 279B.220. 279B.225, 279B.230 and 279B.235. As such, to the extent applicable under State law, these paragraphs apply to this Agreement. This Agreement hereby incorporates by reference any other standard contract clauses required by federal, state, and local laws, ordinances, and regulations.

If any provision of this AGREEMENT is held to be invalid, it will not affect the validity of any other provision. This AGREEMENT will be constructed as if the invalid provision had never been included.

A waiver by a party of any breach by the other shall not be deemed to be a waiver of any subsequent breach.

This AGREEMENT contains the entire contract between the parties and supersedes all prior written or oral discussions or contracts regarding the same subject.

IN WITNESS WHEREOF, the City of Molalla has caused this AGREEMENT to be signed and executed in its behalf by its City Council and duly attested by its City Recorder, and AGENT OF THE CITY has signed and executed this AGREEMENT, both in duplicate, the day and year first above written.
