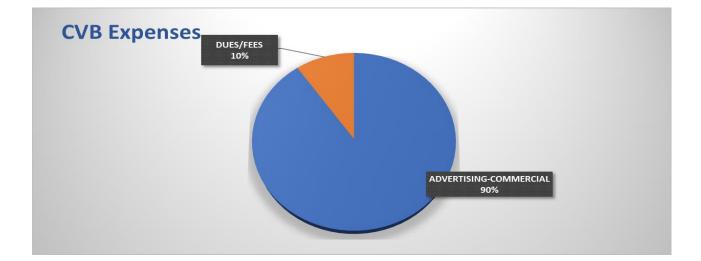


COLLECTED TO DATE (87% of budgeted collected to date)
