RESOLUTION NO. 25-001

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MORGAN'S POINT RESORT, TEXAS, Authorizing Members of the Governing Body to Volunteer for Organizations Protecting Health, Safety, or Welfare.

WHEREAS, Texas Local Government Code Section 21.003 provides that members of a municipality's governing body may serve as a volunteer for organizations that protect the health, safety, or welfare of the municipality, provided the governing body adopts a resolution allowing such service;

WHEREAS, the governing body of the City of Morgan's Point Resort is committed to ensuring the health, safety, and welfare of its residents;

WHEREAS, the governing body recognizes the value of volunteers engaging with and supporting organizations dedicated to protecting and promoting these essential community interests;

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF MORGAN'S POINT RESORT:

- 1. **Authorization to Volunteer:** Members of the governing body of the City of Morgan's Point Resort are hereby authorized to volunteer for organizations that protect the health, safety, or welfare of the municipality, in accordance with Texas Local Government Code Section 21.003.
- 2. **Compliance with Conflict of Interest Policies:** While serving in this volunteer capacity, members of the governing body shall comply with all applicable laws, regulations, and municipal policies regarding conflicts of interest, ethics, and transparency.
- 3. **Open Meeting:** This resolution was approved by the City Council at a regularly scheduled meeting duly posted in accordance with the Texas Open Meeting Act and at which a quorum was present and voting.
- 4. **Severability:** In the event that one or more of the provisions contained in this Resolution shall for any reason be held to be invalid, illegal or unenforceable in any respect, such invalidity, illegality or unenforceability of this Resolution shall be construed as if such invalid, illegal or unenforceable provision has never been contained herein, but shall not affect the remaining provisions of this Resolution, which shall remain in full force and effect.
- 5. **Effective Date:** This resolution shall take effect immediately upon its passage and approval.
