Bruce Leonhardt, 9 Wild Erp Dr, MPR

Spoke on the Bell County Health District press release about a mosquito-related risk and advised the public to eliminate standing water, to treat water that cannot be dumped, and to take personal protective measures when outdoors.

Denise Seibert, 114 Great West Loop, MPR

Requested council to set a brush pickup limit, raised concerns about high annual water usage and the need to advance the water strategy and volunteer tracking, and asked for a four-way stop at 2483 and Morgan's Point Road before school resumes.

Ted Teagarden, 30 Morgan's Point Blvd., MPR

Spoke on the potential reorganization of the EDC, asked for improved communication with volunteers, and urged realistic expectations for economic development in a small community. He has been on the EDC board for ten years.

Cheri Phillips, 1 E. Aztec Lane, MPR

Reported commercial operation in a residential neighborhood at 3 W. Aztec, involving increased noise, traffic, and metalworking, alleged the permit application may have contained misrepresentation or omission, stated prior emails and planning/zoning appeals received no acknowledgement, and asked police to take action.

Carly Pearson, City Manager, said departments will provide regular updates starting next month with utilities, she thanked the city secretary and staff for onboarding and customer service, announced City Hall weekday hours extended to 5 p.m., praised recent public safety improvements under the chiefs.

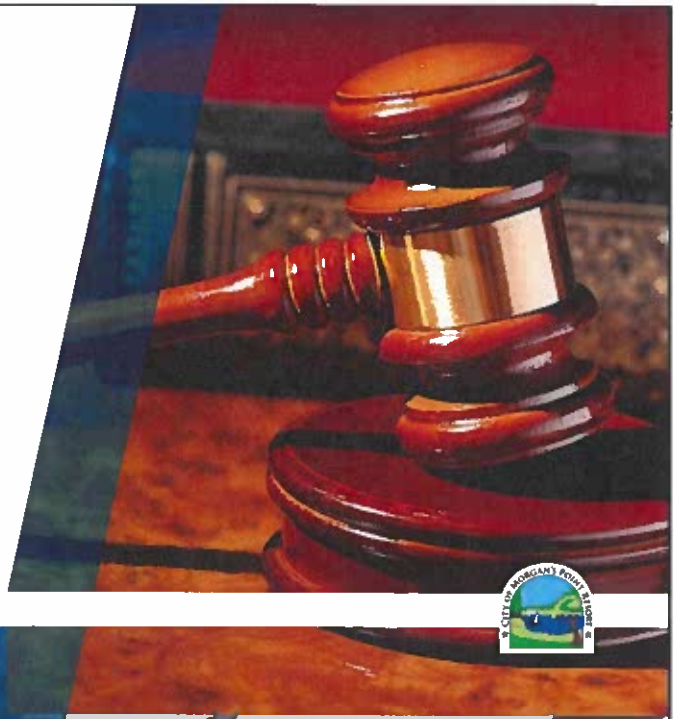

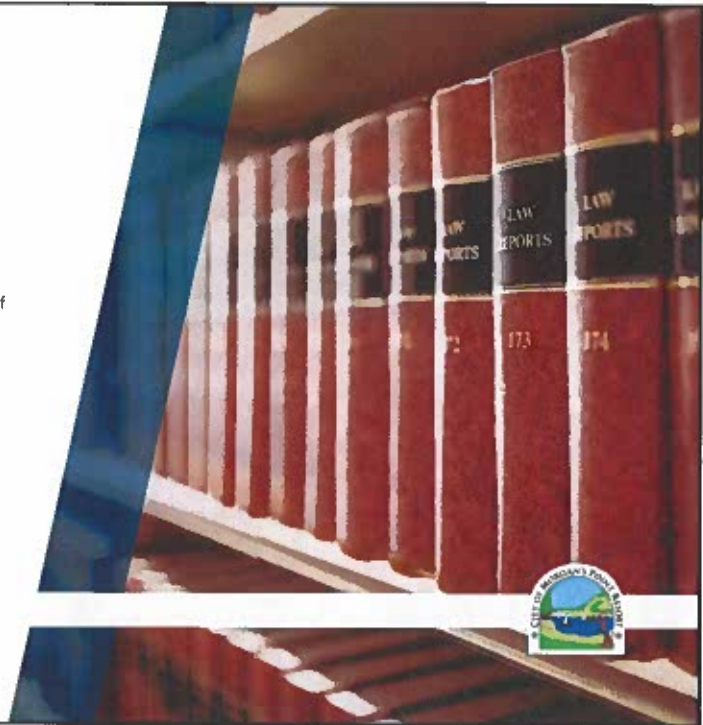
State Law

- STATUTE OF LIMITATIONS Article 12.02(b), Code of Criminal Procedure "A complaint or information for any Class C misdemeanor may be presented within 2 years from the date of the commission of the offense, and not afterward."
- The original citation may not satisfy as an Official Charging document in all cases.

2026 Court Citation Backlog Report

Requirements and Recommendation

- REQUIREMENTS: The determination of whether each citation has an Official Charging Document that satisfies state law to toll the Statute of Limitations would take an uncalculatable amount of staff hours and/or a 3rd party audit (at a cost).
- RESULT: This is likely to result in very few, if any, that have not expired due to the Statute of Limitations.
- RECOMMENDATIONS: Staff recommends clearing citations over 2 years old that do not likely meet the requirements to still be prosecuted.
- PROS: Clear Court Backlog that allows further citations and revenue to not be missed and lost.
- CONS: Loss of old \$146,340.15 in revenue since 2016

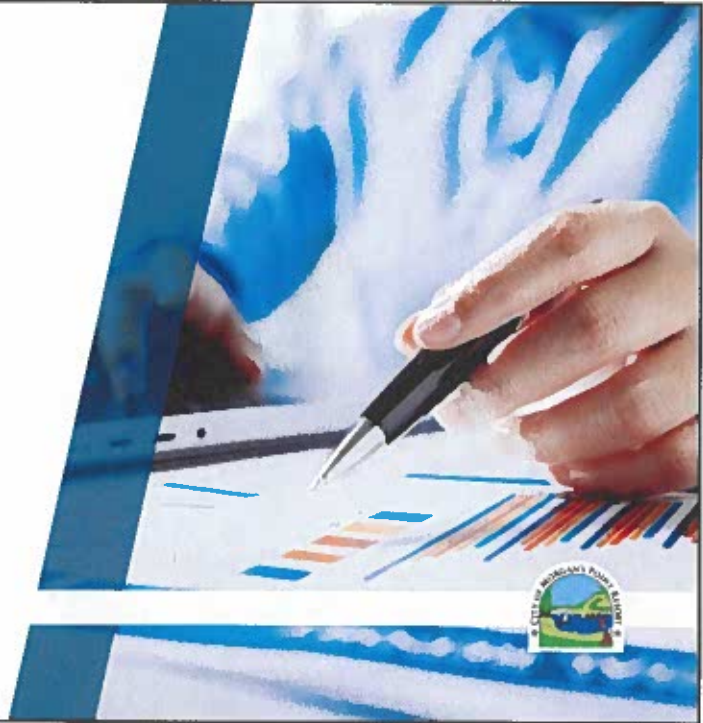

Options for Council Direction

- OPTION 1: Direct Staff to dismiss and remove from backlog all violations on which the Statute of Limitations has expired by default (2+ years old) and may not likely be prosecuted or recovered.
- OPTION 2: Direct Staff to take necessary action to evaluate cost and time to perform an audit to determine if the 2+year old violations were tolled and may still be prosecuted.

WHEREAS, the City previously entered into an agreement with Flock Safety, Inc. for the installation, operation, and maintenance of automated license plate reader cameras and related technology within the City; and

WHEREAS, the City Council has reviewed the current use, placement, operational needs, and associated costs of the Flock Safety camera system; and

WHEREAS, the City Council has determined that the continued operation of multiple camera installations is no longer necessary to meet the City's current public safety objectives; and

WHEREAS, the City Council finds that retaining a single Flock Safety camera installation will provide the City with a limited monitoring capability while reducing operational expenses and technology footprint; and

WHEREAS, the City Council desires to direct the deactivation and removal of all Flock Safety camera installations and related equipment within the City jurisdiction except for one camera installation to be designated by the City Manager in consultation with the Police Department.

Now, THEREFORE, BE IT RESOLVED AS FOLLOWS:

Section 1. The City Council hereby directs the deactivation, removal, and cessation of operation of all Flock Safety, Inc. cameras, equipment, and related technology installations currently located within the City jurisdiction, except for one installation to remain operational as designated by the City Manager.

Section 2. The City Manager, Chief of Police, and other appropriate City officials are authorized and directed to coordinate with Flock Safety, Inc. to accomplish the removal, deactivation, relocation, or discontinuance of service for all installations not retained pursuant to this Resolution.

Section 3. City staff shall take all actions necessary to account for any costs, credits, refunds, equipment returns, or service adjustments resulting from the reduction of installations authorized herein.

Section 4. The remaining camera installation shall continue to operate in accordance with all applicable laws, City policies, and contractual requirements.

Section 5. This Resolution shall become effective immediately upon its adoption.

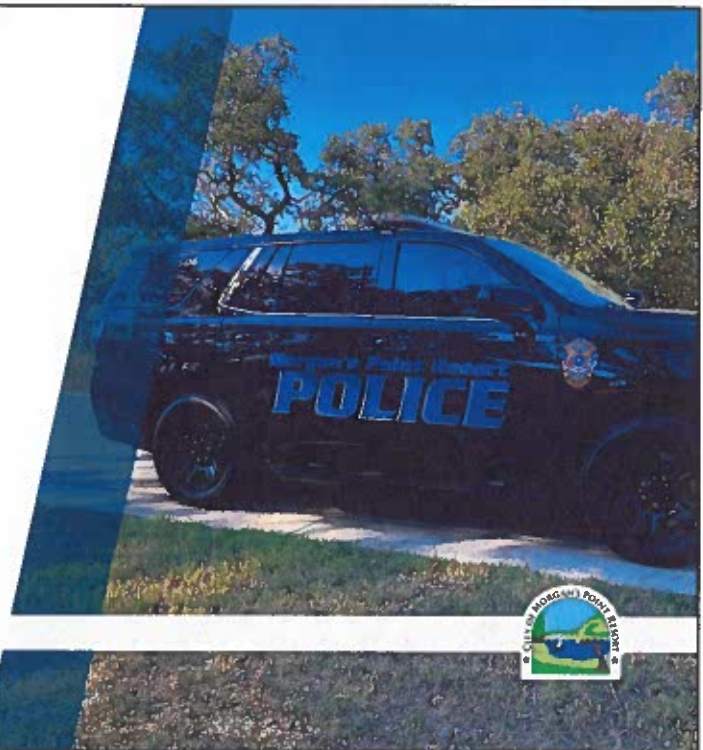

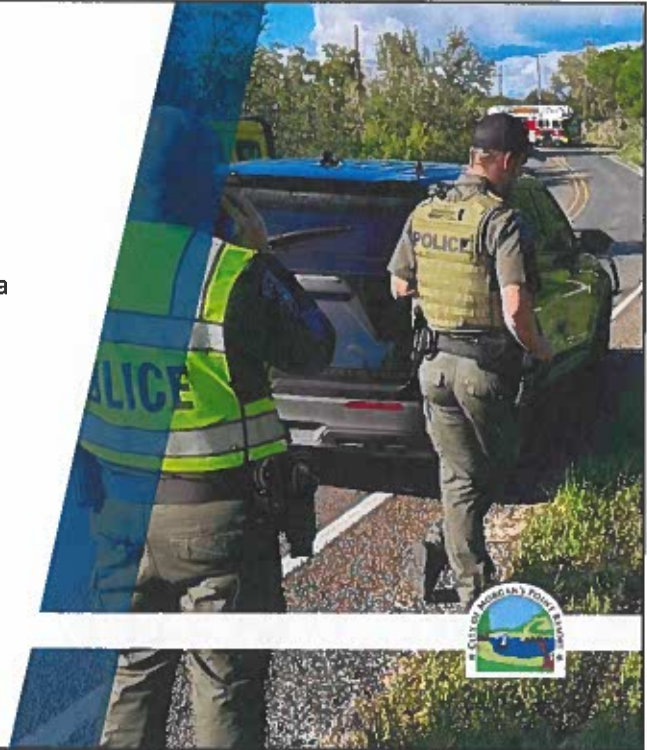

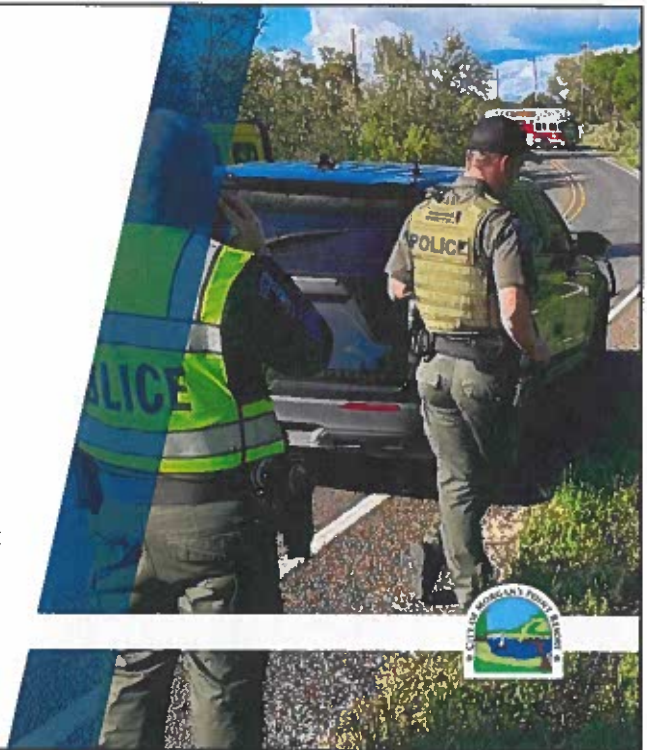
