Introduction

Upon your request, we have summarized some of the key items for consideration in this year's budget.

Budget Format

The 2027 Budget includes the Council-approved priorities for each department. These will continue to be reviewed and updated as needed in the 2027 budget.

Key items in this year's budget:

- LGA will increase by approximately \$431 in 2027, for a total of \$254,842
- The total 2027 tax levy is proposed to increase \$177,368 or 8.88% from 2026.
 - The general levy increased by \$43,038, or 2.72%.

Factors relating to this increase are explained in the General Fund Budget Summary section of this memo.
 - The debt levy increased by \$134,330 or 32.36%.
 - This is due to the scheduled bond obligations and adding the 2026A and 2026B bond payments.
- All employees are projected to receive a COLA increase of 4%.
- We have estimated a 3% increase in workers' compensation and a 4% increase in property insurance. The League of MN Cities suggested a 2% to 5% increase in workers' compensation and a 3% to 5% increase in general liability insurance.

Tax Levy Summary

Overall, the property tax levy includes levies for general operations, and debt service. The 2026 actual and 2027 proposed property tax levies are listed below:

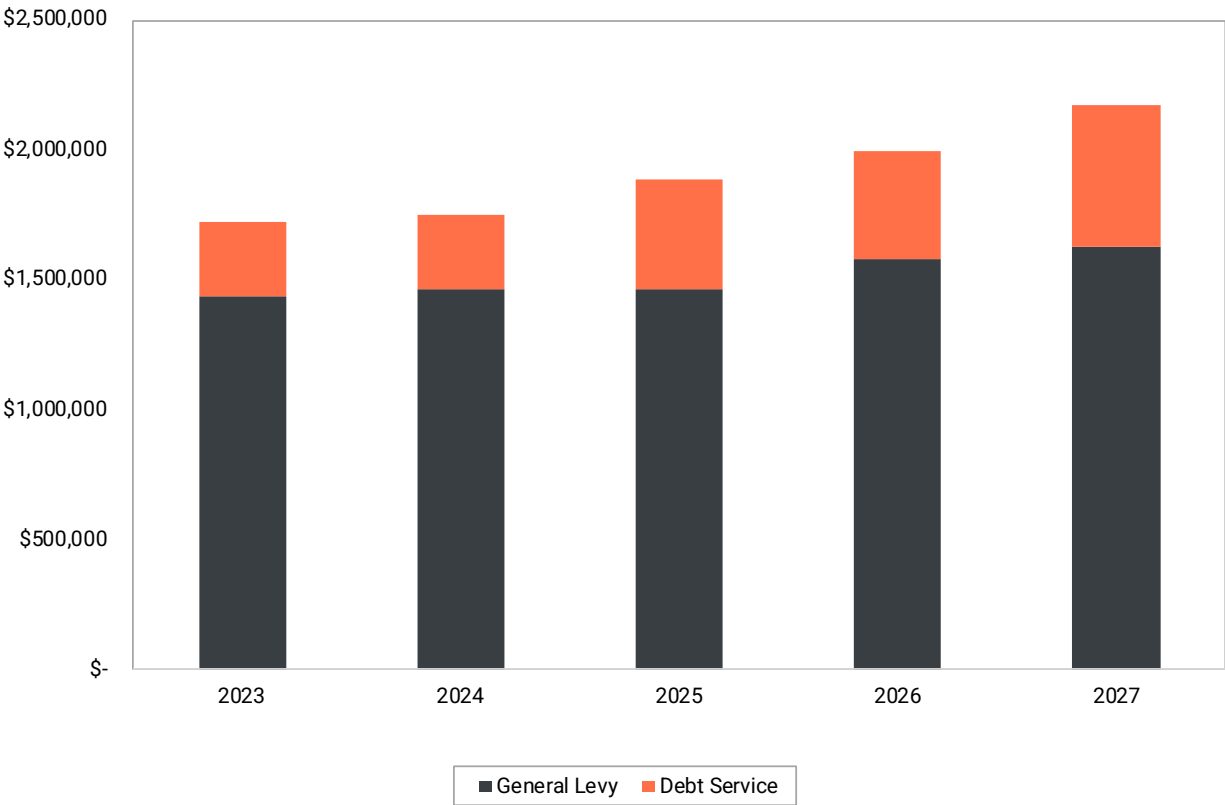

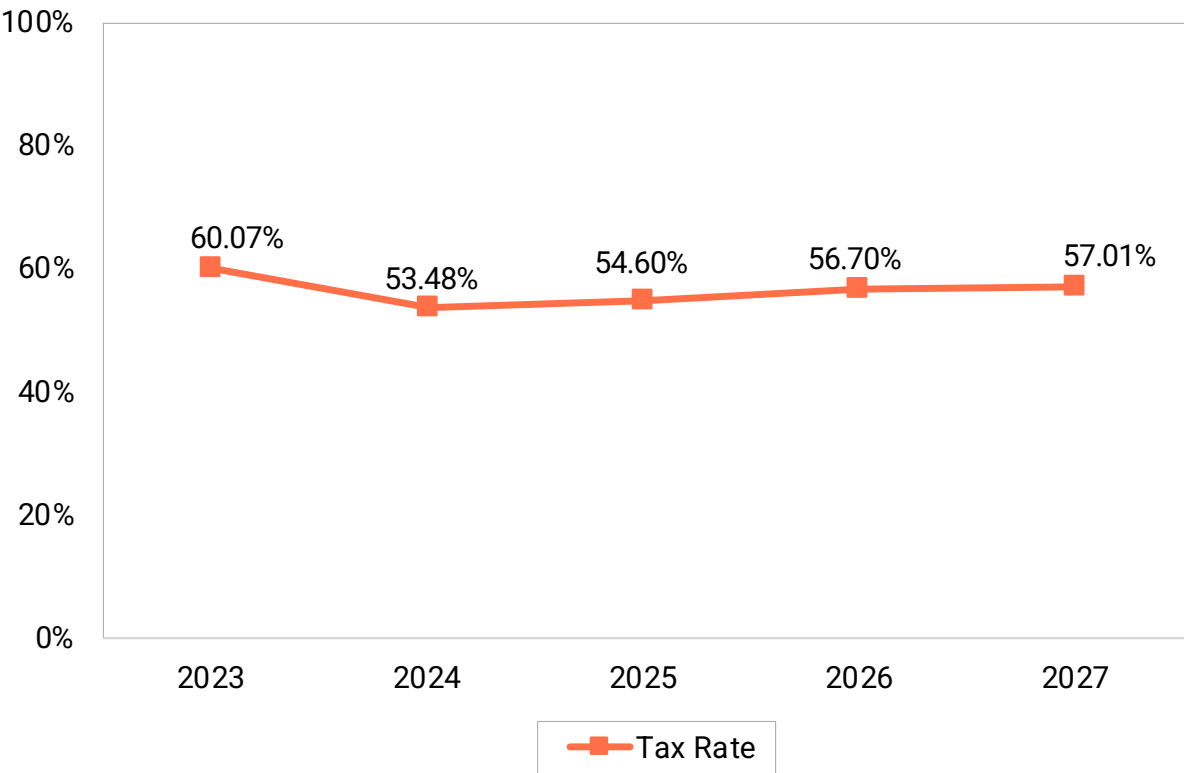

Revenue Key Changes:

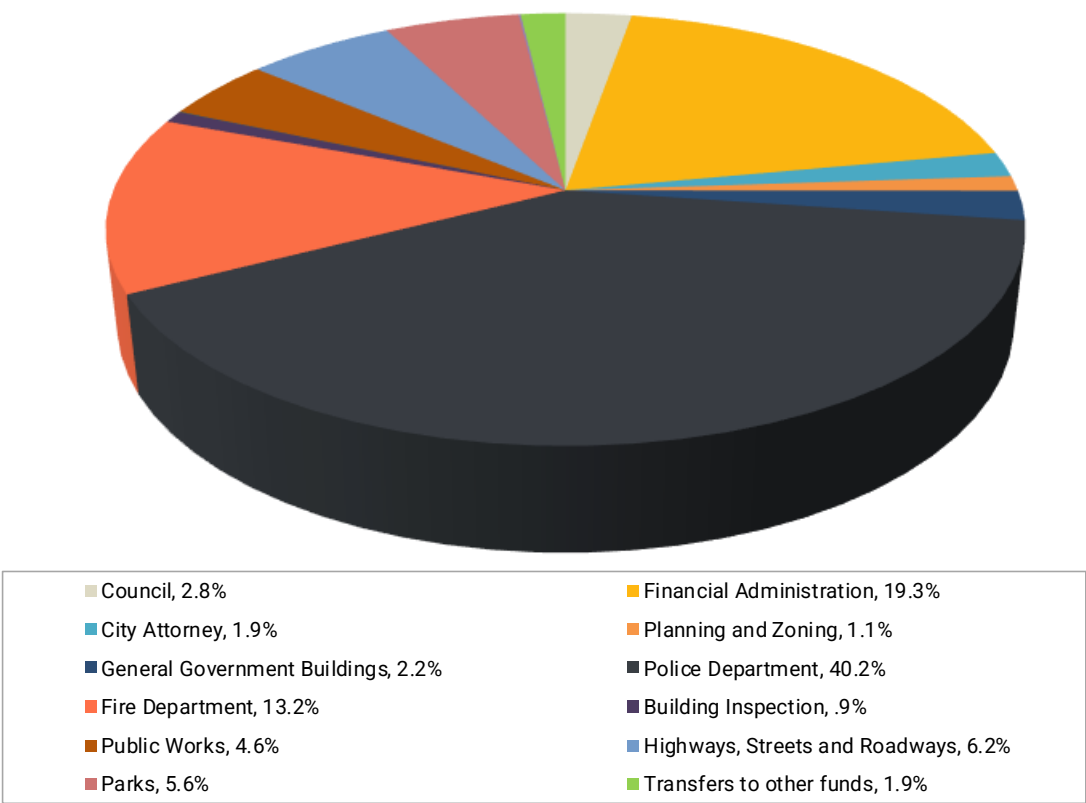
- Property taxes -increase to offset increases in expenditures and changes in other revenue sources.
- Licenses and permits- increase in business license revenue of \$18,550 due to cannabis cultivation and retail operations, and an increase in building permit revenue of \$10,000 to better align with budget expectations. This is an offset to a decrease in rental permits that is only budgeted for every other year.

Expenditure Key Changes:

- Financial Administration –
 - Increase in wages and benefits due to COLA increase.
 - Increase of \$30,281 in auditing and accounting services due to increased audit costs and fees from outsourced finance director services.
- Police Department –
 - Increase of \$55,843 due to the police administration contract.
- Fire Department –
 - Increase of \$30,500 due to the fire administration contract.
- Public Works
 - Increase of \$9,000 in building repairs and maintenance to paint the building.
 - New line item added for lawn care and mowing of \$6,000.
 - Increase of \$1,000 for heavy machinery.
- Highways, Streets and Roadways
 - New snow removal line item added in the amount of \$50,000. This is offset by a \$13,000 decrease in electric utilities and the removal of the street maintenance materials line item budgeted at \$5,000.
