## Meadows HOA Request for City Assumption of Streets, Utilities, and Outlot B

The Meadows Homeowners Association (HOA) Board has approached the City with a request to consider assuming ownership and maintenance responsibilities for the private streets, utilities, and Outlot B within their subdivision.

In preliminary discussions, I advised the HOA that the City has historically not taken on such responsibilities in similar developments. However, should the City Council wish to explore this request further, several key considerations would need to be addressed:

- **Right-of-Way (ROW) Requirements**: The City would likely require a 60-foot ROW, which would extend to or near the front entrances of existing homes, potentially impacting property layouts and landscaping.
- **Entrance Island Removal**: The landscaped islands located at the entrances on Oak Street would need to be removed to meet City standards for street design and maintenance.
- **Transfer of Reserve Funds**: The HOA's existing reserve funds for infrastructure maintenance would need to be transferred to the City to help offset future maintenance obligations.

• **Future Reconstruction Costs**: The first full reconstruction of the streets would be assessed 100% to the benefiting properties. Any subsequent reconstructions would follow the City's Special Assessment Policy in place at that time.

The HOA Board is seeking to understand whether the City Council would be open to further discussion on this matter. If there is interest, staff recommends inviting the HOA to formally present their request, followed by a comprehensive review by City staff and legal counsel.

### **Purpose of Workshop**

This session is intended to:

- Answer any remaining questions from council members.
- Review and discuss the proposed 2026 budget for the merged department.
- Discuss the leasing terms and responsibilities for the current Maple Plain fire station.

### **Merger Progress Overview**

The merger between the West Suburban Fire District (WSFD) and Maple Plain Fire Department (MPFD) is on track for an operational start date of January 1, 2026. The process has been collaborative, with strong support from both departments and transition teams meeting regularly since Spring 2025.

### **Key Developments**

- **Transition Team Work**: Focused on operational alignment—equipment compatibility, records integration, branding, and communications.
- Fire Commission Meeting (July 8, 2025):
  - Confirmed December 31, 2025 as the operational merger deadline.
  - Reviewed a draft 2026 budget and outlined legal steps for council approvals.
  - Identified one-time merger costs (~\$37,000–\$39,000), to be covered by public safety aid funds.

### **Budget Overview**

2025 Combined Budget: \$464,000
 2026 Draft Budget: \$552,000

- Increase driven by pension catch-up contributions, expanded staffing (full-time chief, assistant chief, admin support), and firefighter wage increases.
- A 5% annual budget escalator is proposed for the first five years, after which a new funding formula will be adopted.

### **Fire Station Lease Discussion**

- Ownership: Maple Plain retains ownership of the current fire station.
- Lease Terms: Proposed lease to the merged department for \$1/year.
- Responsibilities:
  - **City**: Roof, mechanical systems, exterior maintenance.
  - **Department**: Interior modifications and operational use.
  - Additional items (e.g., hazardous waste systems, fuel systems) to be clarified in the lease agreement.

### **Next Steps**

- **Council Workshops**: Each city to hold individual sessions in August to address questions and authorize legal work.
- **Resolutions**: Council resolutions to pursue the merger expected by late August.
- **Joint Council Meeting**: Tentatively scheduled for **August 21, 2025 at 6:30 PM** in Independence for final public discussion and symbolic approval.
- **Fire Relief**: Should Fire relief continue their direction of working with their attorney on new bylaws, or should we have them hold off until this gets approved by both councils.
