SUBJECT: Discussion, consideration and possible action regarding the nomination and

selection of three (3) public-at-large members to the City of Midwest City Local Development Act Review Committee, Pursuant to Title 62, Section 855 of the

Oklahoma State Statutes.

Pursuant to the Local Development Act (O.S. 62 § 855), the Midwest City Council on January 25, 2022, appointed the Local Development Review Committee to make a recommendation concerning the proposed district, plan or project. The membership of the review committee shall consists of the following: a representative of the governing body who shall serve as chairperson; a representative of the planning commission having jurisdiction over the proposed district; a representative designated by each taxing jurisdiction within the proposed district whose ad valorem taxes might be impacted according to the plan.

In addition, the law requires the selection of three members representing the public at large and selected by the other committee members from a list of seven names submitted by the Chairperson of the review committee. At least one of the members representing the public at large shall be a representative of the Midwest City business community and, if a proposed plan objective is development of principally commercial retail, such representative shall be either a retailer or a representative of a retail organization.

Staff recommends nominating and approving three names from the list of seven nominees.

She attended Rose State College, served on the Oklahoma Board of Governor's Conference for Women in Business, the Board of Governor's Conference for Small Business as well as President of the Central Oklahoma Chapter of the National Association of Women in Business. She has been a member of Midwest City Library Board, Midwest City Tree Board and the Midwest City Memorial Hospital Board of Grantors, and has volunteered in many other civic capacities as well. Ms. Beaird, a Midwest City resident for over 40 years, was honored to be the 2005 Oklahoma Journal Record Woman of the Year.
