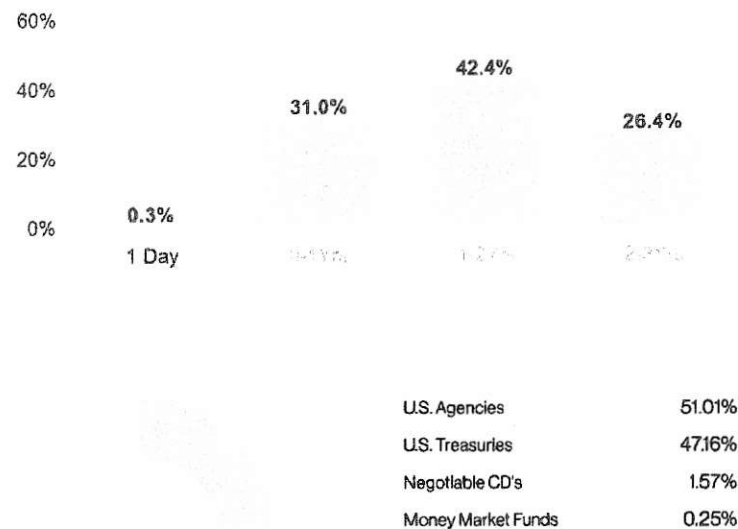

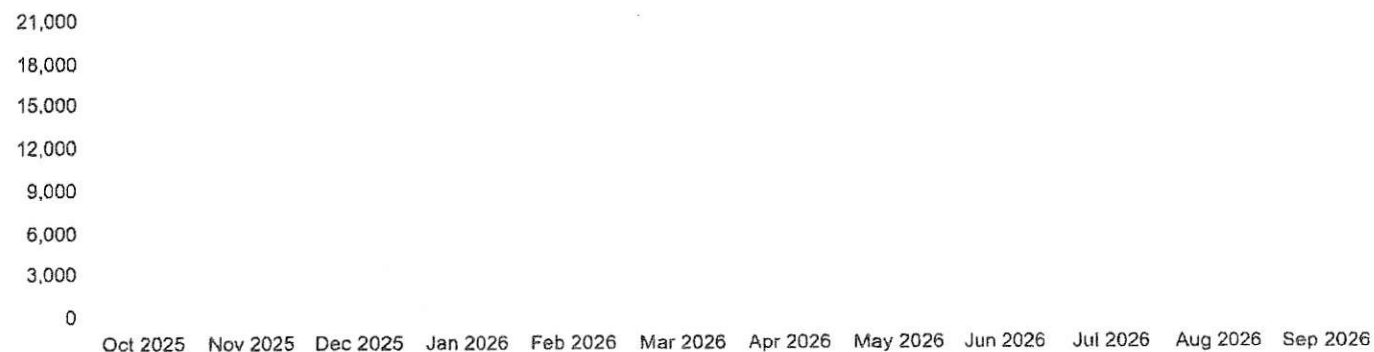

E. Broadway Resurfacing Project

Water Street Bridge Replacement Project

- **Construction was completed September 19 - working toward administrative closeout.**

Stormwater Projects

- **Continuing to work with Colliers to pursue grant funding for construction.**

Combined Sewer Overflow (CSO) Structure Modification Project

The competitive bidding process was completed, with bids opened on Wednesday, October 8 at 2pm. Peterson Construction Company submitted the low bid of \$78,700, while Unilliance, Inc. submitted \$113,850. Jones & Henry Engineers recommend awarding to Peterson. Due to a six-month material procurement lead time and the Village being one year behind its compliance schedule, Resolution 28 is recommended as an emergency.

Lead Service Line Replacement Project

We are working with Cindy Brookes of Great Lakes Community Action Partnership (GLCAP) to apply for the Water Supply Revolving Loan Account (WSRLA) through the Ohio EPA, which provides 53% principal forgiveness and 0% interest on the remaining balance. We are being advised that Resolution 29 should be passed as an emergency, and Resolution 30 must be effective by January 2, 2026, to secure funding.

Grant Updates

- **We have submitted our application for the Wood County Parks District grant. We are seeking benches, bike racks, and a fence/railing for the sled hill.**
- **School Traffic Signals (Rudolph & E. Cherry): The Health Department increased its contribution by \$1,000, for a total of \$9,595, with the Village share at \$3,898. Signs are in production; delivery of the signal units is pending.**

Technology and Cybersecurity Compliance

InTech has advised that additional cybersecurity policies must be approved by July 1, 2026 to comply with Amended Substitute House Bill 96, which establishes statewide cybersecurity standards for political subdivisions.

ORDINANCE NO. 2025 - 31

AN ORDINANCE ABOLISHING THE ELECTED OFFICE OF CLERK-TREASURER, CREATING THE APPOINTED OFFICE OF FISCAL OFFICER, ESTABLISHING THE PART-TIME POSITION OF CLERK OF COUNCIL, AMENDING CHAPTERS 133 AND 147 OF THE CODIFIED ORDINANCES OF THE VILLAGE OF NORTH BALTIMORE, OHIO, AND DECLARING AN EMERGENCY.

WHEREAS, pursuant to Ohio Revised Code §§ 733.26–733.262, a statutory village may abolish the elected office of clerk-treasurer and create the appointed office of fiscal officer; and

WHEREAS, the current Clerk-Treasurer of the Village of North Baltimore has submitted a resignation effective October 31, 2025, thereby creating a vacancy in the office; and

WHEREAS, Village Council desires to abolish the elected office of Clerk-Treasurer upon the effective date of that vacancy and to immediately establish the appointed office of Fiscal Officer to ensure compliance with state law and the efficient management of Village finances; and

WHEREAS, Village Council further desires to establish a part-time position of Clerk of Council to perform the recordkeeping and legislative duties historically assigned to the Clerk-Treasurer, and to amend Chapter 147 to rename the office of “Finance Officer” as “Fiscal Officer.”

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF NORTH BALTIMORE, WOOD COUNTY, OHIO:

SECTION 1. Effective November 1, 2025, following the vacancy created by the resignation of the Clerk-Treasurer on October 31, 2025, the elected office of Clerk-Treasurer is hereby abolished.

SECTION 2. Effective November 1, 2025, the office of Fiscal Officer is hereby created pursuant to Ohio Revised Code § 733.262. The Fiscal Officer shall be appointed by the Mayor with the approval of a majority of Council and shall perform all duties prescribed by the Ohio Revised Code and the ordinances of the Village of North Baltimore.

SECTION 3. Chapter 133 of the Codified Ordinances of the Village of North Baltimore is hereby repealed in its entirety and replaced with the following:

CHAPTER 133 – CLERK OF COUNCIL

133.01 – Clerk of Council Established.

- (a) The part-time office of Clerk of Council is hereby created.
- (b) The Clerk of Council shall be appointed by the Mayor with the approval of a majority of Council and shall serve at the pleasure of Council.
- (c) The Clerk of Council shall perform the duties of maintaining the legislative records of Council, recording and attesting ordinances and resolutions, preparing and maintaining agendas and minutes of Council and committee meetings, providing public notice of meetings, maintaining the official seal of the Village, and such other administrative duties as may be assigned by direction of Council.
- (d) The Clerk of Council shall not exercise any fiscal or treasury-related powers, which are vested exclusively in the Fiscal Officer.

SECTION 4. Chapter 147 of the Codified Ordinances is hereby amended by replacing the term “Finance Officer” with “Fiscal Officer” throughout, without substantive change to the responsibilities or policies set forth therein.

SECTION 5. Upon the effective date of this ordinance, the current Finance Officer shall be appointed as Fiscal Officer without interruption of service, subject to the approval of Council in accordance with Ohio Revised Code §733.262.

SECTION 6. On November 1, 2025, the outgoing Clerk-Treasurer shall ensure that all Village records, property, and other materials in the custody of the Clerk-Treasurer are transferred to the Village Administrator to ensure continuity of government operations.

SECTION 7. This ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the Village, to ensure uninterrupted legislative and fiscal operations upon the effective date of the current Clerk-Treasurer’s resignation and shall take effect immediately upon passage and approval by the Mayor.

SECOND AMENDMENT TO COMMUNICATIONS SITE LEASE AGREEMENT (WATER TANK)

This Second Amendment to Communications Site Lease Agreement (Water Tank) (the “Second Amendment”) is effective on the date of the last signature (the “Effective Date”) by the Village of North Baltimore, Ohio, an Ohio municipal corporation (“Landlord”), and Sprint Spectrum LLC, a Delaware limited liability company (“Tenant”).

Landlord and Tenant (or their predecessors-in-interest) entered into a Communications Site Lease Agreement (Water Tank) dated March 11, 2005, and a First Amendment to Communications Site Lease Agreement (Water Tank) dated March 24, 2007, (collectively, the “Agreement”) regarding the leased space (“Premises”) located at 2253 Grant Road, North Baltimore, OH 45872 (“Property”).

Landlord and Tenant now agree as follows:

1. Tenant is granted five (5) additional five (5) year terms, each Renewal Term-, beginning on April 20, 2035.
2. Rent will be Three Thousand Four Hundred and 00/100 Dollars (\$3,400.00) per month beginning on April 20, 2035.
3. Beginning on April 20, 2035, the current escalation set forth in the Agreement will end. Rent will then increase by fifteen percent (15%) on April 20, 2040, and at the beginning of each subsequent Renewal Term-.
4. Tenant may complete upgrades and additions of new equipment inside its Premises for no additional consideration or fee; however, any upgrades or additions that materially affect the structure, are visible from the exterior in a manner that substantially alters the aesthetics of the premises or materially interferes with Landlord’s operations shall require Landlord’s prior written approval, which approval shall not be unreasonably withheld, conditioned, or delayed. Landlord shall respond to such requests in writing within thirty (30) days of receipt of all required information.
5. As of the Effective Date of this Second Amendment, Landlord shall be responsible for maintaining all portions of the Property in good order and condition, including without limitation, plumbing, elevators, the roof and support structure, landscaping and common areas, as applicable.
6. Tenant may not assign the Agreement or sublease to another company without providing Landlord with written notice.
7. Tenant and Landlord will cooperate with each other's requests to approve permit applications and other documents related to the Premises.
8. Landlord may bill Tenant for any charges related to the Agreement besides Rent within twelve (12) months of incurring the cost or the charges are waived.
9. Landlord may assign the Agreement immediately upon receiving Tenant’s consent to the assignment.

ORDINANCE NO. 2025-20

AN ORDINANCE VACATING A PORTION OF THE UNIMPROVED RIGHT-OF-WAY KNOWN AS OAK STREET, SITUATED IN THE VILLAGE OF NORTH BALTIMORE, WOOD COUNTY, OHIO, AND CONVEYING SAID VACATED PORTION TO LESLIE LINDQUIST AND RICHARD A. & MARY E. CAPELLE

WHEREAS, a portion of Oak Street, located within the Village of North Baltimore, is unimproved and not needed for any public purpose; and

WHEREAS, the portion proposed for vacation lies between properties owned by Leslie Lindquist, Richard A. and Mary E. Capelle, and Country Club Acres Inc. and JCK2 Properties Ltd., and is identified as lying adjacent to Inlots 736 and 737; and

WHEREAS, the Village received a petition dated June 6, 2025, from property owner Leslie Lindquist requesting vacation of the subject portion of unimproved right-of-way, said petition being attached hereto as Exhibit A; and

WHEREAS, notice of the proposed vacation was provided in accordance with Ohio Revised Code § 723.07 by posting said notice in three public places in the Village of North Baltimore for six consecutive weeks preceding Council’s action on the petition; and

WHEREAS, Council is satisfied that there is good cause for such vacation and that vacating the unimproved right-of-way will not be detrimental to the general interests of the Village;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF NORTH BALTIMORE, WOOD COUNTY, OHIO:

SECTION 1. Council hereby finds that:

- 1. There is good cause to vacate the described portion of Oak Street;**
- 2. Said vacation is not detrimental to the general interests of the Village;**
- 3. Vacating the right-of-way serves the public interest and benefits the adjacent property owners.**

Given the unimproved condition of the right-of-way, its exclusive use by adjacent private owners, its de minimis public value, and the absence of any impact to public access or utilities, the Village Council has determined that Planning Commission review is unnecessary for this specific vacation.

SECTION 2. The following described portion of Oak Street, an unimproved public right-of-way situated within the Village of North Baltimore, Wood County, Ohio, is hereby vacated:

Situated in the Village of North Baltimore, Wood County, Ohio, this parcel consists of approximately 6,375 square feet and comprises a portion of the unimproved public right-of-way known as Oak Street. The land to be vacated is a rectangular area that begins at the intersection of Oak Street and North 3rd Street to the east, extending westward for a length of 127.5 feet. The width of the vacated area is 50 feet, extending north and south. The northern boundary of the vacated area is the southern boundary of Parcel No. F23-310-260313004000, owned by Leslie Lindquist, and the southern boundary is the northern boundary of Parcel No. F23-310-260313006000, owned by Richard A. and Mary E. Capelle. The western boundary of the vacated area is contiguous to Parcel No. F23-310-260313005000, owned by Country Club Acres Inc. and JCK2 Properties Ltd. The parcels affected by the vacation of this unimproved section of Oak Street, by way of extending the

boundaries of the parcels to include the vacated land, are Wood County Parcel F23-310-260313004000 and F23-310-260313006000. Parcel No. F23-310-260313005000 is not affected by this vacation.

SECTION 3. The vacated right-of-way shall vest in fee simple to the adjacent property owners in accordance with Ohio Revised Code § 723.041. Any existing public utility, drainage, or access easements located within the vacated portion of Oak Street shall remain in full force and effect. The Village of North Baltimore and any public utility providers shall retain all rights necessary to access, operate, maintain, repair, or replace any existing facilities within such easements.

SECTION 4. Property owner Leslie Lindquist is directed to record a certified copy of this Ordinance, along with Exhibit A (petition), in the official records of the Wood County Recorder’s Office and provide notice to the Wood County Auditor and applicable public utilities.

SECTION 5. It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of Council, and that all deliberations of the Council and any of its committees or decision-making bodies were conducted in compliance with applicable Ohio law.

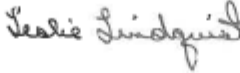
