RESOLUTION NO. 38 – 2025

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A CONTRACT WITH AXON ENTERPRISE, INC. FOR THE PURCHASE OF POLICE BODY-WORN CAMERAS, TASERS, IN-CAR VIDEO SYSTEMS, AND RELATED EQUIPMENT AND SERVICES FOLLOWING A COMPETITIVE BID PROCESS, AND DECLARING AN EMERGENCY

WHEREAS, the Police Department needs to replace body-worn cameras, add in-car video systems, and update conducted-energy devices and related software and training; and

WHEREAS, the Village issued a formal bid package and published bid notices on November 17 and November 24, 2025; and

WHEREAS, one bid was received and opened in accordance with the notice, submitted by Axon Enterprise, Inc.; and

WHEREAS, the bid met all specifications, Axon Enterprise, Inc. was determined to be the lowest and best bidder, and the bid is attached hereto as Exhibit A; and

WHEREAS, Council wishes to proceed with contracting to ensure timely implementation of the equipment and systems.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of North Baltimore, Wood County, Ohio:

Section 1. Authorization. The Mayor is authorized and directed to execute, on behalf of the Village, a contract with Axon Enterprise, Inc., consistent with its submitted bid attached as Exhibit A and related documents necessary to effectuate the purchase.

Section 2. Funding. Payment obligations shall be charged to the appropriate Police Department capital or operating accounts as appropriated by Council. The contract shall reflect the pricing and term contained in Axon’s bid.

Section 3. Compliance. The Village Administrator, Fiscal Officer, and Chief of Police are authorized to take all further administrative actions required to implement this Resolution, including issuing purchase orders, coordinating delivery and installation, and maintaining all required records.

Section 4. Emergency Clause. This Resolution is declared an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the Village, to ensure uninterrupted law-enforcement operations and timely implementation of critical public safety technology. This Resolution shall take effect immediately upon passage by a three-fourths vote of the members elected to Council.

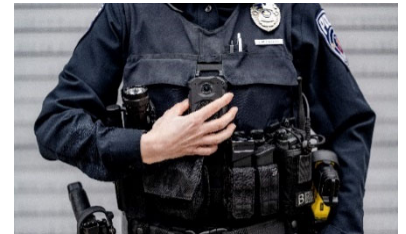


SOLUTION OVERVIEW

The following Solution Overview describes the major components being proposed in response to the Village of North Baltimore's *Police Equipment and Services* bid package. This section describes the equipment and software in Axon's proposal. All proposed devices are new, suitable for law-enforcement use, and supplied with the required accessories, licensing, and support. This overview is intended to provide a clear, direct explanation of Axon's solution and demonstrate full compliance with the Village's requested capabilities.

AXON BODY 4

When operating in unpredictable environments, users need a body-worn camera they can depend on—one that withstands daily wear, captures critical moments with clarity, and stays connected when it matters most. Axon Body 4 is built for this reality, helping camera operators document events, maintain situational awareness, and keep the device running reliably through the demands of a full shift.



Designed and tested to withstand impacts, weather, and daily field conditions, Axon Body 4 offers durability without adding bulk. The device's reengineered battery delivers approximately 13 hours of performance under normal operation, helping users stay ready throughout their shift without the need for frequent recharging or battery swaps. A range of secure mounting options allows users to place the camera in an ideal location, supporting clear evidence collection regardless of uniform type.

High-quality recording is a core function of Axon Body 4. Its custom-designed lens, advanced low-light optimization, and a four-microphone array work together to capture clear, detailed video and audio, even in challenging conditions. Recording features such as Pre-Event Buffer and Video Recall are designed to save critical video from before a recording starts and retrieve footage even if a recording was not manually activated.

Integrated LTE and Wi-Fi enable Axon Body 4 to automatically share live location data, deliver real-time alerts, and support optional livestreaming features. This connectivity allows public safety agencies to monitor situations as they unfold to enhance situational awareness and officer safety. These features are designed to operate passively in the background, helping minimize distraction and support focus during high-pressure situations.

After use, Axon Body 4 docks provide a hands-free solution for evidence upload, device charging, and system updates. Once placed in a dock, the camera automatically transfers recorded footage to secure storage, applies firmware updates and new settings, clears onboard memory, and recharges—helping maintain device readiness for the next shift.

By combining rugged construction, improved battery life, flexible mounting, reliable connectivity, and simplified evidence management, Axon Body 4 supports the capabilities users need—and the confidence agencies expect—to capture, connect, and protect critical moments.

FEATURES AND BENEFITS

Axon Body 4 is designed for video and audio recording, device durability, mounting flexibility, connectivity, and secure data management. The following list outlines the features and benefits.



- ▶ **RUGGED CONSTRUCTION** – Tested to IP68 and MIL-STD-810H standards to support operation in wet, dusty, and high-impact environments. Tested to operate after drops from six feet (in ambient temperatures) and four feet (in cold temperatures).
- ▶ **LONG-LASTING BATTERY** – Integrated 4300 mAh lithium-ion battery provides approximately 13 hours of runtime per charge under normal operating conditions.
- ▶ **VERSATILE MOUNTING SYSTEM** – Works with clip, MOLLE, magnetic, and helmet mounts to support reliable placement across a wide range of uniforms and gear setups.
- ▶ **ADVANCED VIDEO CAPTURE** – Supports both configurable resolutions (480p, 720p, 1080p, 1440p) and wide or narrow fields of view with a frame rate of 30 FPS for clear, smooth recordings.
- ▶ **LOW-LIGHT PERFORMANCE** – Utilizes clear frame technology with less than 0.1 lux sensitivity to capture details in near-dark conditions without significant motion blur.
- ▶ **HIGH-QUALITY AUDIO PERFORMANCE** – Employs a four-microphone array with Nokia OZO Audio processing to help reduce background noise, enhance speech clarity, and improve directional sound capture.
- ▶ **RECORDING FAIL-SAFES** – Configurable pre-event buffer (up to 120 seconds) and Video Recall feature (up to 18 hours) help preserve key moments even without manual activation.
- ▶ **BUILT-IN CONNECTIVITY** – Integrated LTE, Wi-Fi, and GPS capabilities enable passive location tracking, real-time alerts, livestreaming, and Watch Me notifications without disrupting recording operations.
- ▶ **AXON SIGNAL TECHNOLOGY INTEGRATION** – Communicates with Axon-connected devices to begin a recording when certain actions are detected, such as a user arming a TASER energy weapon.
- ▶ **WIRELESS EVIDENCE UPLOAD** – Allows users to wirelessly send select evidence files directly from the camera to Axon Evidence.
- ▶ **AUTOMATED DOCKING AND EVIDENCE UPLOAD** – Hands-free docking charges the camera, applies firmware updates, clears device storage, and securely uploads footage to Axon Evidence.
- ▶ **LARGE INTERNAL STORAGE** – Provides 128 GB of secure onboard memory.
- ▶ **SECURE DATA PROTECTION** – Full-disk AES-256-XTS encryption helps protect captured evidence at rest; communication between the camera and storage uses 256-bit TLS 1.2 encryption with Perfect Forward Secrecy.



AXON FLEET 3

When conducting patrol operations, users need a video system they can depend on—one that adapts to changing field conditions to support clear, reliable evidence capture. Axon Fleet 3 is designed for these tasks and helps law enforcement professionals record critical events both on the road and within the vehicle—confidently and with fewer distractions.

Axon Fleet 3 supports high-quality video and audio recording in a range of environments, from fast-moving roadside stops to low-light interactions in the back seat. Features such as pre-event buffer and Video Recall help preserve important footage even when a recording isn't manually started, while built-in microphones and advanced imaging features support detailed scene documentation.

The system includes a front-facing Dual-View Camera to document video of the scene in front of the vehicle. A separate infrared-equipped Interior Camera records rear-cabin activity in full color during the day and greyscale at night, helping capture subject behavior. These components connect directly to the Axon Fleet Hub, which manages in-vehicle storage, camera activation, and evidence upload. Together, these elements provide flexible video capture and full-cabin visibility with minimal disruption to the vehicle layout.



Axon Fleet 3 is purpose-built for in-vehicle use and system durability, with components that are tested against vibration, impact, and temperature extremes. Power over Ethernet (PoE) cabling provides a stable power source and high-speed data transmission between components, helping promote consistent performance. An integrated supercapacitor supports a safe shutdown in the event of sudden power loss, helping preserve captured evidence.

Connectivity features help users and supervisors maintain operational readiness without interrupting focus in the field. Axon Fleet 3 captures continuous location information from multiple satellites, which helps to maintain vehicle tracking even in difficult environments, such as tunnels, parking garages, or dense urban areas.

In-field workflows are streamlined with the Axon Fleet Dashboard software, which allows users to review, tag, and prioritize video upload directly from the vehicle's MDC. Encrypted transfer and chain-of-custody protections help maintain evidentiary integrity, while features in Axon Evidence support streamlined file management post-upload. Configuration and inventory tools in Axon Evidence help administrators tailor system behavior and monitor hardware across the fleet—supporting operational consistency without adding complexity.

By combining dual-camera coverage, integrated ALPR, and in-cabin review and upload workflows, Axon Fleet 3 helps law enforcement professionals capture and manage video evidence clearly and securely, while remaining focused on their patrol responsibilities.

FEATURES AND BENEFITS

- ▶ **DUAL-VIEW VIDEO RECORDING** – Front-facing camera captures wide-angle roadway footage and high-resolution license plates simultaneously with two integrated lenses
- ▶ **INTERIOR CAMERA WITH INFRARED ILLUMINATION** – Captures clear video of rear-cabin activity in full color during the day and greyscale at night to support documentation of subject behavior



- ▶ **AUTO-ADJUSTING VIDEO PERFORMANCE** – Purpose-built for dynamic environments, the camera uses fast shutter speeds and auto-exposure to adapt in real time and deliver clear video in changing conditions
- ▶ **AXON SIGNAL INTEGRATION** – Built-in Axon Signal technology can start a recording based on vehicle events—such as lightbar activation, door opening, or weapon unholstering—reducing reliance on manual triggers
- ▶ **VIDEO RECORDING FAILSAFES** – Configurable Pre-Event Buffer and Video Recall features help to record critical footage, even if a recording wasn't initiated
- ▶ **BUILT-IN CONNECTIVITY** – Supports livestreaming, ALPR updates, GPS tracking, and secure evidence upload via LTE or Wi-Fi
- ▶ **SECURE IN-VEHICLE STORAGE** – Provides 240GB of encrypted onboard storage with full-disk encryption to store and protect video until upload
- ▶ **DATA PROTECTION** – Full-disk AES encryption at rest and cryptographic file verification support chain-of-custody and help prevent unauthorized access.
- ▶ **IN-VEHICLE VIDEO REVIEW** – Axon Fleet Dashboard software allows users to review, tag, and prioritize evidence directly from the MDC without disrupting field operations
- ▶ **FLEET-WIDE DEVICE MONITORING** – Provides live system status, location information, and hardware alerts in Axon Evidence to support deployment visibility

TASER 10 ENERGY WEAPON

The TASER 10 energy weapon is the most current generation TASER device, providing officers with the most effective less-lethal option available. This device is vital when the de-escalation of potentially violent citizens is necessary, and prioritized over more dangerous and injurious force. This field-proven device employs life-saving technology—effecting Neuromuscular Incapacitation—to safely immobilize a suspect from as close as 0 feet, and up to 45 feet away, leading to far safer outcomes, far more often. Additionally, when the avoidance of force is a clear preference, the TASER 10's enhanced warning display allows officers to warn a suspect of potential deployment, which can then lead to compliance without risk of injury to an officer or citizen.



TASER 10 IN THE FIELD

Officers placed in dangerous situations will find that the TASER 10 is Axon's most intuitive energy weapon to date, especially when the need for quick de-escalation and the avoidance of use of force is paramount. An officer can easily lead with the use of a TASER 10 over other tools and actions, and deter violence or force by activating the warning alert—which consists of a bright pulsing light and loud alert sound that comes from the energy weapon—without ever launching a single probe. Should a TASER 10 deployment become necessary; simple, easy, and accurate probe placement provides officers with up to nine opportunities to stop a threat and reduce injurious or even lethal conflict.

The TASER 10 is robustly built to operate in a variety of harsh conditions and can withstand the rigorous demands of modern-day policing. With a High-Impact Polymer housing, the device is proven to endure a five-foot drop, as well as operate in a wide range of temperatures. Additionally, the TASER 10 has a five-year useful life and holds an IP67 Ingress Protection Rating.



ADDITIONAL FEATURES AND BENEFITS

- ▶ **0-FOOT MINIMUM RANGE** that offers the opportunity to stop a hostile encounter within the personal space of both the officer and suspect
- ▶ **45-FOOT MAXIMUM RANGE** that creates more time and space to de-escalate and resolve conflicts
- ▶ **10-SINGLE PROBE CARTRIDGES** that provide users with nine opportunities to achieve an effective connection leading to NMI
- ▶ **INDIVIDUALLY TARGETED PROBES** that allow users to place each probe with precision and accuracy, and create their own spread from close or long range

TASER 10 AT THE STATION

Once back at the station, officers can charge the TASER 10, upload device logs to Axon Evidence, and receive firmware updates by simply inserting the energy weapon into a docking station. Our docking stations include 1-bay and 6-bay options and can be installed or set up to fit a variety of layouts and designated spaces.

Once device logs are uploaded from the TASER 10 to Axon Evidence, they can be easily reviewed by the Village's Axon Evidence administrators to monitor the usage, as well as the system status of your entire arsenal of TASER 10 energy weapons.

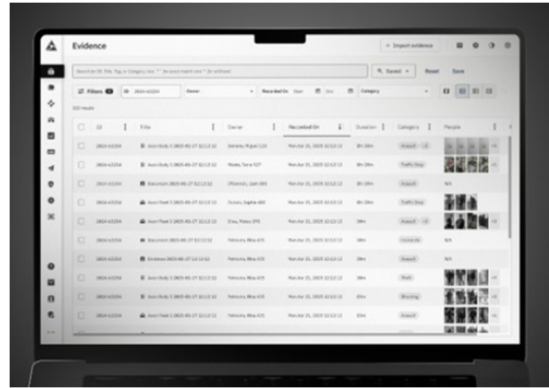
Additionally, your administrators can use Axon Evidence to assign and reassign energy weapons, verify firmware versions, access audit trails, and check a variety of energy weapon statuses.



AXON EVIDENCE

Managing digital evidence across multiple sources is an operational challenge for modern public safety agencies. From capturing footage in the field to preparing case files, agencies manage large volumes of content under tight timelines and regulatory oversight. Axon Evidence is a secure, cloud-based digital evidence management system that helps agencies streamline each step of the evidence lifecycle—from intake and review to sharing and retention.

Evidence can be ingested from a variety of sources, including Axon body-worn and in-car cameras, third-party systems such as CCTV, and public submissions. Uploads from Axon devices make footage available without extensive manual processes. Evidence from third-party sources, such as CCTV footage or residential doorbell cameras, can be uploaded into the system with automatic file conversion if needed for playback. Digital public evidence submission portals or single-use submission links enable secure community contributions. Additionally, bulk evidence uploads and API integrations can simplify large-scale evidence transfers or recurring data transfers into Axon Evidence.



Tools in Axon Evidence help users quickly locate, organize, and manage digital evidence. Users can quickly retrieve relevant files by filtering search results based on multiple fields, including custom options for flexibility. Integrated playback and annotation allow users to mark key moments and add notes. Investigators can group related evidence within case structures, apply bulk updates to metadata, and use evidence-matching features to confirm that evidence related to an incident is included in a case.

Sharing features support secure collaboration with internal users and external partners. Within an agency, users can grant tailored access to files so that recipients have only the permissions necessary to view, edit, or share evidence based on their role. External stakeholders, including prosecutors or defense attorneys, can securely receive shared files through a controlled, traceable process.

Axon Evidence helps protect evidence integrity with audit trails, retention policies, and access controls. Actions such as viewing, editing, or sharing are logged in an audit trail to provide a clear and unalterable record of evidence handling without adding manual work. Customizable retention policies help agencies comply with legal and regulatory requirements by automating evidence storage and deletion. Administrators configure role-based access controls to define user permissions across the system so that personnel have the appropriate level of access to evidence, case files, and system settings while protecting sensitive data from unauthorized access.

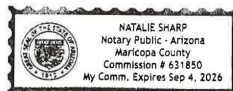
