Grace Hecht announced Tri State Community Health Care Center would be making a presentation at the Council meeting in January and reported on their continued donations of fresh produce to the residents of Needles and the Tri State area.

A representative from Wellness Meditation Center announced an event at the Needles Chamber of Commerce on December 13, 2025.

1. A Collaborative Presentation on area services and expansion efforts was given by: Marci Coffey and Susie White of Inland Empire Health Plan (IEHP); Dr. Sharon Wang of San Bernardino County Department of Public Health; Andrew Goldfrach of Arrowhead Regional Medical Center (ARMC); and Allison Ellsner of San Bernardino County Medical Society.

Council asked questions of staff regarding collaboration efforts with medical service providers in Arizona, and transportation concerns for patients having to travel distances in California for medical services.

Peggy Bostwick talked about MediCal patients having to drive 3-4 hours for appointments in California due to insurance coverage issues and asked staff and health care representatives in attendance about the possibility of creating a collaboration with medical providers across the river in Arizona.

Don McCone thanked the San Bernardino County, Mobile Medical Unit, and City Council for bringing attention to this matter.

2. Bing Lum, Executive Vice President of Colorado River Medical Center (CRMC) gave an update on the hospital services, coverage areas with the mobile medical unit expanding to Big River and Essex, and ongoing community health initiatives.

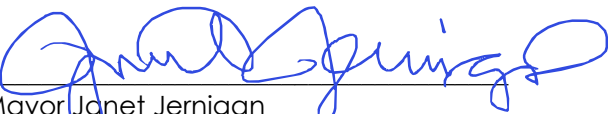
Council Member Longbrake

- Wished everyone a Merry Christmas and Happy New Year

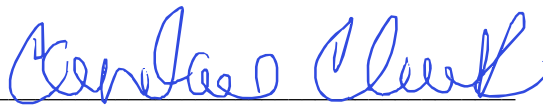
Mayor Jernigan
