Tim Terrall voiced his opinion that this location is not appropriate for proposed business and it will destroy the neighborhood. Barbara Beard informed council that the Planning Commission to deny this request, it should stay a residential neighborhood. Shawn Gudmundson this would change the whole demeanor of the area.

Applicant Rebuttal - Mark, the applicant addressed council that he is here to develop the city and this location has been vacant for over 30 years and the cannabis business will generate large revenues for the city.
