3) NPUA / COUNCIL: City Manager Daniels reported on electric meter misreads and billing errors for months of July, August and September 2022 and provided staff direction as follows: No Shutoffs or late fees until issues are resolved. All accounts will be audited. Possible \$25 contribution for disruption (credit to bill). Possible use of Covid grant funds. Councilmember Longacre stated that the bill should show a separation between the misread and the actual bill and asked how staff missed the errors. Councilmember Evans stated that the error is not the rate payers' fault and asked about possible use of covid funds. Councilember Belt commented the city wants to treat the ratepayers fairly and come to a quick solution. Councilmember Merritt inquired if the city can credit the bill more than \$25. Judy East, Judy Billings and Nichol who lives at 1325 Lilly Hill all explained to council the large increase in their electric bill. Barbara Beard would like to know how this happened. MaryAnn, Needles Museum, received a credit on their bill not knowing it was a mistake. Terry Campbell, Utility Board, reminded staff to ensure the hydro fees are calculated correctly. Pastor Jones inquired about the accuracy of the water meter reads. Considerable discussion ensued.
