9. Newberry Drinking Water Facility Plan Adoption - Resolution (DW010810)
Jamie Jones and Justin deMello, P.E., Project Manager and Principal, Woodard & Curran, presented the Drinking Water Facility Plan.

10. Impact Fee Ordinance - Second Reading Discussion

Mayor Marlowe reminded everyone that this was a discussion item, with no votes on Ordinance 2023-14 to be cast during this meeting. He asked that the Board give direction to staff.

Assistant Manager Lee presented. Discussion ensued. City Manager New and Director Thomas responded to questions from the Board.

Mayor Marlowe asked for Public Comment. Lee Smith, Billy Beltz, Christianna Norfleet, Bobby Prevatt, Ken Hicks, Tripp Norfleet, and Ken Metcalf, Stearns Weaver, representing Lexington Park II spoke.

Discussion ensued.

Staff was directed to edit Ordinance 2023-14 to implement the Study's recommended Residential Impact Fees at 70% for the first year with a 10% increase for each of the next 3 years, and to implement the Study's recommended Commercial Impact Fees at 0% for the first year with a 5% increase for each of the next 4 years.

11. FFY 2022 Community Development Block Grant (CDBG) Florida Department of Economic Opportunity for a Small Cities

Project Manager Lowery presented the Community Development Block Grant (CDBG) application.

Quasi-Judicial Public Hearing: First reading of Ordinance 2023-12/LDR 23-05, an application by eda consultants, Inc., Agent for Tibbetts Land Holdings, LLC, Owners, to amend the Official Zoning Atlas of the City of Newberry by changing the zoning from COMMERCIAL GENERAL (CG) to COMMERCIAL, INTENSIVE (CI) on approximately 8.28 Acres, identified by Alachua County Parcel number 01924-010-004.

Mayor Marlowe read the quasi-judicial procedures and presentation order.

Attorney Walker read Ordinance 2023-12 by title only.

Jeannene Mironack swore in Director Thomas; Billy Beltz, co-owner, Tibbetts Land Holdings, LLC; and Clay Sweger, AICP, LEED AP, Principal & Director of Planning, eda consultants, inc.

Mayor Marlowe asked for ex parte. There was none.

No third-party intervenor.

Director Thomas stated that the applicant and their agent were present and sworn-in to answer questions. He then presented the staff report and recommendation.
