PUBLIC HEARINGS AND ORDINANCES

2. Rezoning from Commercial General (CG) to Commercial, Intensive (CI) on 8.28 Acres (parcel 01924-010-004)

Quasi-Judicial Public Hearing: Ordinance 2023-12/LDR 23-05, an application by eda consultants, inc., Agent for Tibbetts Land Holdings, LLC, Owners, to amend the Official Zoning Atlas of the City of Newberry by changing the zoning from COMMERCIAL GENERAL (CG) to COMMERCIAL, INTENSIVE (CI) on approximately 8.28 Acres, identified by Alachua County Parcel numbers 01924-010-004.

Chair Erched reviewed the Quasi-Judicial Hearing process and procedures. He then read through the presentation order.

Jeannene Mironack swore in Director of Planning & Economic Development Bryan Thomas, AICP; Clay Sweger, AICP, LEED AP, eda consultants, inc., and Todd Rousseau, Tibbetts Land Holdings, LLC.

Legislative Public Hearing: Ordinance 2023-09/CPA 23-05, an application by the City of Newberry to amend the Future Land Use Plan Map of the Comprehensive Plan by changing the future land use classification from Agriculture to Public on a site consisting of approximately 96 acres; identified by Alachua County Tax Parcel Numbers 02538-008-000 and 02538-009-001.

Attorney Scott Walker read Ordinance 2023-09 by title only.

Senior Planner Jean-Paul Perez presented a PowerPoint overview of the application.

Mayor Marlowe explained that this application was to rezone the Parcels to Public. It does not include any possible activities on these parcels. He stated he would open a public discussion about potential activities on these parcels at the end of the agenda.

Quasi-Judicial Public Hearing: Ordinance 2023-11/LDR 23-08, an application by the City of Newberry to amend the Official Zoning Atlas of the City of Newberry by changing the zoning designation from Agricultural (A) and Residential, Single-Family (RSF-2) to Public Facilities (PF) on property generally located on the east side of County Road 337, between Southwest 15 Avenue and Southwest 30 Avenue, consisting of ±217 acres; identified by Alachua County Parcel Numbers: 02536-000-000, 02538-001-000, 02538-004-000, 02538-005-000, 02538-007-000, 02538-009-001.

Quasi-Judicial Public Hearing: Ordinance 2023-13/LDR 23-09, an application by the City of Newberry to amend the Official Zoning Atlas of the City of Newberry by changing the zoning designation from Residential, Single-Family (RSF-2) to Public Facilities (PF) on property located at 120 Northwest 260 Street consisting of ±4.3 acres; identified by Alachua County Parcel

Number: 02035-000-000.

Attorney Scott Walker read Ordinance 2023-13 by title only.

MAYOR'S DISCUSSION

Mayor Marlowe explained that the approximately 96 acres site, identified by Alachua County Tax Parcel Numbers 02538-008-000 and 02538-009-001, has been discussed as a future environmental park which could include the expansion of the municipal wastewater treatment facility, an educational wetland exhibit and retention area, a County Rural Residential Waste Collection Center, a fire training facility, and a potential composting and small-farm meat processing facility. Discussion about the meat processing facility has focused on creation of a 15-acre facility where ranchers within 100 miles could process livestock with USDA inspection.

Mayor Marlowe stated that the Alachua County Board of County Commissioners is scheduled to vote on an Interlocal Agreement with Newberry on April 4, 2023. The Newberry City Commission will vote on the Interlocal Agreement at the end of March or early April 2023. An Interlocal Agreement will allow the next step of feasibility exploration for an environmental park.

Mayor Marlowe asked for public comment. Joy Glanzer, Tommy Aslin, Beth Fields, Cindy Bass, and Laura Atwick spoke.
