PUBLIC HEARINGS AND ORDINANCES

3. A request to paint a mural on the exterior of a building within the Newberry Historic District.

Quasi-Judicial – Resolution CA 2022-02 /Application CA 22-02, a request by Patricia Bulko, Agent, for Bulko Holdings, Inc, Owners, for a Certificate of Appropriateness to allow a mural to be painted on the exterior of a building (Joel's Coffee), located at 22 SW 258th Street (Tax Parcel #02272-000-000), located within the Newberry Historic District.

Chair Erched reviewed the Quasi-Judicial Hearing process and procedures. He then read through the presentation order.

Jeannene swore in Planner Alayna Jackson.

TOPICS FROM MEMBERS FOR DISCUSSION

Member Woodcock suggested that the HARB should be involved when Historic City-owned buildings are being remodeled, such as the Municipal Building and the Little Red School House. Mayor Marlowe stated that the City Charter allows a "meeting on wheels," that must be properly noticed. He suggested using the City bus to tour buildings such as the Old Jail, Electric Plant, Cold Storage, Municipal Building, Little Red School House, Freddie Warmack Park, and other buildings to understand the history of these structures.

The current Codes of Ordinances limits the HARB's review to exterior changes visible to the public on structures within the Historic District (Sec 11.11.2). Planner Jackson stated that some Municipal Codes include the interiors of Public Buildings.

Mayor Marlowe asked for a Presentation on Mural Decision Making.

Mayor Marlowe reminded everyone of the Watermelon Festival this weekend.
