**2.** Amending the Future Land Use Map classification from Agricultural to Material- Oriented Industrial Use on the south 50 acres of a property on Parcel Numbers 01875-000-000 and 01875-001-000.

Legislative Public Hearing: Ordinance 2024-07/CPA 23-13, an application by CHW Professional Consultants, agent, on behalf of E.D. Norfleet, Jr. and Phyllis Norfleet and Katrina Bill, owners, amend the Future Land Use Plan Map of the Comprehensive Plan by changing the future land use classification from City of Newberry Agricultural to Material- Oriented Industrial Use, on **the south 50 acres of** Alachua County Parcel Numbers. 01875-000-000 and 01875-001-000 consisting of approximately 50 acres more or less.

Quasi-Judicial Public Hearing: Ordinance 2024-08/LDR 23-18, a petition by CHW Professional Consultants, agent, on behalf of E. D. Norfleet, Jr. and Phyllis Norfleet and Katrina Bill, owner, to amend the Official Zoning Atlas of the City of Newberry by changing the zoning from Agriculture (A) to Industrial (I) on **the south 50 acres** of Alachua County Parcel Numbers, 01875-000-000 and 01875-001-000 consisting of approximately 50 acres more or less. (This application is contingent upon approval of Application CPA 23-13).
