**NEW BUSINESS** 

Quasi-Judicial Public Hearing: STUP 19-03, an application by End of the Road Events, Inc., dba End of the Road Entertainment, Agent for Pat Post, Owner, for a special permit for a temporary use to allow outdoor concerts, as provided for in "Section 14.10.1. Temporary use permits issued by city commission" of the City of Newberry Land Development Regulations, to be held during a single weekend event, occurring within the February through April 2020 time period, on property approximately 216 acres in size, located adjacent to the Gilchrist County/Alachua County Line on the southeast corner of West Newberry Road and Gilchrist County Road 2085 (SE 90th Avenue, Gilchrist County). The subject property is more specifically identified as Alachua County Tax Parcel Numbers 02515-004-000, 02515-004-001, and 02515-004-002.

Chair Baker read the Quasi-Judicial meeting procedure summary. Chair Baker asked the Board members if they had conducted ex parte communications regarding this application. Jessica Baker and Bill Conrad reported that they each had conversations with staff regarding the application.

Rich Maltby asked anyone thinking of speaking on this Agenda item to stand and be sworn in. He then swore in Bryan S. Thomas, AICP, Director of Planning for the City of Newberry; Wendy V. Kinser, AICP, Principal Planner for the City of Newberry; Jeannene Mironack, Staff Assistant for the City of Newberry, and Greg Hembree, representing End Of The Road Entertainment, Inc. He confirmed that there were no members of the Public intending to speak regarding the application.

Wendy V. Kinser, AICP, Principal Planner for the City of Newberry, presented the staff overview. Discussion ensued.

Greg Hembree spoke representing the applicant. He pointed out that Parcel 02515-004-000 is included in the application and staff report text, but that parcel is not shaded in the graphic. Discussion ensued.
