9. Appointment to fill vacancy on the Planning & Zoning Board and Historic Architectural Review Board.

Resolution 2021-28, a Resolution to appoint a new Planning and Zoning Board member to fill the seat of former member Bill Conrad. The appointee will serve the remainder of the current term which expires on April 30, 2022.

Mayor Marlowe presented this item. He surveyed the Commission to see if they wished to have more time to meet with the applicants due to the short amount of time they had to review the applications.

10. Amending the Comprehensive Plan by adding a new Property Rights Element, as required by Section 163.3177, Florida Statutes.

Legislative Public Hearing First Reading: Ordinance 2021-34/CPA 21-14, an application by the City of Newberry to amend the Comprehensive Plan to add a new Property Rights Element, as required by Section 163.3177, Florida Statutes.

Principal Planner Kinser-Maxwell presented a PowerPoint presentation that provided the staff overview, report, and recommendation. Recommendation is to pass Ordinance 2021-34 on first reading.

Discussion ensued.

Attorney Walker read Ordinance 2021-34 by title only on first reading.

Motion made by Commissioner Clark to pass Ordinance 2021-34 on first reading.

Seconded by Commissioner Marden.

Voting Yea: Commissioner Coleman, Commissioner Clark, Commissioner Farnsworth, Commissioner Marden, and Commissioner Mazon.

11. Legislative Hearing: First Reading of Ordinance 2021 – 36, Providing Consent for the Entire Corporate Limits of the City of Newberry Florida, to be Included in a Non-Ad Valorem Assessment for Municipal Service Benefit Unit (MSBU) Created by Alachua County for Solid Waste Management Costs.

Assistant Manager Lee presented this item. Lengthy discussion ensued regarding MSBU, Solid Waste, Tipping Fees, Rural Collection Center, and the Waste Pro Agreement.

Attorney Walker read Ordinance 2021-36 by title only on second reading.

Motion made by Commissioner Farnsworth to pass Ordinance 2021-36 on first reading.

Seconded by Commissioner Coleman.

AGENDA ITEMS

12. Review development fee refund applications and award appropriate refunds.

Legislative Public Hearing: Resolution 2020-29 of the Newberry City Commission provided criteria for refunds of commercial development fees to stimulate economic development. The City has received three qualified development fee refund applications that are complete and ready for evaluation and award.

Director Thomas presented this item with a PowerPoint presentation of three applications Stonehouse Grille, Alpha-Omega Training & Compliance (A. O. T. C.), and Town Center Storage for the Development Fee Refund Program. Discussion ensued.

Motion made by Commissioner Marden to award Stonehouse Grille the maximum allowable refund amount of \$30,000.

Seconded by Commissioner Clark.

Voting Yea: Commissioner Coleman, Commissioner Clark, Commissioner Farnsworth, Commissioner Marden, and Commissioner Mazon.

Motion made by Commissioner Farnsworth to award A. O. T. C. the maximum allowable refund amount of \$9,174

Motion made by Commissioner Coleman to award Town Center Storage the maximum allowable refund amount of \$10,270.

13. Reauthorize Resolution 2020-29, refunds of commercial development fees to stimulate economic development.

Legislative Public Hearing: A Resolution of the City Commission to stimulate economic development by providing criteria for refunds of commercial development fees. (Resolution 2021-18/LDR 21-20.) A Resolution of the City Commission of the City of Newberry, Florida, providing for a Schedule of Refunds of Fees and Charges for matters pertaining to commercial development in the City of Newberry as specified in Section 14-110. "Fees Enumerated," Section 98-192. "Charge Imposed," and Section 98-172. "Charge Imposed," of the City of Newberry Land Development Regulations, and Resolution 2018-08, to stimulate development; providing qualification criteria; providing severability; repealing all resolutions in conflict; and providing an effective date.

Director Thomas presented this item with a PowerPoint presentation. Discussion ensued. Attorney Walker read Resolution 2021-18 by title only.

Mr. Chris Torrence, citizen, commented.

Motion made by Commissioner Farnsworth made a motion to adopt Resolution 2021-18 with the addition that potential applicants have two years after the issuance of their Certificate of Occupancy to apply.

Seconded by Commissioner Coleman.

Voting Yea: Commissioner Coleman, Commissioner Clark, Commissioner Farnsworth, Commissioner Marden, and Commissioner Mazon.

MOTION PASSED 5-0

14. Quint Apparatus Replacement Alternatives

Assistant Manager Lee and Chief Buckner presented this item. Discussion ensued.

Mr. Jordan Fairfield made a positive comment towards having a quint.

Motion made by Commissioner Clark made a motion to pursue purchasing a new quint.

Seconded by Commissioner Coleman.
