Legislative Public Hearing: First reading of Ordinance 2023-23/CPA 23-06, an Ordinance amending the Future Land Use Plan Map of the City of Newberry Comprehensive Plan from Agriculture to Planned Development for a project known as NC Ranch Planned Development generally located west of US-27/State Road 45/Northwest 250 Street, between Northwest 53 Lane and Northwest 10 Avenue and consisting of approximately 1,293 acres; more particularly described in Exhibit A of Ordinance 2023-23.
