3. Water and Wastewater System Development Charge Ordinances Revision

Legislative Hearing: First Reading of Ordinance 2020 – 23. An Ordinance Pertaining To Utilities Within The City Of Newberry; Amending Division 2 And Division 3 Of Article VI, Chapter 98 Of The Code Of Ordinances Of The City Of Newberry Pertaining To Water System Development Charges And Sewer System Development Charges.

<u>Director Jones</u> presented this item. There is a scrivener's error that needs to be corrected on page 18 Sec. 98-194 (a) and on page 8 Sec. 98-173.

Motion made by Commissioner Coleman to

 Pass Ordinance 2020-23 amending Article VI, Chapter 98, Division 2-3 of the Code of Ordinance of the City of Newberry to reflect that water and wastewater system development charges will be calculated based on water meter size on first reading.

7. Appointment to Fill Vacancy on the Historic Architectural Review Board (HARB). (Resolution 2020 - 51)

<u>Mayor Marlowe</u> presented this item. The Commission voted using voter cards (see Exhibit A). <u>Mr. Joe Montalto Jr., P.E.</u> was selected to fill the vacancy.

Attorney Walker read Resolution 2020-51.

Motion made by Commissioner Coleman to adopt Resolution 2020-51, filling the HARB Vacancy.

8. Acquisition of Property Adjacent to City Cemetery.

<u>Commissioner Marden</u> disclosed that he discussed the process of purchasing property with Mr. Kevin Coleman

Motion made by Commissioner Marden to

- 1. Authorize the City Manager to execute a land purchase agreement to acquire 2.5-acre parcel of property from Ellen Coleman for \$35,000.
- 2. Authorize City Manager to execute all documents necessary to convey parcel from Ellen Coleman to the City of Newberry.
- 3. Direct staff on source of funds to acquire property; use contingency funds first then

pay remaining balance from the general fund.

9. Discussion of Tiny Home Neighborhoods.

<u>Director Thomas</u> presented this item. A lengthy discussion ensued regarding the following:

- 1. Definitions what is a tiny home, or tiny home neighborhood?
- 2. General Requirements what should be required in a tiny home neighborhood, such as, how much common area is required? What are the lot requirements? Parking? Landscaping?
- 3. Design Elements what type of architectural styles are allowed? Should porches or patios be required? What about sidewalks or fencing?
- 4. Allowable Zoning Districts where should tiny home neighborhoods be allowed? Should they be allowed, "by right," or by Special Exception?

10. Support Letter for Dudley Farm Nomination as a National Historic Landmark.

Mayor Marlowe presented this item.

Motion made by Commissioner Clark to authorize the Mayor to sign a Support Letter for Dudley Farm nomination as a National Historic Landmark.
