(This application is contingent upon approval of Application CPA 21-33.)

Senior Planner Kinser-Maxwell presented staff overview and report by PowerPoint. Recommendation is to pass Ordinance 2022-19 on first reading.

A lengthy discussion ensued regarding electronic signs for business vs municipal purposes, having two signs, and potential impact on historic district.

- 1. Authorize the City Manager to execute a contract including Owner Direct Purchasing terms/conditions in the amount of \$370,557.97 for the total of the Base bid and a Deductive Alternate in the amount of \$8,440 with Andrews Paving, Inc., for the Newberry Lane Forcemain and Watermain Project.
- 2. Authorize the City Manager to approve change orders not to exceed ten percent (15%) of the contract amount.

- 2. Authorize the City Manager to approve change orders not to exceed ten percent (10%) of the contract amount.
