#### PUBLIC HEARINGS AND ORDINANCES

1. Amendment to the Land Development Regulations text establishing the Public Facilities zoning district.

Legislative Public Hearing: Ordinance 2022-59/LDR 22-20, an application by the City of Newberry to amend the Appendix B, Article 4 of the City of Newberry Code of Ordinances, and add Section 4.23 of same to establish the Public Facilities zoning district.

Attorney Walker read Ordinance 2022-59 by title only.

Principal Planner Perez presented the staff report and recommendation with a PowerPoint presentation. Discussion ensued.

Motion made by Board Member Thomas to recommend Approval of Ordinance 2022-59/LDR 22-20 to the City Commission, with the condition a site plan may be required with applications for rezoning to the Public Facilities zoning district.
