The Board directed Staff to change Overlay district as follows:

- 1. Wider sidewalks along storefronts
- 2. Overlay encumber entirety of development]
- 3. Maximum height of 42 feet for structures within Overlay district
- 4. Provide cap on overparking
- 5. Change definition of LSR 80,000 to 60,000 square feet for single building

Stacey,

The Norfleet family wishes to defer to a time certain, to the May Planning & Zoning Board (PZB), the pending Special Use Permit application to the May PZB to provide time to address misconceptions and misinformation regarding the proposed project. In conversations with staff, citizens in the community, and social media; several facts need to be reinforced regarding the project:

• The proposed concrete batch plant, is not a cement plant where cement is manufactured from raw materials;

• The batch plant involves the mixing of sand, gravel, dry cement, and water into trucks for delivery to sites;

• A batch plant does not involve any blasting, mining, nor material extraction whatsoever;

• The proposed truss plant is within a site-specific building, designed to contain dust and noise;

• The truss plant involves cutting of milled prepared lumber for the creation of structural building materials;

• Both facilities are strategically located on a rail line, reducing reliance on trucks & highways for aggregate and wood materials; and

• Both facilities are directly connected to NC Ranch property, allowing internal delivery and reducing reliance on roadways.

Most importantly, the proposed facilities must meet all local, State, and national requirements for operations and safety. Copies of all required permits will be filed with the City of Newberry and appropriate agencies.
