City Manager Marlowe presented the item orally. He stated that there was \$6 Million being held for Easton Gym improvements. He requested that the Commission pause planning for the additional funding required for the Easton Gym improvements and allocate \$2 Million of those funds to Champions Park. The funds would be used to address critical safety and functional issues at Champions Park.

In response to questions, City Manager Marlowe stated that staff is researching grants for Champions Park.

Motion to reallocate \$2 Million from the Easton Gym Improvements Capital Project to Champions Park for safety and functional restoration was made by Commissioner Mazon, Seconded by Commissioner Long.
