Quasi-Judicial Public Hearing: Resolution No. 2020-05/Application V 20-01, a petition by Ellen and Richard Potts (Potts & Potts Trustees), Owners, for a variance to the Newberry Town Center Planned Development (PD) Zoning District minimum yard setback requirements to allow a reduction in the rear yard setback from a minimum 10' to a minimum 6.5' on the east yard of lot 32, located at 24820 SW 19th Place (tax parcel 02544-010-032) within the Country Way of Newberry Phase I Subdivision. The purpose of the request is to allow the corner portion of an existing newly constructed aluminum patio cover to extend 3.5' into the rear yard setback.
