#### **AGENDA ITEMS**

1. Intergovernmental Conflict Resolution Regarding Annexations.

A lengthy discussion ensued between County Commissioners, City Commissioners, County Staff and City Staff regarding the annexations in Ordinances 2020-04, 2020-06, 2020-09, 2020-10, and 2020-13.

Motion made by <u>County Commissioner Alford</u> for the following:

1. To approve the annexations of parcels 2020-04, 2020-06, 2020-09, and 2020-13 and with

- the City of Newberry's cooperation de-annex 2020-10 assuming that the de-annexation does not create a new noncontiguous parcel.
- That proposed annexations that reduce existing enclaves be accepted without argument. This is meant to direct staff that if an annexation does not create an enclave and County and City staff agree the Board would not challenge the annexation. This does not bind future Commissions.

Seconded by County Commissioner Prizzia.
