A request by the City of Newberry Building Safety Department to amend the Code of Ordinances pursuant to the recently approved 8th Edition of the Florida Building Code and Chapter 1, effective January 1, 2024.

Legislative Public Hearing: First reading of Ordinance 2023-37 by the City of Newberry amending Part II, Chapter 14, Article II, Section 14-35 and 14-36 in accordance with the 8th Edition of the Florida Building Code and Chapter 1, as amended.

12. City Hall and Newberry Cold Storage Rezoning

Quasi-Judicial Public Hearing: Second reading of Ordinance 2023-33/LDR 23-16, an application to amend the Official Zoning Atlas of the City of Newberry by changing the zoning districts from Residential, Single-Family (RSF-2) and Commercial, Central Business District (C-CBD) to Public Facilities (PF) and Commercial, Central Business District (C-CBD) on property located at 25440 West Newberry Road and 98 Northwest 254 Street consisting of ±1.93 acres; identified by Alachua County Parcel Numbers: 02173-000-000 and 02174-000-000.

Attorney Walker read Ordinance 2023-33 by title only.

Mayor Marlowe reviewed the quasi-judicial procedures and read through the presentation order.

Clerk Rice swore in Principal Planner Jean-Paul Perez.

Attorney Walker read Ordinance 2023-34 by title only.

Jean-Paul W. Perez, Principal Planner, presented a PowerPoint of the staff overview and recommendation for both annexations.

Discussion ensued.

Motion to enact Ordinance 2023-34 on second reading was made by Commissioner Clark, Seconded by Commissioner Coleman.

14. Advanced Metering Infrastructure (AMI) Project - Sensus Change Order Mike New, PE, City Manager, presented the item.

Motion to authorize the City Manager to execute a change order with Sensus to a) finalize pricing and time requirements and close out the installation phase of the City's AMI project, b) extend the Network as a Service (NaaS) for ten years (for a total of 20 years), and c) reduce the cost of the NaaS over the term of the contract, was made by Commissioner Farnsworth, Seconded by Commissioner Mazon.

15. SW 15th Avenue Road Reconstruction Project: Stormwater Retention Basin Update

Mike New, PE, City Manager, presented an update with a PowerPoint.

The School Board of Alachua County (SBAC) approved Newberry's request to provide 1.8 acres of their property, valued at \$75,000, for use as a stormwater retention basin for the SW 15th Avenue improvements project. The SBAC gains 103 parking spaces for school activities, valued at \$200,000. When the executed deed is received, it will be on a Consent Agenda for Commission acceptance.

Discussion ensued.

16. Champions Park Operations Contract Renewal

Travis Parker, Director of Parks, Recreation and Facilities presented the item with a PowerPoint.

Discussion ensued.

Motion to authorize the City Manager to execute a contract with RADDSports for the continued management and operations of Champions Park through the conclusion of the City of Newberry's interlocal agreement with Alachua County (September 10, 2025) was made by Commissioner Farnsworth, Seconded by Commissioner Coleman.
