

TOWN OF NEW CASTLE COLORADO HISTORIC PRESERVATION COMMISSION ORAL HISTORY QUESTIONS

Basic Questions

What is your full name and why were you named this?

What are the names of your parents and siblings?

What is the date and place of your birth?

Where was your family originally from?

What did your parents do for a living?

What stories did you hear about earlier ancestors whom you never knew?

What was your schooling like? (That is, how did you get to school, what classes did you take, and what was your favorite subject?)

What major illnesses or health problems do you remember having or affecting the community (epidemics/diseases)?

Do you have any health problems that are considered hereditary in nature?

Did your family have any home remedies?

What did you want to be when you grew up?

Family History Questions

Tell me a story about your mother/father that shows what kind of person they were.

Do you remember your grandparents? What do you know about them?

Do you remember hearing your grandparents describe their lives? What did they say?

How did your parents die? How old were you when it happened? Is there a family cemetery?

Can you tell about any "black sheep" in the family?

Are there any traditional first names in your family?

Where did your ancestors come from?

If they immigrated to the U.S., did your family name change?

Lifetime Changes

When did you learn how to drive?

What was your first car?

What would you consider to be the most important inventions during your lifetime?

Did you ever get married? What was your Marriage Ceremony like?

Describe the birth of your children.

What family traditions did you try to establish?

What forms of discipline did you use and why?

Was your family affected by the Depression?

Did you or anyone close to you serve in a war?

Do you remember your first contact with such significant inventions as radio, television, or a computer? When did your family first buy these items?

Family Life

Where have you lived as an adult?

Why are you living where you are today?

Do you wish you lived somewhere else? If so, where?

Were there any special family foods or recipes? Do you still make any traditional family foods?

Where did you shop? How far away were these shops and how did you get there?

What's the largest town or city you remember visiting when you were young? Can you describe your impressions of it?

Did you have chores to do growing up?

What were mealtimes like in your family?

What kinds of clothes did you wear? Were they handmade?

Career

As a child, what did you want to be when you grew up?

What was your first job?

What kinds of jobs have you had?

How did you decide on your career?

Oral History Interview Questions Worksheet

Oral history is an interview that records a person's recollection of experiences, thoughts, and feelings about a specific event or a period of time. By showing how national or international events affected the lives of individuals, oral history adds a personal dimension to the study of the past.

Collecting oral history interviews is a way preserve generations of history for others to learn and enjoy. Members of your community can surprise you with a wealth of information and insights into major events of our Town. These guidelines will help you organize an oral history interview.

Preparation

First choose your subject. Whom would you like to interview? Consider the following points:

- What historical information could be obtained from this person?
- Would this person be willing to participate?

Planning the Interview

- Write an introduction to your interview. Introduce yourself if necessary and include an explanation of this project and its purpose.
- •Gather the following basic information from the interviewee:

Conducting the Interview

- Make an appointment with your subject and be on time.
- Explain to your subject that you will be using the information for a Town project.
- If you record the interview, be sure your subject agrees to it.
- Bring along your notes/list to help you guide the interview. Your subject may wander off with an interesting story. Continue with it as long as it adds to your purpose of the project. If it does not, politely return to your list of questions.
- When your interview is finished, Be sure to write your subject a thank-you letter.

Items for Consideration

Commission Discussion: Plans for Historic Designation Outreach and Open House

Chair Riddile said the commission needed to consider an invitation for the open house as well as plan and prepare the informational material for the open house. Commissioner Parks asked if the invitation would solely be sent to specific properties eligible for historic designation. Chair Riddile said the invite could be made available to the general public and liked the idea of having refreshments available to those who attend. Commissioner Copeland suggested including RSVP information so the commission may know how many attendees to expect. The commission agreed to tentatively hold the open house on Thursday, March 14, 2024 at 6:30 p.m. at the New Castle Community Center.

Chair Riddile asked the commission about the design of the invitation. The commission collaborated on design ideas and content details then drafted an invitation for the open house (Exhibit A). Deputy Clerk Bordelon said Charles Engelbert expressed interest to her directly of being historically designated. Chair Riddile recalled that particular property had many modern modifications which made it difficult to consider for a designation, but she said she would like to have Mr. Engelbert attend the open house. Commissioner Ruth Fletcher asked if History Colorado Preservation Planner Lindsey Flewelling would attend

the open house. Deputy Clerk Bordelon said she would contact Ms. Flewelling to inquire about her availability for the open house. Deputy Clerk Bordelon reminded the commission that the open house would be considered a work session and not a formal meeting.

The commission discussed and agreed to advertise the open house to the previously historically surveyed properties of 2023 as well as neighboring properties that were eligible for historic designation. The commission liked the idea of advertising the invitation through social media platforms in order to reach more people. Deputy Clerk Bordelon remarked on the many resources to advertise the open house such as: town website, town newsletter, town Facebook page, etc. The commission agreed to mail individual invitations to specific eligible properties which Commissioner Parks and Alternate Commissioner Fuller agreed to compile and create mailing labels for. Chair Riddile and Commissioner Ruth and Richard Fletcher agreed to assemble the invitations and research History Colorado Tax Credit informational resources. Chair Riddile suggested inviting the owners of New Castle Dental and Eat Bistro to the open house as guest speakers. Deputy Clerk Bordelon said she would reach out to both businesses to schedule guest speakers.

Chair Riddile asked what assistance Deputy Clerk Bordelon could provide. Deputy Clerk Bordelon clarified that, per the role of the Clerk, administrative tasks such as printing and mailing would be available to the commission as a resource. She clarified that all other work on specific commission projects would need to be delegated and assigned to commissioners.

The commission agreed to meet on Tuesday, February 13, 2024 to review materials for the open house before mailing the invitations. Deputy Clerk Bordelon said she would reserve the Community Center for the open house.

Consider Approval of October 16, 2023 Minutes MOTION: Chair Riddile made a motion to approve the minutes of October 16, 2023. Commissioner Ruth Fletcher seconded the motion and it passed unanimously.

Commissioner Comments

Commissioner Parks commented about the videography project and said his son-in-law would be willing to film the interviews. Commissioner Ruth Fletcher said the professor of videography at Colorado Mountain College was interested in assisting with the interviews as well. Chair Riddile remarked that the Jolley family expressed interest in being interviewed.

Adjourn

MOTION: Chair Riddile made a motion to adjourn. Commissioner Copeland seconded the motion and it passed unanimously.
