Consider Approval of Minutes

June 17, 2019

MOTION: Commissioner Copeland made a motion to approve the minutes of the June 17, 2019 commission meeting. Commissioner Riddile seconded the motion and it passed unanimously.

Commission Comments

Commissioner Riddile had a request from museum volunteer Marry Ann Ligon to ask about the possibility of getting grants for the museum. Chair Rippy said that the first step in the process would be to understand what was wrong with the building so that a budget and scope of work could be. He said he will talk to the Town Engineer Jeff Simonson to complete an analysis of the structure. Chair Rippy said he had been in the museum two times in the past week and felt that the building was not salvable, but Engineer Simonson will make that determination. He said he would meet with Engineer Simonson before the next HPC meeting.

Commissioner Johannsson said that some of the grant processes were very difficult and had many conditions which was why he decided against pursuing one for his building.
