Vice-Chair Candraia called the meeting to order at 4:01 p.m.

### **Earth Day Promotion and Logistics**

Commissioners are posting Earth Day flyers throughout town.

All commissioners confirmed they will attend the Earth Day event. Commissioners should wear their CEC t-shirts and wristbands. Commissioners signed up for day-of assignments.

### **Plastic Reduction Flyer**

Commissioners reviewed the two plastic reduction flyer options.

**Motion:** Commissioner Deyarmond moved to approve the white background “10 Tips” flyer with revisions to increase the size of the logos and the “10 Tips” title. Commissioner Bakich seconded. Motion passed unanimously.

### **Community Recycle Guide Updates**
