#### Proclamation

WHEREAS, the National Trust for Historic Preservation has declared the month of May to be Historic Preservation Month; and

WHEREAS, the theme of the month in 2024 is "People Saving Places," celebrating those doing the important work of historic preservation; and

WHEREAS, Chapter 18 of the Town Code, adopted on May 5, 1998, commits the Town to "The protection and preservation of the Town's architectural, historic and cultural heritage, as embodied in designated historic sites, landmarks and districts"; and

WHEREAS, Chapter 18 stablished the Historic Preservation Commission ro carry out that commitment and care for our historic places; and

WHEREAS, in 2922 the Commission received a \$20,000 grant from History Colorado for a survey of Main Street, evaluating each property's eligibility for historic designation; and

WHEREAS, on May 2 the Commissioners held a Community Open House for residents to learn about historic designations; and

WHEREAS, this study of historic designation eligibility is but the most recent of the accomplishments of the Commission over the past 26 years;

NOW, THEREFORE, the Town Council of the Town of New Castle proclaims May to be Historic Preservation Month; and

FURTHERMORE, on behalf of the residents of the town, the Council thanks the Commissioners, past and present, for their service to the Town and its heritage.

#### New Castle, Colorado Historic Preservation Commission Meeting Monday, April 8, 2024, 6:30 PM

Commission Chair Mari Riddile called the meeting to order at 6:30 p.m.

#### **Items for Consideration**

#### Staff Discussion of the Role of the Clerk

Deputy Clerk Bordelon introduced Michelle Huster, Professional Assistant to the Town Clerk as the newest member of the Clerk's office. Assistant Huster was training to take over the Historic Preservation Commission (HPC) Clerk's duties. Deputy Clerk Bordelon said the clerks could assist the commission with administrative work such as copying and ordering supplies. Deputy Clerk Bordelon explained that Professional Assistant Huster, was in training to take over those duties. Deputy Clerk Bordelon would attend some future meetings to assist with a smooth transition for Professional Assistant Huster as the new clerk for HPC.

#### **Reminder of Noticing for 3 or more Commissioners**

Deputy Clerk Bordelon reminded the commission when there are three or more HPC commissioners meeting it would need to be noticed to the public.

#### **Consider Final Details for the HPC Open House**

The Commission finalized the details for the HPC Open House scheduled on May 2, 2024, at 6:30 p.m. Deputy Clerk Bordelon confirmed Preservation Planner Lindsey Flewelling from History Colorado could attend and would provide handouts. Commissioner Ruth Fletcher would provide refreshments. The commission would arrive at 6:00 p.m. to talk with Preservation Planner Flewelling before the open house. The commission assigned duties for the open house to each other. Deputy Clerk Bordelon reminded the commission that Alternate Commissioner Fuller researched possible historic addresses that were not included in the 2023 Historic Survey of Main Street to invite to the open house. Chair Riddile mentioned Eats Bistro and New Castle Dental should be invited to speak about their historic designations.

#### MOTION: Chair Riddile made a motion to approve the final details for the open house. Commissioner Ruth Fletcher seconded the motion and it passed unanimously.

#### **Commission Updates regarding Videography**

Chair Riddile updated the commission about the videography project. The commission completed their first interview with Joe and Lorraine McNeal at Colorado Mountain College (CMC). Commissioner Richard Fletcher and Chair Riddile said CMC agreed to accomplish one videography project per semester with New Castle Residents. Chair Riddile suggested interviewing Steve Rippy or the Jolley family. Commissioner Parks provided an interview release form for written permission from videography subjects when giving an oral interview.

#### Staff Report

Deputy Clerk Bordelon gave a list of upcoming events. The Town Council was holding a yearly work session with town attorneys on April 16, 2024, at 6:00 p.m. The Town Council would like HPC and the Planning and Zoning Commission to attend. Chair Riddile mentioned there was an HPC meeting scheduled for April 15, 2024, and a work session on April 16,2024. Deputy Clerk Bordelon asked the commission if they wanted to cancel the April 15, 2024, meeting and the commission agreed. Deputy Clerk Bordelon stated reappointments would also take place on April 16, 2024. Commissioner Richard Fletcher and Chair Riddile were the only two commissioners to submit letters of interest.

Deputy Clerk Bordelon said that May was Historic Preservation Month, and the council was proposing a proclamation to honor Historic Preservation Month at the May 7, 2024 meeting. Chair Riddile, Commissioner Parks and Commissioner Richard Fletcher planned to attend.

#### **Consider Approval of January 15, 2024, Minutes**

MOTION: Chair Riddile made a motion to approve the minutes of January 15, 2024. Commissioner Ruth Fletcher seconded the motion and it passed unanimously.

#### **Commissioner Comments**

Commissioner Parks participated in a webinar called Colorado Heritage for All. He passed out some handouts from the webinar. Commissioner Parks said that History Colorado was recognizing the 150<sup>th</sup> anniversary of Colorado Statehood and putting together a program to include 150 historic places that were previously unrecognized throughout Colorado. Commissioner Parks stated that History Colorado would recognize communities of color, women, LGBTQ, and other minorities that may have been overlooked despite their

Historical Preservation Commission Monday April 8, 2024 significance to the history of Colorado. Commissioner Parks said that History Colorado asked HPCs to look within their communities for minority owned business or properties that may have been overlooked. Commissioner Parks said Colorado Heritage for All would support and help identify communities. Commissioner Parks said they could potentially identify some of the historical minorities as they talk to people at the Open House. Commissioner Richard Fletcher suggested looking into the first-generation families that worked in the mines. Chair Riddile suggested Steve Rippy as a resource, and recommended he be invited to the Open house. Commissioner Parks said the information could be found on History Colorado's Website.
