Dear Ms. Andis and Town Council,

It is a pleasure and honor having the opportunity to apply for your upcoming Municipal Prosecutor position. I have attached a copy of my resume for your review.

It was bitter-sweet, honestly, when I pulled-up my resume, as I have not done so for over 20 years. Bitter in that I cannot believe that it's been 32 years since I graduated from law school and that somehow, I am now 59 years old. Sweet in that everything listed on my resume brought back only great memories.

I understand that you're probably not interested in all of those old positions listed on my resume, but instead of re-working a new one, I decided to just give you what I have because it still does give you a "snapshot" of my education and experience. Oh, I just noticed, I guess the old stuff may be relevant after-all in that it shows that I was employed as a Municipal Prosecutor for the Cities of Minneapolis and St. Paul during my third-year of law school (it was an accomplishment to be sworn in as a "student attorney" in those days...again good memories).

I am an energetic and young feeling 59-year-old and fully intend on working for at least another ten-years. Interestingly (to me anyway) as I write this, I find myself feeling both nervous and excited, so, I must still be young. Anyway, if hired, you do not have to worry about me retiring, thereby causing you to go through this hiring process again within the next few years.

As you can see on my resume, I currently enjoy the following contracts, all since 2000.

I no longer practice family law, personal injury law or really, take any private cases at all anymore. It has been years since I entered into a private case and when I do, it is usually for a friend or someone who just needs an attorney.

In addition to the above-contracts, I fill-in as both Municipal Prosecutor and Municipal Judge in several municipalities, when needed. You likely know this as I have been covering prosecution in New Castle for Tim Graves for several years now. Ms. Andis has compensated me in the form of New Castle coffee mugs, which is why you have not received a bill from me. Prior to covering for Tim, I was actually your back-up Municipal Judge for Judge Hugh Warder. I voluntarily passed that baton to Amanda Maurer when she arrived on the scene.

A few significant advantages you have with me are:

My experience and knowledge of New Castle: I know how to prosecute municipal cases and know the philosophy of your small town with respect to doing so. If chosen, I would immediately meet with your police department and / or representative of your council to ensure that. I am still learning and am getting better at prosecuting, but you can be rest-assured that if hired, I would "hit the ground" running.

I would not be using the prosecutor position, or your Municipal Court for that matter, as a vehicle to gain experience or to make a name for myself. Hiring someone with those goals would result in an unnecessary expense to you in that there would be unnecessary trials and Court appointed public defenders. Yes, trials are sometimes necessary and every Defendant can request one, however, I have found that most cases can be resolved short of trial. A proper pleabargain can leave the town satisfied by receipt of a fine, while at the same time, leaving the Defendant satisfied in that he or she got a fair shake from the town. There is such a thing as a Defendant acknowledging their wrong, paying a fine and leaving the building with nothing but respect for the town, police department and court. Efficient and fair resolution of both traffic and criminal cases, in my opinion, should be the chief goal for your prosecutor; also taking into consideration that these Municipal Court appearances are most often the only court appearances these Defendants will ever make.

Since I do not take private cases, it is extremely rare for me to be conflicted-out of cases. With me, you will have minimal need to pay for substitute prosecutors.

I understand that, if hired, I represent New Castle in my personal life as well. All of you, and I, happily share that responsibility. I still make mistakes, but you can be confident that my mistakes are not linked to dishonesty or any other off-duty behaviors that would embarrass or otherwise cast the Town of New Castle in a negative light.

There are more qualities I have and reasons you should choose me, such as my reliability, but I am tired of talking about myself here. I am hopeful that the above is sufficient to grant me the honor and privilege of meeting with all of you in person to further discuss.

Oh, as far as money, I am thinking flat-fee, five-or-six hundred dollars per month? Open for discussion of course as I have not put too much thought into that, nor have I reviewed Tim's contract with you.

Staff Reports

Town Administrator - Administrator Reynolds said at the last council retreat there was not a decision made on when to have the next retreat. The next council retreat was decided to be on September 28, 2024. He said council had discussed having a work session to discuss building a rec center and preparing a survey. Administrator Reynolds met with the manager of Town of Debeque since they have a new rec center. He also took a tour of the rec center at Battlement Mesa. The rec centers are two different operations and to see what that looks like. Administrator Reynolds said town staff will be hosting the New Castle Chamber BINGO on June 13, 2024. He said the town is applying for an AGNC Technical Grant which is due next week. There are a couple of different grants written: 1) traffic control devices specifically for Midland Ave. 2) help downtown businesses. The town can only submit one. AGNC will give a technical grant and the town is asking for \$5,000.00, then the town would match from the downtown group. Then, the town would open outgoing grants to downtown businesses which are forward faces to Main Street. The money could be used for new paint, new signs and etc. The council agreed to apply for the grant to help the businesses. Administrator Reynolds said the City of Glenwood Springs completed a regional traffic study. From the study the City of Glenwood Springs wants to create a traffic coalition and wants the Town of New Castle to be part of the coalition. Administrator Reynolds said the Carrier Neutral Location (CNL) had meetings with Garfield County and the other towns. The discussion was since there is a building for CNL what happens next. There was an RFP to internet providers for who is interested and what it would look like. There have been interviews with 6 different internet providers. Out of the 6 there are two providers for second interviews. The ownership of the building and the equipment is becoming complicated. Garfield County Commissioners has said they are not in the internet business and the CNL's to go to the towns. The town was very deliberate up front by stating the town would lease the property, but the town doesn't want the maintenance of the facility until we know more about the pros and cons to the town. Mayor Pro Tem Hazelton asked about the insurance. Administrator Reynolds said the insurance is all part of the maintenance and ownership of the building. He said the purpose of this was the federal and state was putting out money to provide services to the underserved communities. The privilege was for smaller towns to have competing providers. When the state started to map what they considered underserved didn't include the town proper because the town already has high speed internet. Administrator Reynolds said there was a gas line that was hit at the round-about construction site. He said he has been going through council retreat notes, there was discussion about open houses for residents to come talk to council and to staff. Staff had an idea to make the open house more appealing. Staff suggested having an ice cream social at Burning

- 1 Mountain Park in June, serve ice cream and talk with residents. Administrator Reynolds
- 2 said Town Attorneys David McConaughy and Haley Carmer will be doing an orientation to
- 3 council and commissioners on "do's and don'ts.) Administrator Reynolds said he and staff
- 4 has a meeting with a realtor to talk about the old schoolhouse. Administrator Reynolds
- 5 said he will be going on vacation in May and will not be available from May -21, 2024.

PROSECUTING ATTORNEY PROFESSIONAL SERVICES AGREEMENT

THIS AGREEMENT is entered by and between the Town of New Castle, Colorado, hereinafter referred to as "the Town" and John Collins of John C. Collins, P.C., hereinafter referred to as "Prosecuting Attorney", this <u>16</u> day of April, 2024.

WITNESSETH:

WHEREAS, the Town requires personal services of a legal nature, as more fully set forth below; and

WHEREAS, John Collins of John C. Collins, P.C., is fully qualified, through experience and education, and where required by state or local law, is duly licensed to perform such services, and is ready, willing and able to help the Town in carrying out such services personally as set forth herein; and

WHEREAS, the Town has reviewed and evaluated the Prosecuting Attorney's qualifications and deems that the Prosecuting Attorney is qualified to perform the services set forth herein; and

WHEREAS, the Town desires to contract with the firm of John C. Collins, P.C., for performance of services, with John Collins being designated as the lead municipal prosecutor.

NOW, THEREFORE, in consideration of the mutual covenants hereinafter contained and subject to the terms and conditions hereinafter stated, it is hereby understood and agreed by the parties hereto as follows:

AGREEMENT:

- 1. **Contractor**. The Town hereby agrees to engage and compensate the Prosecuting Attorney, and the Prosecuting Attorney agrees to personally perform the services hereinafter described subject to the conditions hereinafter set forth.
- 2. **Scope of Services**. The Prosecuting Attorney agrees to perform and carry out satisfactorily and in a proper manner, those duties and work toward the specific needs of the Town Council as agreed upon by the Prosecuting Attorney and the Town Council. The Prosecuting Attorney agrees to devote his best efforts in the performance of services provided hereunder (the "Services"), which Services are expected to average 8 10 hours per month.
 - a. The Prosecuting Attorney shall prosecute ordinance violations before the Town's Municipal Court.

- b. The Prosecuting Attorney shall attend all arraignments and trials, as set by the Municipal Judge and Court Clerk.
- c. The Prosecuting Attorney shall advise the New Castle Police personnel of legal matters relating to enforcement of ordinances by the department.
- d. The Prosecuting Attorney shall perform such other duties as may be prescribed for him by the Town Council or the Town Administrator.
- e. The Prosecuting Attorney shall engage an alternate attorney at no additional expense to the Town in the event he is unable to perform the agreed upon duties.
- f. In the event of a Municipal Court Order or the Prosecuting Attorney finds it necessary to retain a Special Prosecutor because Prosecuting Attorney has a conflict of interest on a matter, compensation to the Special Prosecutor will be paid by the Prosecuting Attorney.
- g. The Prosecuting Attorney is hired as special counsel for municipal prosecution pursuant to Article VIII, Section 8.1, of the New Castle Charter.
- 3. **Term.** The term of this agreement shall be two (2) years from the effective date, and thereafter shall automatically renew for additional two (2) year periods, unless the Prosecuting Attorney provides notice to terminate sixty (60) days prior to the expiration of the then current term.
- 4. **Termination.** The Prosecuting Attorney may terminate this agreement upon sixty days written notice to the Town. Pursuant to Article VIII, Section 8.1, of the Town Charter, the Town Council may remove the Prosecuting Attorney at any time with or without cause. Such termination shall in no way prejudice the payment due the Prosecuting Attorney for Services rendered through the date of termination, nor prejudice the Town's right to receive Services through the date of termination if desired by the Town. The Prosecuting Attorney hereby waives those rights that may be afforded by C.R.S. § 31-4-307 with regard to the termination of this Agreement, provided nothing herein shall be deemed an admission that such statute applies.
- 5. **Agreement Subject to Appropriations.** Notwithstanding any provision to the contrary, any payments to the Prosecuting Attorney beyond the fiscal year in which this Agreement is signed shall be subject to annual budgeting and appropriation as required by the Colorado Constitution. If the Town fails to make or maintain sufficient appropriations to pay any costs incurred under this Agreement, then the Agreement shall be terminated immediately. No provision of this Agreement shall be construed or interpreted: i) to directly or indirectly obligate Town to make any payment in any year in excess of amounts appropriated for such year; ii) as creating a debt or multiple fiscal year direct or indirect debt or other financial obligation whatsoever within the meaning of Article X, Section 6 or Article X, Section 20 of the Colorado Constitution or any other constitutional or statutory limitation or provision; or iii) as a donation or grant by Town to or in aid of any person, company or corporation within the meaning Colorado law.

- 6. Compensation.
 - a. The Prosecuting Attorney will be paid at the rate of \$800.00 per month for all attorney and other legal professionals' time, regardless of the number of hours worked in a given month, plus customary costs including telephone and mailing charges and costs for the preparation of photographic and video evidence. The Prosecuting Attorney will not bill the Town separately for paralegal or legal assistant time.
 - b. The Prosecuting Attorney shall provide monthly billing statements to the Town.
- 7. **Miscellaneous.** This instrument embodies the whole agreement of the parties. There are no promises, terms, conditions, or obligations other than those contained herein; and this Agreement shall supersede all previous communications, representations, or agreements, either verbal or written, between the parties hereto. Except as provided herein, there shall be no modifications of this Agreement except in writing, executed with the same formalities as this instrument. Subject to the conditions precedent herein, this Agreement may be enforced in the courts located in Garfield County, Colorado, and the parties consent to the jurisdiction and venue of such courts. The Parties hereto understand and agree that the Town is relying on and does not waive or intend to waive by this Agreement or any provision hereof, the monetary limitations and any other rights, immunities and protections provided by the Colorado Governmental Immunity Act, C.R.S. §§ 24-10-101 *et seq.*, as amended from time to time, or otherwise available to the Town. The parties consent to the use of electronic signatures hereon, which shall be binding.
