Roll Call/Pledge of Allegiance

Mayor Good opened the meeting at 6:31 P.M. followed by roll call & Pledge of Allegiance.

Reading of the Mission Statement read by City Clerk Kyla Gardner

Mayor Good requested that the City Council consider amending the agenda to add an Action Item to the agenda for the two piles of dirt that need to be moved as you turn left out at the Land App. This Dirt needs to be declared as city surplus.

- Council Member Ryker moved to approve amending the agenda to approve declaring the Dirt at the Industrial Park as Surplus due to the time sensitive nature of this action. Old City Hall

Mayor Good asked City Clerk Gardner where we are in the process of the Sale of the Old City Hall. Gardner mentions that there are a few items still in the building that need to be removed. Gardner explains that the building will then need to be cleaned and then the City Council will need to work on an Auction Date. Barron Loper asked what the acreage is at the Old City Hall? Gardner explains that the building is around 1800 Square feet and the acreage is .09 acres. The date of the auction will be set at a later meeting.

Unemployment Insurance

Mayor Good mentions that at this time the City is doing cost – reimbursement for Unemployment Insurance so the City has to reimburse the state in full for benefits paid to their employees. Mayor Good explained that its very expensive to do it this way and it's very hard to budget for. She also explains that the other option is to be an Experience-rated employer to pay in contributions based on an assigned tax rate. Then any unemployment claims would be paid for by the State Department of Labor. Mayor Good suggests placing this on the agenda for next meeting as an action Item.

Road & Streets committee update

Ken Crogh was the only one who was present at the Road and Streets Committee meeting. Ken reported that he had received some useful information from Andy regarding the signs and he says that he found three other people to volunteer for the committee. Mayor Good asked Ken to give the potential volunteer's contact info to the City Clerk so she can get the information and agendas to them as well. Also, Mayor Good said that she will have Hunter reach out to Ken for the information on the Stop signs.

Dogs in the Park & Depot Area

The City Council reviewed the ordinances related to dogs in the park. The Mayor mentioned that the City does not have a designated pet area. Mayor Good also explained that citizens getting ready for events in the park spend time cleaning up after the pets. Suggestion was made to get a grant or some sort of funding to get dog bags and a trash receptacle for park. Mayor Good explained the ordinance would need to be changed and then given to the attorney for review.
