Discussion Items

Comprehensive Plan

Mayor Good explained that this plan should be looked at and updated every 5 years. Good also explained that the Comprehensive Plan is what the City looks at for Development, how the City is going to operate and what things are important to our community. When someone comes in with an idea the city would make sure that it lines up with the comprehensive plan. This is why it's necessary to look at this plan and update every 5 years. City Council will go through a little bit at a time, add the suggested changes and put out to the public for feedback and approval. Mayor Good asked City Clerk Gardner where she would like to start on the plan. City Clerk Gardner suggested City Council start with first 15 pages. Clerk Gardner also explained when Planning & Zoning requests require the Clerk to do a staff report, this plan is something she has to look through. When someone brings their P&Z plan to her, she needs to make sure that their plan does mesh with the comprehensive plan.

Rates & Fees Review – Planning & Zoning

City Council reviewed the rates and fees for Planning and Zoning and gave some suggested changes. The beer and wine and liquor fees will be reviewed by the City Attorney and reviewed later. The notary fee will be reviewed at the next meeting.

Bulk Water Station

Mayor Good talked about a Bulk Water Station that provided bulk water that is paid for with a credit card. The City of Council has that type of station with a dump station nearby. Mayor Good
